REV. J. S. MULLAN'S CASE

(Continued from page one)

ject. He urged that a public confession was necessary before the Presbytery could act. "Unless a public statement is made there are people in Stanley who will not submit to Mr. Mullan's return. I cannot see my way clear under the present circumstances to vote for his restoration and I must refuse to do so."

MR. McCASKILL'S SUGGESTIONS.

Rev. Mr. McCaskill said he sympathized with Mr. Ross' attitude but since listening to Dr. Smith he felt that the matter might be arranged through a different procedure. He suggested that Mr. Mullan should come before the Presbytery as a member of the Church of Scotland and apply for admission. Mr. Mullan had the authority of the government for considering himself a member of the Church of Scotland, although this was in opposition to the verdict of the courts of the church and the equity court.

Doctor Smith said that he had merely pointed out that the people had justification for thinking that they were acting honestly.

Mr. Ross—"I cannot believe any such thing. I know the people. It was a deliberately planned affair."

Doctor J. H. MacVicar asked the reasons for Mr. Mullan's suspension and was informed that it was a technical charge of contumacy. He said that if it was the intention to punish, heavy punishment had already been suffered.

Doctor Smith gave further particulars of his interview with Mr. Mullan and of the latter's statement of his regret and his willingness to devote the balance of his life to remedying the wrong he had done.

Dr. MacVicar asked if there was any reason to believe that Mr. Mullan would sign a statement to this effect as well as his application.

Dr. Smith said that he was no prophet but he had found in Mr. Mullan a spiritual attitude for which the Presbytery should be grateful to God.

Mr. Townsend said that he had understood that the Presbytery had no intention to exact the pound of flesh or make Mr. Mullan get down on his knees to the Presbytery.

Mr. Macpherson said they had found in Mr. Mullan a fine penitent Christian spirit and he did not think they should exact his scalp or his pound of flesh.

Mr. Ross—"I object to such language."

Judge Forbes—"Take it down. Put it on the records."

Mr. Macpherson withdrew the expression.

Mr. MacVicar asked if it would be satisfactory if Mr. Mullan signed the report of the committee.

Dr. Smith raised the point that the action of the Presbytery in deposing Mr. Mullan did not necessarily affect his membership of the church.

Mr. MacKeigan asked if the Presbytery was dealing with the application of a deposed minister, or of a minister of the Church of Scotland.

Dr. Morison said that the Presbytery had appointed a committee for the purpose; they had heard the report and had had it amplified by the verbal report of the convener of the committee and he suggested that it would be a reflection on their committee if further evidence were required in addition to the report.

Judge Forbes said that the matter of the license to solemnize marriage was a matter for the government and the Presbytery had nothing to do with it than they had with the licensing of Salvation Army officers.

URGES SIGNATURE

Dr. MacVicar saying that it was no reflection on the committee, moved that the committee be requested to obtain Mr. Mullan's signature to their report. He felt that if they went to the assembly without his signature the case would be thrown out.

Mr. Ross maintained that the license to solemnize marriage would be a stumbling block.

Mr. Ross said that negotiations with the government had broken off because the government had no case.

Mr. Clawson protested against Mr. Ross' statement that Mr. Mullan and his adherents lied in face of the evidence which had been brought out.

Mr. Ross said that he would not be contradicted as he knew the people and knew the facts.

Judge Forbes said that Mr. Mullan had sat in the Presbytery for thirty years and it was too late for him to say that he was a member of the Church of Scotland. As far as the marriage license they all knew that Mr. Mullan's son-in-law was a member of the legislature and had the government by the throat and forced them to give the license.

(Mr. Mullan's son-in-law is John A. Young, M.P.P. for York.)

Dr. Smith asked if it was understood that if he secured the signature of Mr. Mullan he would have the moral certainty that the reinstatement would go through.

The question was put and apparently carried. There were cries of "question" and Dr. Smith said that if the matter was to be fought through to the assembly on technical grounds he would be no party to it. He would not go back to Mr. Mullan unless the support was unanimous.

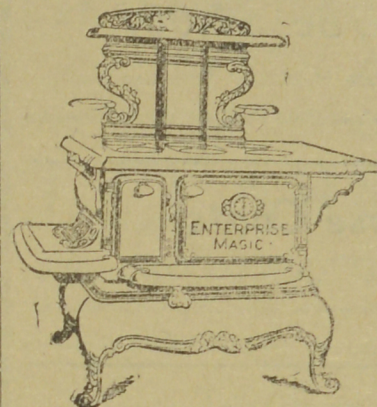

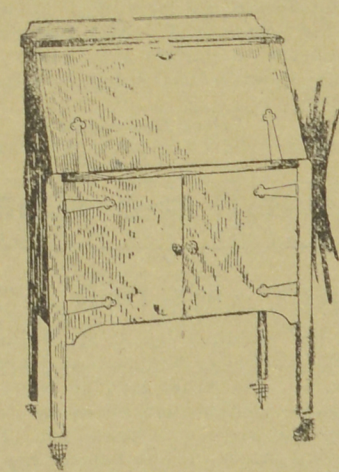
