TROUBLE OVER NORTH

The "friends of the local government" (which is a phrase intended only for use in Liberal counties) in Northumberland have been invited to meet in the town hall at Newcastle, on Thursday, Feb. 15th, to nominate four candidates for the local legislature. It will be remembered that Premier Flemming during his recent visit to Newcastle made a strenuous but not very successful effort to restore harmony in the ranks of his followers in the County of spruce and political deals. Hon. John Morrissey was on hand to greet the Premier, but Commodore Stewart and other insurrecto leaders were conspicuous by their absence. The Hon. John, having things pretty much his own way was apparently able to convince the premier that things were not as bad as they had been painted and suggested that a convention be called at once. The premier acquiesced and the call for the pow-wow was accordingly sent forth. That the worthy Commodore Stewart was not consulted and is not at all pleased over this turn of affairs is shown by the following editorial which appeared in the last issue of The World:

"It is rather surprising to find that Mr. W. H. Belyea, at the request of Hon. John Morrissey, has signed a call for the convention of the Local Government Organization. Mr. Belyea signed such a call once before, and the convention met, and a good Government supporter was nominated, and then what happened? MR. MORRISSEY ADOPTED THE NOMINEE OF THE OPPOSITION CONVENTION AND MISUSED THE GOVERNMENT PATRONAGE TO DEFEAT THE NOMINEE OF THE GOVERNMENT PARTY. Mr. Morrissey had no use for the convention and its nominee then. How is it that he appeals now to the organization he repudiated then? The organization that elected Morrison, Morrissey, MacLachlan and Allan, and nominated Swin, WAS ASSASSINATED WHEN MR. SWIN WAS OPPOSED BY THE GOVERNMENT. MR. BELYEA HAS ISSUED THE CALL BY REQUEST, BUT NEITHER HE NOR THE CHAIRMAN, MR. CLARK, WILL HAVE ANYTHING TO DO WITH IT. NO SELF-RESPECTING CONSERVATIVE CAN IDENTIFY HIMSELF WITH IT OR SUPPORT ITS CANDIDATES. Let the Liberals vote for them or for candidates of their own. Mr. Morrissey may repudiate the convention ticket before election day and give the Government support to the Opposition nominees. It would not be any more childish foolish and incomprehensible than his opposition to Mr. Swin."

From the above it would seem that Premier Flemming's efforts to bring order out of chaos among his followers were not crowned with success. The beligerent Commodore and his friends are blessed with good memories and they have not forgotten the way in which they were flouted by Mr. Morrissey during the bye-election of three years ago and they have no intention of forgetting it. Should they take the trouble to attend the convention there is sure to be a hot old time.

A practical committeeman in presenting diplomas last June, to a graduating class spoke as follows: "Girls in presenting you these diplomas, if by their significance you are led to allow your mother to do all the work, bake all the bread, sweep all the floors, because you can read Latin or demonstrate a theory in geometry, then has your school been a most unfortunate course, and in all the teachings you have ever received at my hands I trust there has been no lesson that has weaned you from the dish pan. Boys, if from this graduation you go out into the world too nice to carry wood or will the boys, if need be, then has our school failed in its purpose and sown the wrong seed."

WILL NOT DOWN

The Boston Globe, noting the passage by the Saskatchewan Legislature of a resolution approving reciprocity, has this to say: "It is interesting to note that the Legislature of Saskatchewan, after extensive debate, has approved, by a vote of more than two to one, of a resolution favoring reciprocal trade relations between Canada and the United States. We were told after the Canadian election returns were received, that reciprocity was dead. Now we get notice that it is neither dead nor sleeping, but is alive as ever in the Canadian northwest."

"This attitude in Saskatchewan at least serves to awaken Canada to the fact that she is at liberty at any time to accept the terms of the reciprocity agreement, as passed by our congress. The act is still on our statutes and constitutes a standing invitation to our neighbor on the north to be neighborly. The time is coming when Canada will abandon the false issue of annexation and consider the agreement on its merits."

Discussing the grain blockade in the West the Toronto Globe says: "The result of the pinch has been to make the west a unit in favor of freedom to sell, and to convince many manufacturers and traders in the east, that the attempt to hobble and restrain the west in selling its staple product was bad politics and worse business. The Hon. Clifford Sifton and the Hon. W. T. White would not find so fruitful soil in Ontario factory towns today as they found last September for their speeches against the sale of Canadian wheat to the millers and dealers of Minneapolis. Their fancies have been put to the test of experience and a Tory Minister of Trade and Commerce has hastened to do all he could to divert grain to the southerly routes. Rarely have men in public life been justified by events so completely and so speedily as Mr. Fielding and Mr. Patterson have been justified in their endeavor to secure the removal of the duty upon grain on both sides of the international boundary."

Brightford Expositor: Premier Borden and Hon. C. J. Doherty, the Minister of Justice both rallied this week to support the contention of Hon. A. B. Aylesworth as to the marriage question. And yet the late Liberal Government was blamed roundly by Ontario Conservatives on this very question, and the argument was used where possible as one stepping stone to office.

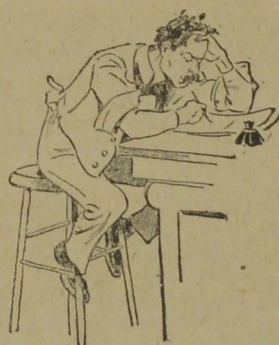
