Berlin, Nov. 23-German official circles express themselves as 'quite indisturbed by the sinster rumors in regard to the international situation manating from Vienna.

It is declared this morning that the prospects of a peaceful settlement of he Austro-Servian conflict have distinctly improved.

The report that the Austro-Hungarian government had made a repreentation to the Russian Government discredited here. On the contrary he relat ons between Vienna and St. etersburg, are understood to have mproved since Russia gave Servia o understand that she cannot have Russian support in her demand for a port of the Adriatic Sea. The reported tension between Roumania and Austria-Hungary is also discredited by German officials.

long was defeated in the last election on that issue, or rather on this issue"-pointing to the American and British flags behind him on the wall. "We had just as strong arguments as you had on the economical s de, but we were not defeated on economic grounds-these did not enter into it. It was the strong feeling of nationality in Canada tgat had been arous ed that said 'No.'

"The old Union Jack defeated that proposition. As you know, personal ly I am in favor of a trade agree ment with the United States and I ess loyal to do a business of more han \$455,000,000 than it does to do hat amount of business.

"Our relations with the United states are cordial. There never can be any serious difficulty between the United States and Canada. I do not lepend on the Monroe Doctrine to keep the great British empire from having a quarrel with the United States but I depend on the sound common sense of the people of both countries."

The speaker said that inasmuch as Canada had always accorded the United States the freedom of her canals along the St. Lawrence and the Great Lakes, there was some feeling in Canada over the present attitude of the United States toward Canada in the Panama canal. He hoped this matter would be sat isfactorily adjusted.




