

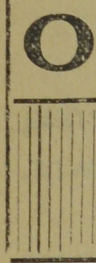

CHURCH BUILT OF DRINK FINES

Serowe, the capital of Khama's country, was recently the scene of an event which drew the attention of practically the whole native population. The foundation stone of Khama's new church was laid, and it is worthy of note that the chief raised some £10,000 for the building in the course of punishing his people for the brewing and consumption of Kafir beer.

Khama's country is "dry," dry in a double sense, for in some portions rain does not fall for a year, and there is effective total prohibition of intoxicating liquor. As long ago as 1876, the reigning chief wrote to Sir Henry Barkly: "There are three things that distress me very much—war, selling people, and drink." And against this trinity of evils the enlightened ruler fought with splendid courage. Today, a happy and contented people, rich in cattle, secured for all time in the possession of their reserves, live peaceably under Khama's benevolent despotism.

But Khama's people are human, and they sometimes yield to the allurements of Kafir beer. One day not long ago, dame rumor reported to the monarch that one of his imps in a distant corner of his realm had been brewing Kafir beer. He immediately gave instructions that another impi should at once proceed to the place and confiscate the beer. The man obeyed instructions, and confiscated the beer—but they turned aside to drink it. So another impi was sent to see what had become of the first. The consequences were serious to the delinquents, for the brewers and the consumers were heavily fined, and many head of cattle thus passed into the King's hands. The cattle were sold and many thousands of pounds were at once available for the building of the new church upon which the King had set his heart.

The stone-laying ceremony was at the whole of the King's regiments were paraded, each regiment wearing its colors on the most lavish scale. Thousands of natives thronged the little town, and the stone was "well and truly laid" by Colonel Panzera, C. M. G., the Resident Commissioner. European carpenters and bricklayers will be at work upon the building, but the unskilled labor, and some of the skilled, will be done by the native workers.

Serowe is a "dry" town, but, although it has a large native population, five policemen are sufficient to keep order.

"BULL MOOSE" BOOM AFFECTS INTERCOLONIAL RY.

The great demand for the "Bull Moose" emblem in the United States is creating a craving for the advertising literature of the Intercolonial Railway, many requests being received from American cities, and from the various outside agencies. The reason for this is that the "Bull Moose" is really the trade mark of the Canadian government railways, and the stamp of the moose head is to be found on all pamphlets, guide books, posters, etc. The Progressive Party in the States is conducting a vigorous campaign and the Bull Moose is being used extensively for illustration purposes and widely circulated as a souvenir. Photos of moose are being urgently requested by publishers and printers everywhere. In some States the services of guides have been engaged to give the "moose call" at the convention and party rallies.

It is a curious coincidence that a political party in the United States should adopt as a party emblem the trade mark used for many years by a railway owned and operated by the Canadian government, but the Progressives evidently know a good thing when they see it. Incidentally, the American people will learn that it is in Eastern Canada the bull moose flourishes in his native haunts, untroubled by the contaminating influences of political strife.

HIGHEST RANK MASONS GATHER

Washington, D.C., Oct. 7.—Men from widely separated parts of the world who have won the highest distinctions that the Masonic fraternity can give them, have arrived in Washington to attend the International Conference of the Scottish rite, the sessions of which will last through the greater part of this week. Among those in attendance are delegates representing the Scottish Rite supreme councils in the United States, Canada, Italy, Belgium, Egypt, Greece, Venezuela, France and Mexico.

TWENTY YEAR OLD LAW JOKER IN C. P. R. DEAL

Any body of publicists or politicians who, in the language of the Street, plan to "put something over" on the Canadian Pacific Railway, had better revise the old joke about getting up early in the morning to do so. They had better start in at least twenty years in advance, and then the chances are they will be left just as badly as the agitators have been left in connection with the new stock issue authorized yesterday by the shareholders, which bids fair to be known as the joke of the century, the butts of the joke being the politicians and papers that have been demanding in stentorian tones that the Dominion government refuse to permit the big road to issue any more common stock.

All of which leads up to the statement that during all this outcry against the issue of more stock by the C.P.R., and frantic appeals to the government to step in and refuse permission for this issue, the directors of that corporation, secure in a twenty-year-old enactment, have been calmly sitting tight and smiling over the joke they were about to spring.

JOKER WAS HIDDEN.

Ever since May 10th, 1892, the C.P.R. has been practically secure against any such demand as arose recently in connection with their application to the government for permission to increase their capital stock by sixty million dollars. Section 2, chapter 10, Victoria, 55-56, contains the neat little joker which has now come into the light of day, but of which not a word was breathed by the directors while the grain growers and other organizations were trying to defeat the proposed issue, and the stock was falling ten points through fear that this agitation might have some effect. They just kept on, laughing in their sleeves, and then when the time came Sir Thomas Shaughnessy casually announced that the road would issue this new stock by substituting it for consolidated debenture stock which it had the authority to issue, permission to effect this substitution being granted by parliament.

THOUGHT IT TO FULL AGITATION.

Some of those who were present at the annual meeting and heard this statement misconstrued it and issue common stock whenever and wherever it pleases up to the authorized limit of the debenture stock. All it can do is to substitute common stock for consolidated debenture stock. In the present case had the sixty millions of consolidated debenture stock which the company had been previously authorized to issue but had not done so, been put out, it would probably have been necessary to issue it at a discount as this stock only pays four per cent and the issue might not have yielded over fifty millions. But in the present case, with the common stock being issued at a premium of seventy-five thought the government had taken this course in order to effect a compromise and lull the agitation, but it now transpires that this authority was given when the legislation creating the Consolidated Debenture Stock was passed somewhat over twenty years ago.

A provision was inserted in the act enabling the company to issue capital stock at any time for purposes for which an issue of consolidated debenture stock had been authorized. In all the years that have passed since then there never was an

occasion when the company needed to take advantage of this safeguard. But there it was all the time in case an emergency such as the present late one should arise. Why the directors ever bothered applying to the government for permission to issue this new stock is something of a mystery. Possibly they did not desire to bring this provision prematurely into undue prominence but when the date of the annual meeting approached and no apparent action had been taken on their application by the Government, the company decided to take the matter out of politics and they have taken it out very effectively.

ONLY UP TO THE LIMIT

Of course this provision does not give the road unlimited power to per cent the issue yields the face value of sixty millions and forty-five millions additional.

WIPES OUT BONDED DEBT

Apart from the strategic beauties of the re-financing plan there are many striking features to it that become apparent on closer inspection. For instance the bonded indebtedness of the road will be practically wiped out. In the last annual statement, there were but two mortgage charges against the road's securities, an issue of five per cent bonds which mature in 1915 and an issue of Algonia branch first mortgage bonds. Under the new scheme the thirty-three millions of the bonds maturing in 1915 will be retired and then the road's fixed charges per miles will be only \$750 annually or infinitely lower than any other road on the American continent, which has issued bonds.

It would seem to be the financial policy of the company to raise all money it ever may require in the future by means of capital stock issues and eventually reach the position when there will be no fixed or mandatory charges against its properties.

CONVENTION OF TEAMSTERS

Indianapolis, Oct. 7.—Between 200 and 300 delegates from various parts of the United States and Canada were present here today when the biennial convention of the International Brotherhood of Teamsters, Chauffeurs, Stablemen and Helpers was called to order by President Daniel J. Tobin of Cambridge, Mass. The officers' report showed an increase of about 10,000 members in the past two years and a treasury gain of \$60,000 in the same period. Indications point to the re-election of President Tobin and nearly all of the other officers.
