

HAD SO MANY NAMES SHE GOT CONFUSED

JOHNSON VS. JOHNSON IN THE DIVORCE COURT

Defendant Wife Contracted a Bigamous Marriage Here with Albert J. Hughes of St. John.

The New Brunswick Court of Divorce and Matrimonial Causes met this morning in the opening session of the January term, Mr. Justice Crockett presiding.

To be Heard Thursday
The unfinished case of James Francis Keedy vs Lydia Keedy was set for Thursday morning. This is from Jacques River. The defendant wife is now in the city.

Struck from the Docket
Two cases were ordered struck from the docket and the libels dismissed. These were John S. Brown vs Mabel Brown and Clifford Gideon Steeves vs Elsie Steeves, in which the plaintiffs were stated by proctors to be unable to proceed.

Made Remanets
On the motion of the registrar H. G. Fenety, Phillip Landry vs. Mary Landry and Peter Miles Geldart vs. Annie May Geldart were made remanets.

Evidence in Johnson case
The case of Guy S. Johnson vs. Gertrude Johnson was begun. Francis Kerr appearing as proctor. Witnesses examined were the plaintiff Guy S. Johnson, Daniel McVey and R. W. L. Tibbits.

The plaintiff is a resident of Hampstead and the defendant wife of St. John. They were married at St. John Sept. 16, 1914, by Rev. F. H. Ventworth the name of the wife being Gertrude Hodgkin. They lived together for a time at St. John and at New Jerusalem, Queen's County. The husband noticed that in St. John his wife was keeping late hours and upon remonstrating with her was told that she was keeping company with a soldier. The wife left the plaintiff and on Sept. 13, 1917, at Fredericton was married by Rev. J. S. Sutherland to Albert J. Hughes under the name of Viola May Johnson. The husband and the witness McVey both stated that they visited the so called Mrs. Hughes who admitted that she had been married and said that she used the name Johnson because she had so many names she got confused. The defendant lived for a time in Fredericton and for a time in St. John.

J. J. FRASER FARRALINE HOME IN CITY FORMALLY DEDICATED AND OPENED; COMMITTEES IN SESSION

Large Delegation from St. John—Building One of the Oldest in City and has Historic Associations—Extreme Capacity of Fourteen Inmates—His Lordship Richardson Will Offer Dedicatory Prayer—King's Daughters Have Charge of Institution.

The formal opening of the J. J. Fraser Farraline Home, Queen street in this city will take place tonight at eight o'clock. This morning the committees of the King's Daughters of St. John and Fredericton which have been in charge of the work of preparing the Home, were in session. At noon luncheon for the Directors and House Committee was served, thirty guests sitting down of whom fourteen were from the St. John branches.

The Board of Directors met this afternoon at two o'clock. Tonight there will be the formal handing over of the deed and a dedicatory prayer by Bishop Richardson. There also will be other addresses.

The New Home.
The J. J. Fraser Farraline Home is for aged persons. The full capacity will be fourteen and eight are now ready to enter it. The building which faces the St. John River and is immediately adjacent to the Legislative Buildings is one of the oldest structures standing in Fredericton. It is of old-time frame construction with masonry-filled walls. This made the installation of a new heating-plant extremely difficult.

Changes Made.
The St. John King's Daughters presented the floor coverings and window blinds and one of them installed a window in one room. The Fredericton members of the society were in general charge of the improvements. New bath rooms have been installed and a electric bell system and the building painted and papered throughout. The property also comprises garden, lawn and out buildings.

Mrs. Alonzo Barker of Fredericton is matron and Miss Phoebe Brewer of St. John assistant matron.

By the removal of a partition an office has been located immediately at the right of the main entrance. The large dining-room is adjoining that. A feature of the entrance hall is the name of the institution "J. J. Fraser Farraline Home" in Old English on the wall. The building once was the residence of the late Hon. J. J. Fraser, at one time Lieutenant governor of New Brunswick. His widow the late Mrs. Fraser, donated the property for the use to which it is now being put, a home for the aged.
