

# SAYS LIQUOR EXPORT TAX IS ULTRA VIRES

## IMPORTANT CASE BEFORE THE COURT

Counsel for the Export Company Says that the Act Interferes with Commerce.

The Appellate Division of the Supreme Court resumed its session again yesterday afternoon when the case of the King vs. Earl Ashe was taken up. Mr. Lambert of Sackville appeared for the defendant and continued the argument. The Attorney General, J. P. Byrne, appeared for the Crown. The court will consider.

Lemuel Allen Gilbert, of Campbellton was called, sworn, and enrolled on attorney on the motion of Mr. Mullin, K. C. Mr. Gilbert is at present principal of the Campbellton High School and will continue to fill that position for the coming year.

The case of the King vs. Hon. J. E. Hetherington, provincial Secretary Treasurer ex parte Security Export Company, Ltd., was considered. Dr. F. R. Taylor, K. C. in support of the rule for an order nisi to quash warrant under Liquor Exporters' Taxation Act, asked that Mr. A. Geoffrion of the Quebec Bar be allowed to act as counsel. The courtesy of the court was extended to Mr. Geoffrion. Dr. Taylor took the ground that the Act was ultra vires the Province of New Brunswick in that it imposes indirect taxation, and is opposed to the British North American Act as it interferes with trade and Commerce. The Attorney General, contra, took preliminary objections in that the Writ was not directed to proper persons.

The Appellate Division of the Supreme Court continued its session today, and this morning the case of the King vs. Hon. J. E. Hetherington, Provincial Secretary Treasurer, continued to occupy the attention of the court. The court will consider the preliminary objection raised by the Attorney General yesterday in respect to improper service of the writ and will give judgment in the whole matter. The Attorney General proceeded with the argument against an order nisi to quash warrant issued under the Act and was still engaged when court rose at 1 p. m.

# APPLICANTS FOR LICENSES TO SCALE LUMBER

## EXAMINATIONS GOING ON TODAY

Under Act of the Assembly All Scalers are Now Requested to Take Out Licences.

The Provincial examinations for N. B. Scalers licenses are being held in the city today, and there are some fourteen applicants. This morning Mr. Richard McFadgen, Chief Scaler for the New Brunswick Railway Company and Mr. A. T. Murchie, Chief Scaler for the Province, took the candidates to Fraser's Mill below the city and scaling of logs was done. This afternoon examinations were written in the Parliament Buildings. Under the Act these examinations are held in July and September and oftener if necessary and the new Scalers' Act passed at the last session of the Legislature requires all scalers on Crown Lands whether employed by the Government or by private companies to have licenses.

# TIMBER BERTH BROUGHT \$505 PER SQUARE MILE

## WAS KNOCKED DOWN TO LUTHER B. SMITH

A McAdam Junction Man Who Bid \$25 per Mile will Protest the Sale.

A number of timber licenses to expire on the first of August 1923, but subject to renewal to August 1st 1923 for the purpose of cutting all classes of lumber were disposed of this morning at the Crown Land Office. Six lots in all were put up and all with the exception of one went at the upset price of \$20 per mile. All the applicants bid in the land Luther B. Smith securing one tract of 9 and 1-2 miles on the Parish of Dunbarton, Charlotte County up to \$505 per mile, the highest price ever paid for a timber license in the memory of the oldest officials at the local Crown Land office.

The lots were as follows:—

No. 16 of the Bay du Vin River, 4 square miles to Bernard J. Cook at \$20 per sq. mile

### A Record Price.

No. 17 in Parish of Dunbarton, Charlotte County, 8 1-2 square miles to L. B. Smith at \$505 per square mile. In regard to this lot a dispute arose. Charles Anderson of McAdam Junction bid \$25 it is said following Mr. Smith's bid at the upset price \$20 and it is alleged that Col. Loggie who was acting as auctioneer knocked the lot down to him at that price. Mr. Smith objected on the ground that he had not heard the auctioneer and asked that the lot be put up again. This was done and then the Bonnie Lumber Company took a

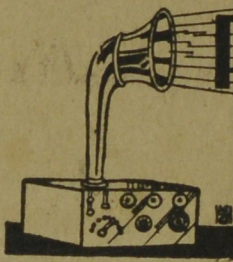
