Division of Troops May be Made-On Other Hand Ottawa May Decide Against Training.

The militiamen of this section of New Brunswick are at a loss as to what preparations to make for annual training camp on account of the uncertainty existing at Ottawa in regard to the militia estimates. So far it is known that both Sussex and Woodstock have been suggested as places for training in 1922. Woodstock has made a particularly strong bid for a camp either for all the rural corps of the district which comprises the province or for those of the western section of Sussex is selected for the eastern section. The town has offered a large area of land to the militia department at such terms that it would be most advantageous for the department to accept. On the other hand Sussex is desirous of having the brigade camp restored to it as it was before the war. District headquarters are said to favor Sussex.

May Not Be Any.

The House of Commons may solve the problem by declaring against any training of militia this year except at local headquarters. There is a strong feeling not only in the House but some hundreds of thousands of veteran troops in civilian life militia training can be dispensed with for one year at least.


Run Totalled Only Four Million -St. John River Now Not Far Above Summer
