NO. 47 A By-Law to Regulate Traffic on Streets in the City of Fredericton.

Be it enacted by the City Council of the City of Fredericton, as follows:

INTERPRETATION OF TERMS.

In this By-Law, unless the context otherwise requires-

The expression "vehicle" means every description of waggon, carriage, cart, sleigh, sled or other thing travelling upon wheels or runners, except a ing, said vehicle shall remain stationary, so long as may be reasonable to allow baby carriage, and whether drawn by any animal or propelled by mechanical power, and includes also a person on horseback and a horse led by any person.

The expression "horse" includes any draft animal. The expression "driver" includes the driver or rider of any horse, the operator of any motor vehicle or the rider of a bicycle.


The expression "curb" means any lateral limit of the portion of a street used or intended to be used for vehicles whether marked by curbing stones





ary unnecessary noise by cutting out the muffler or otherwise.

34. On streets heavy merchandise may be transferred from trucks or other vehicles over the sidewalk by the use of skids, or some suitable protection, provided the sidewalk is not unreasonably obstructed, and for a period of not more than five minutes at a time, except by permit from the chief of police.

DRIVING-CONDITION AND TREATMENT OF HORSES-STEALING RIDES.

35. No person shall drive or conduct any vehicle in such condition or so of this by-law, or any part thereof, are hereby repealed. constructed or so loaded as to be likely to cause delay in traffic, or accident or injury to man, beast or property.

36. No person shall drive or convey through any public street, any vehicle the width of which, with its load, exceeds ten feet, except in accordance with a permit from the chief of police.

37. No person shall carry or cause to be carried on any vehicle, a load the weight of which exceeds six tons, unless such load consists of an article which cannot be divided, except in accordance with a permit from the chie of police.

38. No person when driving a vehicle with a horse or horses attached thereto shall cease from holding the reins in his hands to guide and restrain the horse, nor, when not seated on the vehicle, cease from walking by the head of the shaft or wheel horse, either holding or keeping within reach of the bridle or halter thereof.

39. No one who is less than eighteen years of age shall drive any public, numbered or licensed vehicle.

40. No one shall drive a horse not in every respect fit for use and capable disease likely to cause delay in traffic or accident or injury to persons or property.

41. No one shall ill-treat, over-load, over-drive or cruelly or unnecessarily beat any horse.

42. No horse shall be left standing on the street for a longer period than fifteen minutes, in weather cold or inclement enough to cause suffering, without proper protection by blanketing or otherwise. In case of any violation of this section, any police officer shall forthwith seize and remove such horse,

44. No horse shall be unbitted in any street or highway, unless secured hy a halter.

45. No one shall remove a wheel, pole, shaft, whiffletree, splinter-bar, or any other part of a vehicle or any part of a harness likely to cause accident if e horse or horses start, without first unhitching the horse or horses attached o said vehicle.

46. No one shall steal a ride upon any veh.cle, and no one shall ride upon he rear of any vehicle without the consent of the person in charge thereof.

47. The owner of every vehicle known as a "jitney buss" or other motor vehicle used for hire or the conveyance of passengers for fares or other remuneration, shall not operate or drive any such buss or vehicle, or cause or permit the same to be operated or driven upon any street without license for that purpose first had and obtained from the chief of police, and which license shall expire on the first day of May in each year, and may then be renewed; out no such license shall be issued or renewed until the following fees shall have first been paid to the City Treasurer: (a) In the case of a non-resident owner, an annual fee of twenty-five dollars (\$25.00); in the case of a resident owner, an annual fee of fifteen dollars (\$15.00).

48. The absolute control of vehicular and pedestrian traffic in the treets shall be under the management of the Police Commission of the City of Fredericton through the police, constables and officers who shall have the duty of enforcing the provisions of the by-law.

49. An former by-laws in anywise contrary to the terms and provisions

50. Any person convicted of any breach of any provision of this by-law be liable to a penalty of not exceeding fifty dollars.

51. This by-law shall come into full force and effect on the first day ofA. D. 191 .



The attention of motorists is directed to the following extracts taken from the Crimina Rode of Canada, respecting injuries to persons due to motorvehicles:

Section 35.- "Every one is guilty of an indictable offence and liable to . wo years' aprisonment who, having the charge of any carriage or motor vehicle, aut robile or other vehicle, from wanton or furious driving, or racing or other wilh'ul misconduct, or by wilful neglect, does or causes to be done, any bodily harm to any person."-Revised Statutes of Canada, 1906, C. 146; Statutes of Canada, 9-10 Edward VII., C. 13, sec. 1.

Sectic! 385A-"Whenever, owing to the presence of a motor car on the highway, a saccident has occurred to any person or to any horse or vehicle in charge of any person, any person driving the motor car shall be liable on summary conviction to a fine not exceeding fifty dollars and costs, or to imprisonment for a term not exceeding thirty days, if he fails to stop his car and, with intent to escape liability, either civil or criminal, drives on without tendering assistance and giving his name and address."-Statutes of Canada, 9-10 Edward VII., C. 13, sec. 2.

Section 285 B.—"Every one who takes or causes to be taken from a gar-age, stable, stand or other building or place, any automobile or motor car with intent to operate or drive or use or cause or permit the same to be operated or



No owner or driver of any motor vehicle shall make use of any siren, or other similar contrivance or device, emitting or producing any sound resembling or likely to be confused with the siren, or other contrivance or certificate of the City Treasurer, shall device used for such purposes on any apparatus or vehicle used by the fire be filed with the City Clerk or at his department.

19. Every driver of any vehicle shall, on seeing danger of collision with any vehicle, animal or person, or on receiving any warning, signal or command before from any person, or the driver of any vehicle, requiring him to stop on account of any danger to any person or vehicle, stop immediately and not proceed the requirements of the Election Act have been complied with.

RIGHT OF WAY.

20. Any vehicle used by the police department, or the fire department, any ambulance and any vehicle used for the carriage of His Majesty's mail, shall have the right of way as against any other vehicle on any street, and shall have the right to pass through any procession.

21. A vehicle waiting at the curb shall promptly give place to a vehicle about to take on or let off passengers.

22. The driver of a vehicle on the approach of any fire apparatus, shall immediately draw up the vehicle as near as practicable to the left hand curb and parallel thereto, and bring it to a standstill.

SPEED OF VEHICLES. 24.—No person shall operate or drive any vehicle at a greater rate of ed than is reasonable and proper, having due regard to the traffic and the derman for King's Ward. speed than is reasonable and proper, having due regard to the traffic and the use of the street, or so as to endanger the life or limb of any person or the A. D. 1917. afety of any property. It shall be prima facie evidence of a rate of speed greater than is reasonable and proper as aforesaid if (a) a motor vehicle is operated at a greater speed than twelve miles an hour, (b) a truck, dray, cart or slove with an animal attached thereto is driven at a greater speed than five million hour, (c) a delivery, express wagon, hackney carriage or coach five miles an hour, (c) a delivery, express wagon, hackney carriage or coach. If a girl wants a man to think her with an animal attached thereto, is driven at a greater speed than seven miles superior she shouldn't firt with him; an hour, provided always, that on going around a corner or curve in a street, no vehicle shall be driven at a rate of speed greater than six miles an hour.

STOPPING, STANDING AND TURNING.

25. Unless otherwise directed by a Police Officer, no vehicle shall remain hacked up to the curb except when actually loading or unloading, and then for not more than fifteen minutes at any one time.

26. Unless in an emergency, or to allow another vehicle or pedestrian to cross its way, no vehicle shall stop in any street except close to the curb.

27. No vehicle shall stop in such a way as to obstruct any street or crossing for the purpose of taking on or setting down a passenger, or for loading or unloading freight, or for any other purpose except in case of accident, or when the the to do so by a police officer.
