ONTARIO MURDER CASE ATTRACTS ATTENTION

Girl Charged With Being an Accessary
May be Made a
Principle.

Cornwall, Ont., April 11.—A fresh arrest in the St. Pierre murder case was announced when the trial of Emerson St. Pierre on a charge of shooting his father, an Osnabrock township well digger, on February 8, opened before Mr. Justice Latchford this morning. Mrs. William St. Pierre, widow of the murdered man, will be charged with being an accessory after the fact, it was stated.

R. A. Pringle, K.C., Ottawa, who announced that the arrest would be made in the course of his address to the jury outlining the case, said Mrs. St. Pierre was present when the body of her husband, who had been shot and killed the day before, was buried in the cellar.

Mr. Pringle hinted that the charge against Nettie Richmire, charged now with being an accessory after the fact, might be changed so as to include her as a principle. He said she had first claimed to have done the shooting, later had described how she had engaged the old man's attention while Emerson went upstairs and shot him through the ceiling, and later still had decided to withdraw this second explanation.

The crown would produce a witness who would swear that Nettie Richmire had said that to save the neck of Emerson she would plead guilty to the murder, as she would stand a better chance of getting off than her lover.

Emerson St. Pierre pleaded not guilty.

In her evidence this morning Nettie Richmire in her evidence stated that Emerson St. Pierre shot his father through a hole in the ceiling. The body was afterwards buried in the cellar.

RUSSIA WANTS NO SEPERATE PEACE

Petrograd, via London, April 11.—"The party of the fatherland and the army," which includes most of the members of the Petrograd garrison, has passed resolutions strongly supporting the war.

"We urge the continuance of the war to a victorious conclusion," reads the resolution, "namely, a peace restoring the ancient frontiers of Russia and a free Poland, including the German and Russian territory, a peace without the consent of the Allies would be shameful, would threaten Russian liberty, would brand us with disgrace and treason."

AGRICULTURAL DEPT. TO ASSIST SETTLERS

Hon. Mr. Tweeddale Arranges to Supply
Seed to Settlers in Restigouche
County.

Representations having been made to the honorable Minister of Agriculture from representatives in the county of Restigouche that there was a great scarcity of seed potatoes and seed oats in the Hazen and Grimmer settlements Hon. Mr. Tweeddale at once took steps to make provision to assist the settlers in those new communities so that they would be enabled to produce not only what was necessary for themselves, but also additional quantities for export.

The Minister of Agriculture has endeavored to ascertain from different parts of the province the most accurate information possible with regard to the seed situation. His efforts have been hampered by the fact that for a considerable period before the election and during the campaign, the department was practically without a head, the minister himself being engaged in political work and the former deputy, Mr. Daggett, also interesting himself almost quite as much in the campaign. Because of this, there was a stagnation in the efforts of the agricultural officials and to overcome this some vigorous action has been required.

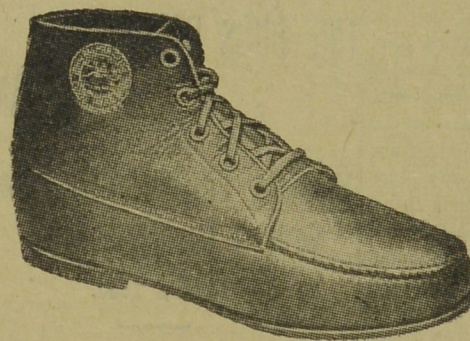

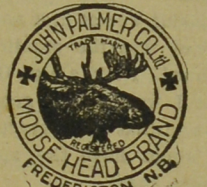

THE ROAD TO THE RIGHT.

YOU'VE met at least one of those few good old souls, who are constantly getting the worst of it when shopping, who don't believe in advertising. A hundred disappointing and instructive experiences have failed to teach him their plain lesson.

When he bought his first watch he was beguiled into buying one without a known name or a trustworthy guarantee. That watch—a poor timekeeper—cost him dearly by reason of missed appointments and missed trains, and for frequent repairs. Yet he paid the price of a good watch.

It is the same story with regard to his underwear, his shoes, and his fountain pen.

This good old soul's case is not unique. Many of us, if the truth be confessed, resemble him; we allow ourselves to be sold merchandise with an unknown brand or trade mark instead of buying merchandise which is well known to us through the medium of advertising. In slang language, we get "stung" pretty often.

In most of these cases we have ourselves to blame, for "the road to the right" thing to buy has been made plain by advertising.

There is no good reason for passing by the known thing, soundly guaranteed, to buy a dubious article, which, quality for quality, cannot be cheaper than the known, branded article.
