## AN EVENTFUL WEEK FOR THE CANADIANS

### Attempts of Germans to Enter Trenches Proved Ineffectual--Garrison Driven Out.

London, March 21.—The following is issued by the Canadian War Records Office as a Canadian communiqué under date of March 18:

The week on the whole has been an eventful one. There were a few patrol encounters and the Germans made several ineffectual attempts to enter our trenches, in particular on Tuesday night. These attacks were made after what was evidently a very carefully prepared bombardment. Not one of these attempts succeeded. On the contrary, the attackers were driven back to their own lines and in one instance left two dead in reach of our wire.

Later in the week a storming party of our men succeeded in entering the German trenches despite heavy opposition. In some places there was hand-to-hand fighting, but no prisoners could be secured. In others the garrison jumped out of their trenches and ran back to their support lines. A few fine days have permitted greater aerial activity and many fights have been witnessed above our lines. Honors have been about equally divided. There has also been a slight increase in artillery activity on both sides.

### BULGARS BOMBARD A SERBIAN TOWN

Corfu, Greece, March 20, via London, March 21.—Asphyxiating gas bombs thrown into the open city of Monastir by the Bulgarians in their violent bombardment on March 17, killed more than sixty civilians, including twenty-five women and thirty-one children, according to the Serbian press bureau. Nearly twenty others, mostly women and children, were killed by shell fire. The bureau has received the following from Saloniki:

"According to supplementary reports, the exact number of the victims of the terrible bombardment of the open town of Monastir by the Bulgarians on March 17 was: Killed, 5 old men, 5 women and 5 children; wounded, 2 old men, 2 women; killed by airships dropping asphyxiating bombs, 6 old men, 25 women and 31 children; suffering from effects of gas, 61, who are not expected to recover."

### TWO GERMAN SPIES HAVE PLEADED GUILTY

New York, March 21.—Albert O. Sander and Charles N. Wunnenburg, indicted as member of the Central Powers War Film Exchange, with engaging in a military enterprise and sending spies to England to get information for the German military authorities, today pleaded guilty.

They will be sentenced tomorrow.

### BABIES DIE IN BURNING HOME.

Saskatoon, Sask., March 20.—Two babies lost their lives in a fire which destroyed the farmhouse of C. Dahl, northeast of Wainwright, last Saturday. The father was severely burned while trying to rescue his children.



The total allotment of bonds of this issue will be limited to one hundred and fifty million dollars, exclusive of the amount (if any) paid for by the surrender of bonds as the equivalent of cash under the terms of the War Loan prospectus of 22nd November, 1915.

The instalments may be paid in full on the 16th day of April, 1917, or on any instalment due date thereafter, under discount at the rate of four per cent per annum. All payments are to be made to a chartered bank for the credit of the Minister of Finance. Failure to pay any instalment when due will render previous payments liable to forfeiture and the allotment to cancellation.

Subscriptions, accompanied by a deposit of ten per cent of the amount subscribed, must be forwarded through the medium of a chartered bank. Any branch in Canada of any chartered bank will receive subscriptions and issue provisional receipts.

This loan is authorized under Act of the Parliament of Canada, and both principal and interest will be a charge upon the Consolidated Revenue Fund.

Forms of application may be obtained from any branch in Canada of any chartered bank and at the office of any Assistant Receiver General in Canada.

Subscriptions must be for even hundreds of dollars.

In case of partial allotments the surplus deposit will be applied towards payment of the amount due on the April instalment.

Scrip certificates, non-negotiable or payable to bearer in accordance with the choice of the applicant for registered or bearer bonds, will be issued, after allotment, in exchange for the provisional receipts.

When the scrip certificates have been paid in full and payment endorsed thereon by the bank receiving the money, they may be exchanged for bonds, when prepared, with coupons attached, payable to bearer or registered as to principal, or for fully registered bonds, when prepared, without coupons, in accordance with the application.

Subject to the payment of twenty-five cents for each new bond issued, holders of fully registered bonds without coupons will have the right to convert into bonds of the denomination of \$1,000 with coupons, and holders of bonds with coupons will have the right to convert into fully registered bonds of authorized denominations without coupons at any time on application to the Minister of Finance.

The books of the loan will be kept at the Department of Finance, Ottawa.

Application will be made in due course for the listing of the issue on the Montreal and Toronto Stock Exchanges.

Recognized bond and stock brokers having offices and carrying on business in Canada will be allowed a commission of three-eighths of one per cent on allotments made in respect of applications bearing their stamp, provided, however, that no commission will be allowed in respect of the amount of any allotment paid for by the surrender of bonds issued under the War Loan prospectus of 22nd November, 1915, or in respect of the amount of any allotment paid for by surrender of five per cent debenture stock maturing 1st October, 1919. No commission will be allowed in respect of applications on forms which have not been printed by the King's Printer.
