

### TWO SEIZURES OF LIQUOR BY CHIEF FINLEY

#### WRONG ADDRESSING THE REASON FOR SEIZURE

#### Pilfering of Liquor for Personal Use While in Transit is Reported—Case on Monday.

Two seizures of liquor were made yesterday and today by Chief Finley, sub-inspector for the city. Both were made at the Dominion Express office. The cause of seizure was improper marking of the packages containing the liquor.

#### Pilfering Reported.

Much pilfering of liquor consigned for personal use has been reported in this section. The stealing is done while the goods are in transit and is usually confined to liquor in wooden containers. Water usually is added to make up the proper bulk.

#### Case on Monday.

A charge of violation of The Intoxicating Liquor Act 1916 has been laid as the result of a seizure made in a local store some weeks ago by Sub-Inspector W. A. Johnson of Tracey. A summons has been served and the case is to be heard on Monday.

#### Salvation Army Tag Day.

The Salvation Army will hold a tag day tomorrow for the purpose of raising funds for huts needed in the work among the troops overseas.

#### Ford Cars Advance \$100.

An advance of one hundred dollars in the price of Ford cars has gone into effect. The types affected by the increase are touring, runabout and chassis.

#### Want More Pay.

The municipal council of the county of Victoria will seek legislation at the approaching session of the House, to enable it to pay members of the council five dollars per day for their services.

#### Change of Residence.

Chief of Police Finley has rented the dwelling house in Brunswick street now occupied by Mr. H. M. Blair and will occupy it on May 1st. Mr. Blair has been filling a position in Halifax for the past two months.

#### Adjournment Until March 5.

The case of W. Henry Maxwell vs. The St. John & Quebec Railway was adjourned yesterday afternoon until March 5th, the defense not proceeding with its case. It is expected that by that time Mr. Benjamin Carson of Public Landing, who is the last witness for the plaintiff will be sufficiently recovered from his illness to give evidence.

#### Banker Transferred.

Victoria County News: Mr. H. L. Alcorn, who for the past five years has been manager of the Bank of Montreal here, received word that he was being transferred to Toronto to manage the Eglinton Avenue branch, which is about five miles from the main Toronto office. Mr. Alcorn has made many friends throughout the county since coming here who are very sorry to learn that he will be leaving for Toronto about the middle of next month.

#### Before Appeal Court.

Argument is being heard today before the Appeal Court in the case of Woodstock Electric Light Co. vs. Dominion Tanneries Co. Mr. J. C. Hartley, K. C., moved to set aside verdict entered for the plaintiff and to enter verdict for defendant or for a new trial. Mr. J. B. M. Baxter, K. C., and Mr. R. P. Hartley the same side. The motion is opposed by Mr. A. B. Connell, K. C., and Hon. F. B. Carvell, K. C. The case of Farnell et al vs. Conway et al was completed yesterday. Court considers.

#### Bogus Ten Dollar Bills.

Chief of Police Simpson of St. John gives warning to the public that some person or persons unknown are putting into circulation bills of the denomination of five and ten dollars which have been raised from one dollar. This is done by cleverly pasting a printed ten over the one in the bill and many already have been received. Warning was given late last fall to banks, hotels, exchange and express offices and large stores to look out for raised bills and since that time several have appeared in St. John. Raised bills have been circulated quite extensively in recent months in Vancouver, Winnipeg and other western cities, but this is the first appearance in St. John.

### CHAUTAUQUA CIRCUIT WILL BE EXTENDED

#### WILL BE HERE ONE WEEK DURING SUMMER

#### Council of Board of Trade Endorsed Project Last Night—Bulk Sales Act was Discussed.

The Chautauqua Circuit which has been a most important feature of public entertainment in the United States for many years past is to be extended to include the Maritime Provinces. Mr. Sutcliffe of Philadelphia, representing the Chautauqua Club of Pennsylvania appeared before the council of the Fredericton Board of Trade last night and outlined the intention as far as Fredericton is concerned. This is the first year the province of New Brunswick was included in the circuit and Fredericton being the capital, it was thought well to begin here. Mr. Sutcliffe's proposal was so well received that nine of the members present signed a guarantee with regard to expenses. Thirty signers are required to guarantee \$1,500.

Lectures by prominent persons with musical features of each session are well known parts of the program. One hundred people will be brought by the Chautauqua Club including a forty-piece orchestra which will play the complete opera "Robin Hood." The club will furnish all its tents and will do its own advertising. A site is required, however, of the local people interested. Arrangements have been made to have tickets sold by the Red Cross Society of the city. The course will be given one week in July or August.

#### Bulk Sales Act.

The meeting of the council of the Board of Trade last night was chiefly for the purpose of considering the Bulk Sales Act. A decided difference of opinion developed and the matter was left in the hands of President Campbell who will secure further information.

#### Telephone Rates.

President Campbell reported that the result of the joint meeting of representatives of the Board of Trade and the City Council was a determination to continue opposition to the proposal of the New Brunswick Telephone Company for power to increase rates until further expert evidence from an impartial source is obtainable.

#### Development of Water Powers.

A resolution of the Woodstock Board of Trade concerning the development of water powers in New Brunswick was approved and a committee was appointed to draw up a similar resolution in support.

A communication from the Maritime Branch of the Canadian Manufacturers' Association was received with a draft bill concerning uniformity in provincial legislation. The council decided to frame a resolution endorsing the same to be forwarded to Premier Foster.

### TRAIN WRECK AT NEREPIS HAS BLOCKED C.P.R.

#### TWELVE FREIGHT CARS REPORTED OFF TRACK

#### Communication with St. John Cut Off—No Train Expected Until Late This Afternoon.

Communication between St. John and Fredericton by C.P.R. was broken this morning as the result of a wreck of a freight train near Nerepis which occurred last night. The early train for St. John left Fredericton at the usual time but it is not known how far it got on its way. One story is that it stopped at Fredericton Junction until the line is cleared and another is that its passengers were transferred over the break at Nerepis.

#### May Arrive This Afternoon.

The C.P.R. station in this city had no definite word from Nerepis at an early hour this afternoon but it was thought probable that a train would arrive with passengers from St. John at about four o'clock. Whether the line would be clear or a transfer made around the wreck was not known. The smash is reported to have been a bad one and the line to be in bad condition.

#### Carleton Curlers Held Up.

The members of the Carleton Curling Club who were playing the Fredericton Club here yesterday afternoon and last night were held up by the wreck and remained here this morning.
