Be it enacted by the Lieutenant-Governor and Legislative Assembly as follows:

1. This Act may be cited as the "Housing Act, 1919."

In this Act, unless the context otherwise requires the following expressions shall have the meanings assigned to them: 'Local Authority' shall mean any City or Town Council of any regularly incorporated Town or City or the Municipal
