PROHIBITION MEASURE ADOPTED BY THE HOUSE

Debate was Continued in the Early Hours of the Sabbath Day—Slim Attendance of Members—New Measure Does Not Prohibit the Manufacture of Liquor for Export—Prorogation is Likely to Take Place This Afternoon.

Ottawa, Nov. 9.—The government measures enacting conditional prohibition have weathered the commons. Some members of the upper house prophesied that one of them, the bill amending the Canadian Temperance Act will run aground on the senate shoals, but the administration expects both to receive the signature of the governor general before prorogation on Monday afternoon.

Whatever the senate does it will do quickly and on Monday morning. Many arguments which senators were prepared to urge against it have been forestalled by amendments already made by the minister of justice, Hon. C. J. Doherty. The bill now only provides for the Dominion government holding a referendum in any provincial area whenever it is informed that the legislative assembly of such an area has passed a resolution requesting that a province-wide vote should be taken of all the electors on the question of the importation or transportation of intoxicating liquors into that province.

These bills will still leave to manufacturers of any province the right to make intoxicating liquors for export or for sale in any province whose laws do not forbid it. There is also a clause added which makes it incumbent on the government to hold a referendum on the question of revoking prohibition where any misguided legislature passes a resolution that this is done. Therefore, as it works both ways, the senate should not object.

While the bill was in the committee stage another amendment was made to the effect that the federal government would take action only in the case of a province which had already by provincial statute made unlawful the sale of intoxicating liquors as a beverage. An amendment by J. E. Armstrong of Lambton, was also added to provide that the federal government would have to act within three months after receiving a petition from a provincial legislature.

Not One-Tenth Present

The chief opposition to the bill came from E. Gus Porter member for Hastings, who brought in an amendment that a referendum would have to show a three-fifths part of the total vote cast in favor of prohibition before the Dominion government could enact it. On a standing vote the amendment was defeated by a vote of 14 to 8, thus indicating that on one of the most important questions before the house during the session there were not one-tenth of the members present.

The first bill which passed without any objection in the afternoon, simply provided penalties for the manufacture of intoxicating liquor with the intention of dealing with it afterwards in violation of the law of the province where it is manufactured the written approval of the attorney-general is made necessary to prosecute a person outside of the province.

It was 9:30 o'clock Saturday evening when Hon. C. J. Doherty rose to introduce the government's main temperance measure. He was very careful first to meet the criticism of those who claimed the act delegated federal authority to the provinces. He said that the bill did no such thing. It simply divided the country into various areas which for convenience were made identical with the provincial areas, but the provinces were not dealt with nor referred to in this legislation in their quality of provinces having separate and distinct legislatures. It was simply a Dominion provision providing a way whereby people in the areas selected could express their wishes as to the prohibition of the importation of intoxicating liquors. The occasion for testing this desire was to be a resolution passed by the legislature asking for a referendum. The request of the legislature would be considered to justify the setting in motion of the act because it represented the people in the areas involved. There could not arise any question as to what were the provincial powers of the legislatures. The subject matter of the bill was the importation generally into the Dominion and importation from one province to another.

Piecemeal Legislation

D. D. McKenzie objected to the bill as providing piecemeal legislation. His province of Nova Scotia might become dry and be isolated between a wet province and a wet state, and it would be

very difficult to prevent an illicit trade developing.

Opposes Plebiscite

Hon. W. S. Fielding thought it a grave mistake to require a plebiscite from any province of the dominion. It would be ample for the legislature to speak for the province to have the manufacture and importation stopped within the province. In his own province of Nova Scotia the people had again and again expressed themselves on the question and he thought that elsewhere as well temperance people would object to being put to the expense of holding plebiscites.

Violation of B. N. A. Act

E. Gus Porter said that the statement of the minister had removed one of his chief objections to the bill when it had been made clear that manufacture for export would be allowed. He wanted it thoroughly understood at the outset that he was not advocating the cause of the Liberty League or any of the particular interests again which the bill was aimed. He did not think the question of temperance was involved in the legislation except in a very general way. His objection was that it was in violation of the constitution of the dominion. Section 21 of the British North America Act provided that "Articles of the growth, produce or manufacture of any one of the provinces shall form and after the union be admitted free into each of the other provinces."

Hon. C. J. Doherty in closing the debate said this was not a customs law. The law was only to strengthen and fortify the enforcement of a law passed in a community which desired it and would stand behind it. With regard to Mr. Fielding's proposal he recognized the advantages of the proposal if it were right constitutionally. Such legislation was not in their power if it delegated powers to provincial legislatures.

Hon. Mr. Fielding—"That is not my object. I propose that the legislation be made effective on a petition from the legislature."

Hon. Mr. Doherty again argued that the representative character of the members of legislature would justify this parliament in enabling the people of that area to express their desire on this question. Proclamations issued by the government under this bill would go direct to the people. This legislation was for the whole of Canada and provided that if the majority did not want the liquor to come into a province it would not do so. It was local option with the area enlarged. The provincial legislatures as legislative bodies would play no role whatever, but simply be interpretative of the sentiment of its province.

The province would not force the dominion but the federal parliament enacted that the provincial body under certain circumstances should take a certain action.

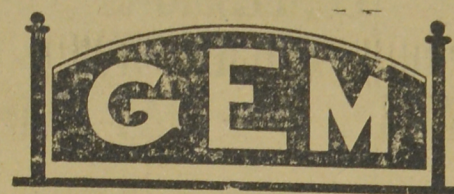

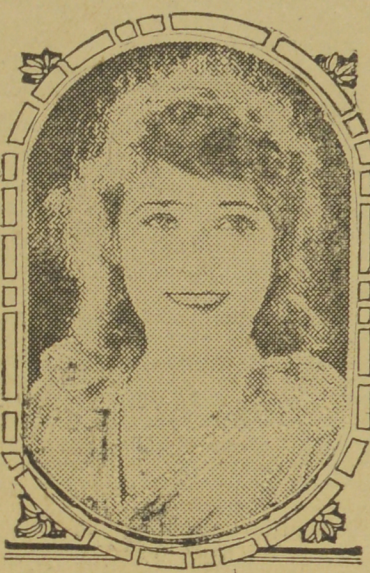
