

COUN. DENNIN DEFEATED IN NORTH LAKE

SIXTH COUNCILLOR DEFEATED IN ELECTION

Coun.-Elect Floyd C. Smith Led the Poll—Coun.-Elect Coburn Trunk Road Superintendent.

Returns for the Parish of North Lake in the biennial municipal elections for the County of York show that still another member of the council elected in 1917 has gone to defeat. The defeated councillor is James P. Dennin whose place is taken by Coun.-elect Floyd C. Smith who led the poll.

The returns from North Lake are as follows:
Floyd C. Smith 92, Coun. Arthur C. Wetmore 70, Coun. James P. Dennin 57.

Six Councillors Defeated

The defeat of Coun. Dennin makes a total of six members of the council who failed of re-election upon appeal to the electors. The canvass against the Municipal Home project was particularly effective in the western portion of the county.

Thirty Years' Service

Coun. Robert Thompson who was defeated in Manners Sutton was councillor for that parish for upwards of thirty years and was a notable figure at council meetings. Coun.-elect Frank Coburn who is a prominent resident of that parish is one of the Superintendents of Trunk Roads for the province.

Funeral This Afternoon

The body of the late Mrs. John McBean arrived from St. John last evening and was taken to the former home at Nashwaak for interment this morning. The funeral took place this afternoon at one o'clock interment being made at Tay Creek.

Mrs. W. B. Chandler Dead

Mrs. Chandler, wife of Judge W. B. Chandler, died at the family home at Moncton last evening quite suddenly of heart failure. She had been in failing health some months. She is survived by her husband and one daughter, Mrs. C. R. Troop.

Reorganizing Bands

Bandmaster James White of the G. W. V. A. Band was at Oromocto yesterday reorganizing the band there which existed before the war. It is composed of about fifteen pieces and promises to be successful under his leadership.

Drunks Before Magistrate

Two drunks appeared before the Police Magistrate yesterday and one of them was fined \$8. The other one who was having his first drink of intoxicant, as he stated for some twenty or so months, was let go on a three months' suspended sentence upon promise of good behaviour.

Car Struck Hearse

While officiating at a funeral Tuesday afternoon C. Allan Frost, undertaker of Hampton was painfully injured when the hearse which he was driving was struck by an automobile causing Mr. Frost to be thrown to the ground breaking his arm, injuring his knee and head and causing other minor injuries. Mr. Frost was taken to his home where a doctor attended him.

Officiated at Hampton

A wedding of interest to a large circle of friends throughout the province was solemnized in the United Baptist church, Hampton, Tuesday afternoon at 2.30 o'clock, when Rev. W. H. Johnson, assisted by Rev. E. W. Lester of Marysville an uncle of the groom, united in marriage Marion Freeze Ryan, only daughter of Mr. and Mrs. Howard Ryan, to Robert E. DeLong, eldest son of Mr. and Mrs. John DeLong.

Civil Court Cases

Two civil court cases were before the Police Magistrate yesterday, the first being that of Josiah Fairley vs. Charles Lebel, of McGivney. Action was brought because of a dispute over a difference of seventy-five cents on a milk bill. Judgement was given for the plaintiff. In the second case action was brought for the amount of \$2 for a pulley block loaned to Lebel by Fairley and \$25 for a hog of Fairley's which had strayed from his land to that of Lebel's and was locked up by Lebel with two sows receiving injuries which resulted in its death. The case was continued yesterday afternoon and was adjourned for judgment until next Wednesday. P. J. Hughes appeared for the plaintiff and G. T. Feeney for the defence.

Shot Cow Moose

Charles Hay and Lloyd McCoy of Barker's Point were caught red-handed by Provincial Constable Charles Barker in the act of bringing the carcass of a cow moose which they had shot from the woods on Monday night. Residents of the vicinity had reported the shooting and acting on the instructions of Chief Game Warden L. A. Gagnon, Constable Barker investigated. He seized the firearms and obtained the names of the men and later on instructions from the Chief Game Warden disposed of the meat to a local butcher and hotel. It is understood that the men will face several charges when they are brought before Magistrate Limerick. Warrants are now out.

WILL AFFILIATE WITH MARITIME BOARD OF TRADE

J. D. PALMER, J. S. NEILL AND H. S. CAMPBELL TO GO

Fredericton Board Pressing for Better Train Service on St. John & Quebec Railway.

A meeting of the executive of the Fredericton Board of Trade was held last evening to consider several items of importance. The affiliation which was proposed with the Maritime Board of Trade was considered and agreed to. Several important discussions took place.

The executive agreed to affiliate with the Maritime Board of Trade after paying the necessary fee of 15 cents per member. Three delegates J. D. Palmer, Ex-President; J. S. Neill, Ex-President and H. S. Campbell, President were appointed to attend the meeting of the Maritime Board of Trade on the 7th of the present month.

To Cooperate

A motion was introduced and passed that the Fredericton Tourist Association act in conjunction with the All New Brunswick Tourist, Game and Resources Association in interviewing the Provincial Government concerning a grant with which to carry out the work of the organization. The Fredericton Tourist Association will still act as a committee of the Board of Trade at the same time doing all in its power to further the work of the All New Brunswick Tourist, Game, and Resources Association.

A reference was made by the President to vocational work for the returned soldiers. A letter from the Secretary of the Canadian Manufacturers' Association, Maritime Branch, was read advising the members that he hoped to arrange with Mr. G. E. White house the representative of several journals in the British Isles in Canada, to include the Maritime Provinces in his itinerary.

In the matter of the Valley Railway schedule, the President was requested to make further efforts to have the C. N. R. management arrange a better passenger schedule.

Road Signs Needed

Several members of the Board who are enthusiastic motorists urged the great necessity of sign boards at the different branch roads for the benefit of New Brunswickers as well as American tourists and Canadian motorists in the province.

Sovereign Grand Priory

THREE HOUSES DAMAGED BY FIRE ON SHORE ST.

FIRE APPARATUS SLOW IN RESPONDING

Dwellings Occupied by James W. Gough, Geo. Bell and W. Turvey—Outbuildings Burned.

Fredericton had another fire in its residential district shortly after noon today, which got an excellent start and was threatening for a time on account of slow response by the fire apparatus. The motor-truck balked at the hose-station and the run was a hard one for the horses the fire being about a mile away. The motor-truck finally got away after some minutes' delay.

Three Dwellings Damaged

Three dwellings adjoining one another were damaged. Mr. James W. Gough is the owner of two of them, one occupied by himself and the other by Mr. George Bell. The other is owned and occupied by Mr. William Turvey. The damage was confined practically to the sheds and outbuildings of the dwellings of Messrs Gough and Bell that of Mr. Turvey being merely scorched. The outbuildings were practically destroyed. The fire got into the rear of the Bell residence but did little damage.

Origin Not Known

The cause of the fire is not known. When first observed it was bursting from a barn which lies at the rear of both the houses owned by Mr. Gough. It had a great start before the first water was put on. After their arrival the firemen worked hard and kept the flames where they started.

Could Not Be Avoided

It is reported that the delay of the motor-truck could not be avoided and is the first of the kind which has occurred in a long time. The reserve horse was not used to long runs and made as fast time as it could with the hose-wagon.

Needs Overhauling

That several of the fire alarm boxes as well as the whistle need an overhauling was demonstrated last night when a fire broke out at the Barker House stables. The whistle sounded several times and the alarm was finally given by telephone. The fire was caused by a match being thrown into a stove the pipe of which was unconnected. It did not cause much damage.
