According to a bulletin issued by the Dominion Bureau of Statistics, there has been quite an/increase in the number of live stock in Canada in 1919 as compared with the year 1918. According to an increase of 58,112. According to the bulletin, there are now 10,084,111 head of cattle in Canada as compared with 10,045,867 last year, a very small increase. The number of swine is now placed at 4,040,070, an increase of 249,612 over last year and the number of sheep at 3,421,958, an increase of 369,210. 


