SOME AMENDMENTS TO THE INTOXICATING LIQUOR ACT

(Passed 22nd June, 1917.)

Be it enacted by the Lieutenant-Governor and Legislative Assembly, as follows:

1. Sub-section (n) of section 2 of the Act entitled "An Act for the suppression of traffic in Intoxicating Liquor, 1916," is hereby repealed, and the following enacted in lieu thereof:

(n) The expression "wholesale license" shall mean a license authorizing a chemist or druggist, duly registered as such, under and by virtue of the Act or Acts relating to the New Brunswick Pharmaceutical Society, in force in this Province, or such other person or persons as may be approved by the Chief Inspector, to sell, subject to the provisions of this Act, in the warehouse or store defined in such license, alcohol in sufficient quantities to manufacturers and to those engaged in mechanical pursuits, upon the written authorization of the Chief Inspector, and in quantities of ten gallons, at any one time, for scientific purposes, and to sell to any duly registered medical practitioner, but to no other, liquor in sufficient quantities to meet his professional requirements, and to any retail licensee liquor in sufficient quantities to meet physicians' prescriptions, and to clergymen for sacramental purposes, and to any bona fide hospital in sufficient quantities to meet the requirements of

Section 11 of the said Act is hereby repealed and the following enacted in lieu thereof:

11. No person other than the father, mother, guardian or physician, nurse or attendant of a minor, or retail licensee under prescription from a physician, shall sell or give liquor to any person under the age of twenty-one years, and then only for

3. Section 33 of the said Act is hereby amended by the insertion of the word "manufacturing" between the words "mechanical" and "or" in the second line thereof.

4. Section 38 of the said Act is hereby repealed and the

following enacted in lieu thereof:

38. No person shall, upon any vehicle of transportation or at any public place or resort, or upon any sign or bill board, or in any newspaper, periodical or other publication printed and published in this Province, or upon any circular, poster or price lists, or otherwise, advertise liquor, or advertise the manufacture, sale, keeping for sale, or furnishing of liquor, or the person from whom, or place where, or the price of which, or the method by which liquor may be obtained. And no person shall sell or distribute any such matter, and no person, whether owner or occupant, shall permit any sign or bill board containing such advertisement to be or remain upon his premises after the coming into force of this Act, provided, however, that nothing herein contained shall prevent the publishing of the names and places of business of licensees under this Act.

5. Section 39 of the said Act is hereby repealed, and the

following enacted in lieu thereof:

39. Nothing herein contained shall prevent any person engaged in mechanical business or in scientific pursuits from having in his possession alcohol for mechanical, manufacturing or scientific purposes, as the case may be, in a quantity not exceeding ten gallons at any one time, or a larger quantity when authorized, in writing by the Chief Inspector, but the alcohol used in the preservation of specimens for scientific purposes shall not be included in said ten gallons; or to prevent any person, being a clergyman, from directly importing or having in his possession any quantity of wine for sacramental purposes.

6. Section 47 of the said Act is hereby repealed and the

following enacted in lieu thereof:

47. Any dentist who is a duly registered member of The New Brunswick Dental Association, and who is lawfully and regularly engaged in the practise of his profession, and who shall deem it necessary to administer to any patient being then under treatment by him, liquor, may himself administer to such patient the liquor thus needed, and for such purpose he may keep in his office a quantity of liquor not exceeding one pint at any time and one gallon of alcohol for mechanical purposes.

7. Section 145 of the said Act is hereby repealed and the

following enacted in lieu thereof:

145. (1) In case any liquor seized under any of the provisions of this Act does not have clearly marked on the outside of the package or vessel containing the same the name and address of the person for whom the same is intended or if the name or address of such person is fictitious or not known, or if the person to whom the same is addressed cannot be found at such address given, or if on such package shall not be specified the fact that liquor is contained in such package, or if the bill of lading of such package shall not contain the same information, it shall be prima facie proof that such liquor is intended to be sold or kept for sale in violation of this Act, and if no claim is made to such liquor and no notice thereof given to the Inspector within thirty days after such seizure, the Inspector 180 and 181 of this Act, he shall be liable to the penalties proshall apply to a Magistrate, Justice of Justices for an order that such liquor be destroyed, and the Magistrate, Justice or Justices on receiving an affidavit of such facts, shall order that such liquor be destroyed, and the Inspector shall thereupon the words "eleven-thirty." cause the same to be destroyed; or upon application of the Commissioners of a Public Hospital or Almshouse or Provincial Hospital by the authorization of the Chief Inspector, the Justice may order that the liquor, or any part of it, instead of being destroyed, be handed over to such hospital, almshouse or provincial hospital for medical purposes.

(2) If such liquor, or any part thereof, was shipped as other goods, or was covered or concealed in such manner as would probably render discovery of the nature of the contents of the vessel, cask or package in which the same was contained more difficult, it shall be prima facie evidence that the liquor was herein shall prevent druggists from keeping their premises opsold or shipped or was intended to be sold or kept for sale in en during such prohibited hours for the carrying on of their contravention of the provisions of this Act. 8. Section 165 of the said Act is hereby amended by the insertion of the word "wilful" between the words "every" and "default" in the first line thereof.

9. Section 180 of the said Act is hereby repealed and the

son, the Chief Inspector may, upon payment of such fee as may be fixed by the Lieutenant-Governor-in-Council, issue a license to such person for the sale of such drinkable liquids as are non-intoxicating, that is, having less percentage of alcohol than 2 per centum of proof spirits such as hop-beer, root-beer and similar liquids or beverages that contain alcohol, and are classed under sub-section (a) of section 2 hereof as non-intoxicating, such license to be known as a beer license, and shall be in force until the first day of May next succeeding the issue thereof. Such license shall be as in Form No. 37 in Appendix to

10. Section 181 of the said Act is hereby repealed and the following enacted in lieu thereof:

181. A "beer license" shall be construed to mean a license for selling, bartering or trafficking by retail in such drinkable liquids as are classed by this Act as non-intoxicating, but no such license shall authorize the sale or keeping for sale of any beverages which are in fact intoxicating, malt or spirituous. But no license shall be required for the sale of soda-waters of other beverages containing no alcohol.

(a) If any person without a license shall sell or keep or offer for sale any of the temperance drinks mentioned in sections vided by section 94 of this Act.

11. Section 184 is hereby amended by striking out the word "ten" in the 6th line thereof and inserting in lieu thereof

12. Section 185 of said Act is hereby repealed and the

following enacted in lieu thereof:

185. No person holding a beer license shall sell on Sunday any of the drinks or beverages for sale of which a license is required under this Act, nor shall the premises licensed be kept open after the hour of eleven-thirty at night, nor be opened before seven o'clock in the morning; provided that this section shall not apply to the sale of such drinkable liquids as are classed under sub-section (1) of section 2 hereof, as non-intoxicating, to guests in hotels; and provided also, that nothing ordinary business; but they shall not, during such prohibited hours, sell any of the beverages mentioned in sections 180 and

13. Section 192 of the said Act is hereby repealed and the

following enacted in lieu thereof:


