

TEXT OF BILL RESPECTING VOCATIONAL EDUCATION

Be it enacted by the Lieutenant-Governor and Legislative Assembly, as follows:

1. Section 3 of the said Act is hereby repealed and the following is enacted in lieu thereof:

3. (a) For the purpose of administering this Act, the Board of Education shall appoint a Vocational Education Board, consisting of nine members, namely: The Chief Superintendent of Education, the Principal of the Normal School, the Secretary for Agriculture, the Director of Elementary Agricultural Education, and five others, of whom one shall be a representative of farming, one of labor, one of manufacturing and one of commerce. The Chairman shall be elected from the last mentioned five, and the Chief Superintendent of Education shall be the Vice-Chairman. The five members of the Vocational Education Board, as above set out, shall be appointed to serve till June 30th, 1921. In June, 1921, one member shall be appointed to retire in 1922, one in 1923, one in 1924, one in 1925 and one in 1926, on the 30th of June in each case. After 1921, no member shall be eligible to succeed himself on the Board, and each appointment shall be made for a term of five years only. No remuneration shall be paid to the members of the Vocational Education Board for services as members of Board, but they shall be reimbursed for all necessary outlays in connection with their duties under this Act.

(b) It shall be the duty of the Vocational Education Board to investigate the need for and to aid in the introduction of Vocational Education; to superintend the establishment of Schools and Departments for the various kinds of such education, and to supervise and approve such Schools and Departments, as hereinafter provided. The Vocational Education Board shall appoint the officials necessary to administer this Act, define their duties and fix their salaries, subject to the approval of the Lieutenant-Governor-in-Council. The Board shall make an annual report to the Lieutenant-Governor-in-Council.

2. Section 4 of the said Act is hereby amended by striking out the word "the" after the word "Board," in the eleventh line thereof, and inserting the word "any" in the place thereof, and by inserting the words "so recommending" after the word "Town" in the eleventh line thereof, and by inserting the words "Board of" after the word "or" and before the word "School" in the eleventh line thereof, which section when so amended shall read as follows:

4. In Cities and incorporated Towns, the Board of School Trustees may apply, on the recommendation of the Common Council, City Council or Town Council, as the case may be, and in districts where the School Trustees are elected, the ratepayers may, at any annual meeting, or any special meeting called for the purpose, by resolution, request the Trustees of such School Districts to apply to the Vocational Education Board for power to establish, equip and maintain a Vocational School setting forth and including in such application the plans of any proposed building and the nature of the instruction desired, and upon such application being approved of by the Vocational Board, any City or Town so recommending, or Board of School Trustees so applying, shall have the power to assess and collect a sufficient sum for the purpose of establishing and equipping a suitable building or for otherwise carrying on the work, and for maintaining the same, and for the payment of tuition fees and in all respects carrying out the provisions of this Act, and for the purposes aforesaid shall have all the powers of a Board of School Trustees under the Schools Act, Chapter 50 of the Consolidated Statutes, or under any amendment thereof.

3. Section 5 of the said Act is hereby amended by striking out the word "capital" in the thirteenth and sixteenth lines thereof, and inserting the word "employer" in the place thereof.

4. Section 6 of the said Act is hereby repealed, and the following is enacted in lieu thereof:

6. Two or more cities, towns or school districts, each having secured the approval and provided the funds necessary (according to section 4 hereof) may co-operate to establish a Vocational School under a joint Vocational Committee composed of two



members of each School Board, appointed by their own Board in each case, and three others appointed by the Vocational Educational Board; and any city or town, having secured the approval and provided the necessary funds, as hereinbefore provided, may co-operate with any municipality to establish a Vocational School under a joint Vocational Committee, composed of two members appointed by the Municipality, two members of the School Board, of each City or Town co-operating, appointed by such School Board, and three members appointed by the Vocational Education Board, one of whom shall be the Warden of the Municipality, and two from the Cities or Towns so co-operating.

5. Section 2 of the said Act is hereby repealed and the following is enacted in lieu thereof:

8. Members of a Vocational Committee, appointed under section 5 of this Act, except the Chairman, shall hold office for not more than three consecutive years. The initial membership of said Committee, excluding the Chairman, shall be appointed, one-half for two years, and one-half for three years, or one-third for one, one-third for two and one-third for three years. Succeeding appointments shall be for terms of three years.

Members of a Vocational Committee appointed under section 6 of this Act shall be appointed as follows: One appointee of any School Board, one appointee of any Municipality, and one appointee of the Vocational Board for a period of two years. The remainder for three years. Succeeding appointments after the initial membership of said Committee shall be for terms of three years, and no member shall be eligible to succeed himself on said Committee. Such Committee shall elect its own Chairman.

Members of a Vocational Committee appointed under section 7 of this Act shall be appointed as follows: Two appointees of the Municipality and two appointees of the Vocational Board for a period of two years. The remainder for three years. Succeeding appointments after the initial membership of the said Committee shall be for terms of three years, and no member shall be eligible to succeed himself on said Committee.

THE QUEEN OF ROUMANIA ADMIRER BY THE WORLD

Two wearers of crowns emerge from the world with the admiration of the world. King Albert of Belgium and Queen Marie of Roumania have displayed a fortitude and bravery that have compelled the respect even of their enemies. Albert, returning in triumph to his capital, has seen his people on the way to recovery from the sufferings of war. That goal is not yet in sight for the faithful Marie, who has arrived in Paris as a supplicant to the Allied diplomats in behalf of her hungry people. On her breast she wears the French War Cross with a palm, bestowed not in idle compliment to the queen of an allied state, but as the citation pointed out, because she was "a good soldier."

All that she has proved herself to be. The daughter of a son of Queen Victoria and a German princess, she has opposed everything German. Her husband, King Ferdinand, with whom she ascended the throne after the outbreak of the European war, is a Hohenzollern with a brother in the German army. How much Marie did to turn him against his natural affiliation may never be known outside the royal palace, but soon after their ascension to the throne Roumania entered the war.

All the world knows what followed. Deserted by Russia and isolated from her other allies, Roumania was overrun by an overwhelming force of Germans and Bulgarians. As soon as her armies took the field Queen Marie donned the garb of a Sister of Charity and gave all her time to the sick and wounded. Until forced to flee before the invaders she gave the greater part of her palace in Bucharest over for use as a war hospital. Oppressed by the double grief of her country's misfortunes and the death of her youngest child, Queen Marie still devoted

herself to hospital work. For days, fleeing before the advancing Germans she and her family had no home. Writing of this period when she buried her private sorrow in that of her subjects she said:

"As a queen it was my duty to place myself at the service of my suffering people, to place myself there where I could hear every cry of agony and every echo of suffering and distress."

She earned the title of "the Joan of Arc of Roumania," and when, overcome by hunger and superior forces, Roumania was forced to sign a humiliating treaty of peace, Marie declared she would never accept the result. At the final review before the demobil-

HOUSEHOLD SCIENCE.

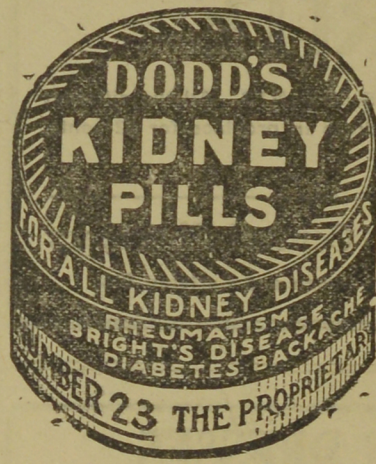
A damp woollen cloth will pick up small pieces of broken glass.

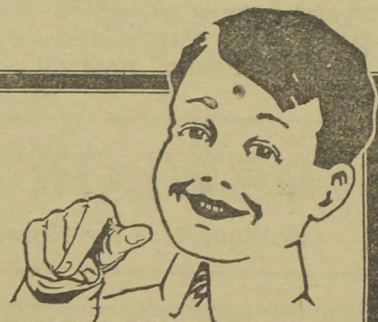
