## INTERESTING DIVORCE CASE BEFORE BOSTON COURTS

Loving Epistles Exchanged by Wife and Husband Read Out in Court—"Dearest Boy" and "Old Darling" Among the Terms Used—Wife Relates a Story of Husband's Alleged Cruelties to Her.

Boston, Jan. 22—Loving letters that passed between Mr. Margaret Reed Freeman of Hyde Park and her husband Ernest B. Freeman, also of Hyde Park, were placed in evidence yesterday at a hearing in her suit for divorce before Judge Fred W. Fosdick in the Suffolk Superior Court. She alleges cruel and abusive treatment.

"Dear Little Girl" was a phrase used by Freeman in his missives. Those written by his wife started "My Dearest Boy" and "Dear Old Darling."

The couple were married in Worcester, Jan. 14, 1903, and have had six children, four of whom are alive. The eldest, Sally, is 16, Ruth is 14, Barbara six and Reed five.

The couple separated in July of last year. Injunction proceedings were brought by Mrs. Freeman to prevent her husband from interfering with her after they separated.

Yesterday morning, Ex-Gov. Eugene N. Foss was in court room waiting to be called as a witness by Freeman, it is understood.

The libelee is general manager of the Sturtevant Blower Works at Hyde Park at a salary said to be \$20,000 a year. For years Ex-Gov. Foss had been the head of the company.

For four hours Mrs. Freeman was on the stand giving direct testimony in answers to questions of her counsel, Damon B. Hall of Hurlburt, Jones & Hall. At 3.30 in the afternoon Mr. Hall turned the witness over to Thomas Hunt of Gaston, Snow, Saltonstall & Hunt, who are contesting the divorce libel for Mr. Freeman. Other counsel represented in the case for the libelee are Bates, Nay, Abbott & Dane and Horatio Alden.

It was during the half hour late in the afternoon that letters from Mrs. Freeman written to her husband while he was on business trips in 1906, were introduced in evidence in the cross-examination.

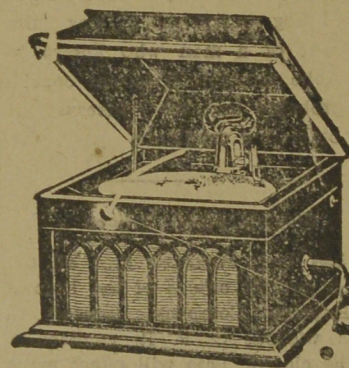
