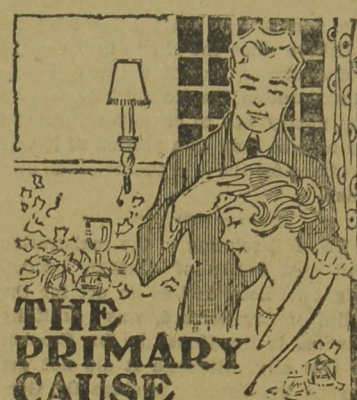
## MARBLES AND LOVE ARE SIGNS OF SPRING
