BRITISH HUSH POLICY ON JUTLAND IS ASSAILED

The Admiralty Now Announces That No Official Account of the Great Naval Battle will be Published—Material Collected Has Been Handed Over to Writer of Official Naval History of the War.

London, Nov. 20—Amid a clamorous demand for the "Truth about Jutland" the British Admiralty has announced that no full official account of the big naval battle is to be published, but that the whole mass of material collected has been handed over to Sir Julian Corbett for incorporation in his semi-official naval history of the war. This has led to more violent denunciations than ever of the Admiralty's policy of "hush" regarding Jutland, which virtually dates from the morning of the battle itself, when the first official news gave the impression that the British navy had suffered a disastrous defeat.

"It is still believed abroad that Jutland was a German victory," complain the Admiralty's critics; and their demands for the full official facts are accompanied by the publication of sinister rumors, officially denied, of sharp disagreements between Admirals Jellicoe and Beatty over the former's alleged retirement from the battle when the annihilation of Von Scheer's fleet was within his grasp. The suggestion, obviously, is that the Government is suppressing facts in order to whitewash Jellicoe.

One curious excuse made by the Admiralty is that "Sir Julian Corbett's 'Naval History of the War,' in course of publication under the authority of the Committee of Imperial Defence, whose volume including Jutland, is likely to be published in the course of next year, and the publishers have made representations that they would have strong reason to complain of the simultaneous publication by the Admiralty of any such narrative."

Another excuse was that a mass of new information has turned up in Germany.

Avoiding Responsibility

A hint that the Admiralty's action has been taken with a view to avoiding responsibility is found in this announcement prefacing Sir Julian Corbett's first volume already published. "The Lords Commissioners of the Admiralty have given the author access to official documents in the preparation of his work, but they are in no way responsible for his reading or presentation of the facts as stated."

Arthur H. Pollen, the eminent naval critic, has made some pointed remarks on the affair. He says:

"We are told of controversy between the two schools of naval thought—the fighters, represented by the present Admiralty War Staff on the one hand, and the non-fighters, represented by the Fisher-Jellicoe group, with their big spokesman, Sir Julian Corbett, on the other. If this rumor be true, then the victory has gone to the old gang, despite the fact that the new men are the Government's official advisers. We are told, of course, that Lord Beatty 'has acquiesced in this decision.' Now, the decision has two characteristics.

Breach of Faith.

"The public has been promised an impartial statement of the facts. Not to keep this promise is a breach of faith. This promise was made before Lord Beatty came to the Admiralty, and he has endorsed that promise so

often that he cannot have wished to agree to the present decision. Further, as a matter of policy, he cannot possibly be a willing party to the suppression of the truth.

"If Lord Beatty has acquiesced, we cannot believe that it was in order to save the personal feelings of Lord Jellicoe or to prevent the truth coming out. The explanation must be that there has been pressure from without. What does that mean? Why should there be this pressure? Is it to save the consistency of those who made Lord Jellicoe First Sea Lord, who kept him in office during a year of continuous failure, first against the submarines, then in many other directions, until he was dismissed at Christmas?"

HYPNOTIZED GIRL PUZZLED THE EXPERTS

Vienna, Nov. 30—The experiment of a hypnotist in giving a criminal suggestion to a subject here recently worked so well that all Vienna is discussing a sensational case which mystified the police and fooled several reputable physicians and specialists.

Walter Senn, a professional hypnotist, wished to disprove an assertion made by Dr. Wagner-Jauregg, a famous Vienna psychiatrist, that a crime could not be committed in response to a hypnotic suggestion. In the presence of two witnesses, Senn hypnotized an 18-year-old girl, Mia Osta, whom he had used regularly as a subject for experiment and to whom, while she was in a hypnotic sleep, he gave an explicit command to force her way at all cost into the presence of Dr. Wagner-Jauregg and shoot him with a pistol after which she would continue under his hypnotic control until a given hour.

The girl was provided with an old muzzle-loading pistol which had been rendered harmless by the removal of several parts. Thereafter she was followed by witnesses. It took her two days to obtain access to the scientist, but finally succeeded during his office hours and stood face to face with him and attempted to discharge the pistol.

Dr. Wagner-Jauregg believed he was a victim of vengeance and caused her to be arrested, not realizing he was dealing with a hypnotized subject.

Miss Osta was taken to the police station, where detectives discovered they were questioning a girl who was stupefied and who was unable to give her name, her address or to explain why she had attempted to kill the scientist. Even the police physicians were unable to diagnose her case. She was then committed to a psychiatric hospital for observation. There, punctually at the time set by the hypnotist she awoke from her hypnotic state and gave her name and address. Senn explained the incident to the newspapers here later.

It is held that the case deals a heavy blow at the medical experts who dealt with it.

New York, Nov. 30—Mildred Harris motion picture actress and divorced wife of Charlie Chaplin, is worried. She scarcely knows how she is going to get along on \$50,000 a year.

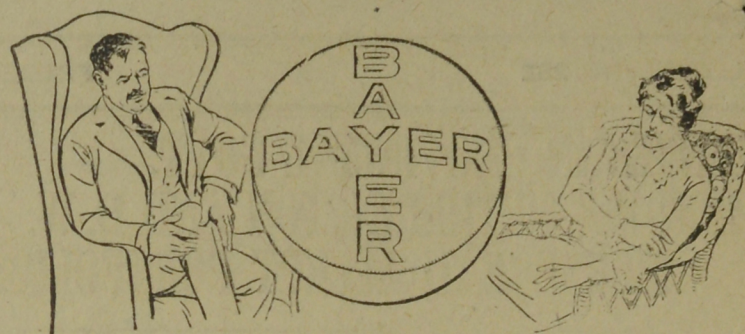

NIGHT CLUBS SUBSTITUTE FOR CABARET

London, Nov. 30—London has not yet the cabaret habit—though it has expensive and exclusive night clubs, one of which has just started a modified cabaret show. The nearest approach to the New York cabaret here and in the big provincial cities is the growing custom of having leading concert performers sing at restaurants and hotels during meal times, in addition to the usual orchestra.

The introduction of songs into the hotel musical program was first made at the Midland Hotel, Manchester, when it was opened, nearly 20 years ago. At that time nearly all singers, big and little, considered it rather infra dig to sing in an hotel, though the Midland Hotel paid a fee of \$50 and gave accommodation.

A man who engages singers for the biggest restaurant company in Britain said: "We are ever on the lookout for singers of talent for whom there is a tremendous demand. We pay salaries from \$100 upwards and the fee is regulated by the quality and reputation of the singer. To those who are at the top of their profession we pay as much as \$400 a week.

"The provincial cities will not have any artists but the best. At Liverpool the audiences are most critical, and all over the North of England the people are musical, and frequently discuss music while at dinner. The people in the North did not take to jazz, which they regarded as unmusical."
