MARKET HUNTING

One of the primary objects of those who are engaged in promoting more adequate protection of wild life is to stop the destructive activities of the market hunter. Mr. F. Bradshaw, Chief Game Guardian of Saskatchewan, in speaking before The National Conference on Wild Life Protection, held in Montreal in February by the Commission of Conservation, made a forceful appeal on behalf of the prohibition of the sale of game. Mr. Bradshaw gave the following instance of the manner in which wild life resources are depleted by those who hunt as a means of livelihood instead of recreation.

"The destruction that can be wrought by a single individual whose goal is the slaughter of game for financial gain is appalling.

"Some ten or twelve years ago a family of my acquaintance homesteaded on the south shore of Lake Johnson, Saskatchewan. This lake at that time was a sportsman's paradise, and is still considered to be a choice hunting ground for waterfowl. There were four adult males in the family, all excellent shots, and as soon as the hunting season opened they started their deadly fusillade and from daylight until dark for six days a week they hunted as long as a goose remained to be shot. They kept one man steadily hauling the game to Moosejaw, 40 miles distant. Among other things, they admitted, earning enough money in two years to purchase and pay for an automobile."

THE CARE OF MACHINES

The automobile driver who has studied his machine until he recognizes the slightest indication of trouble, gets added service from his car. He saves money and increases his pleasure by being able to diagnose every squeak, every grind, every rattle and to apply the proper remedy.

If the disorder is beyond his skill, he takes his machine to an expert and has it put in shape. The careless driver pursues the opposite course, driving his car regardless of warning signals until one day the abused mechanism is unable to travel farther.

There are wise and foolish automobile drivers and by the same token there are men prudent in caring for their bodies and others who are careless. The cautious man heeds the distress signals which his brain receives when nature has been outraged or there has been a breaking down of vital parts of the human machine. If skilled in the care of his body he takes the necessary measures; if the symptoms are beyond his comprehension he consults the physician—nature's repairman. The foolhardy man disregards warnings until, like the abused motor car, his body is incapable of going farther. Then comes inactivity or illness and worn-out humans like worn-out automobiles finally find their way to the scrap heap.

AN EXPERT OPINION

Commodore Stewart who is recognized by himself and others as a high authority on Parliamentary rules and practice, says that Mr. B. F. APPEAL IN DISMISSED IN RAILWAY CASE

Court Suggests That Matter be Referred to a Master of the Supreme Court.

Judgments handed down today by the Appeal Division, Supreme Court, were as follows:

The King vs. Wm. Edgar Dean ex parte Adelaide Dean in re Catherine E. A. Dean an infant. The written judgment of Judge Grimmer was read by Chief Justice Hazen. Appeal from the decision of Chief Justice McKeown of the King's Bench Division on Habeas Corpus proceedings, dismissed without costs.

In re estate of Martha C. McDonald deceased. Written judgment of Judge Grimmer read by Chief Justice Hazen. Appeal dismissed with costs.

LeBlanc vs. Moncton Tramways Co., Ltd. Judgment read by Chief Justice Hazen. New trial granted, costs of appeal to be paid by respondent.

Valley Railway Case. Bank of B. N. A. vs. St. John & Quebec Railway Co. et al. Judgment read by Chief Justice Hazen. Appeal dismissed with costs, and in compliance with judgment of Judge Chandler the matter should be referred to a master of the Supreme Court to take an account of the amount due by The Hibbard Co., Ltd., to the Bank of B. N. A. for loans and advances in connection with the contract between the Hibbard Co. and the St. John & Quebec Railway Co. dated May 8, 1912, and that an account should be taken of the amount due from the St. John & Quebec Railway Co. to the Hibbard Co. under the contract above mentioned.

Casey vs. Kennedy. Motion dismissed with costs.

In re McDonald estate, appeal allowed, with costs to be paid by respondent to appellant, matter remitted to Queen's County Probate Court to reopen and to proceed on nearing of petition for proof of will without requiring the petitioner to be cross-examined.

Lupée vs. Hogan. Appeal dismissed with costs.

Eagles vs. Canadian Bank of Commerce. Appeal dismissed with costs.

BANK WILL INCREASE ITS CAPITAL

Toronto, April 23—Canadian traders have paid relatively little attention of late to bank stocks but the announcement yesterday of a new issue of \$2,000,000 by the Bank of Montreal bring that bank's paid up capital up to \$22,000,000 will be heard with interest. According to the terms given out on the floor of the Toronto Exchange, the price to shareholders of record of May 20 will be 150, as compared with the present market price of about 210. The new issue being one-tenth of the existing issue, it was presumed that the offering would be in the proportion of about one to ten shares held. This would give a small sized melon for distribution, but the attitude of the Street would have to undergo a change to find an lively movement following the announcement.

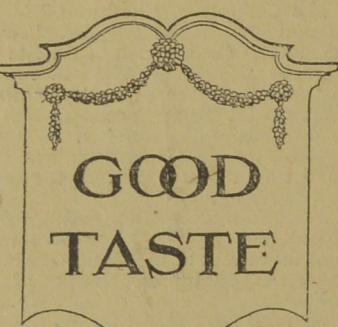
