

## PRICE OF MILK TO REMAIN AS IT HAS BEEN

### PRODUCERS NOT UNANIMOUS IN MATTER

Meeting Held at Court House  
Saturday—Farmers' Co-operative Dairy Opposed Proposal.

A meeting of the milk producers and retailers was held at the Court House on Saturday to consider the advisability of raising the retail price of milk to seventeen cents per quart. That this action was not taken was due largely to the attitude of the Farmers' Co-operative Dairy, Ltd., who maintained that present conditions did not warrant any change in price, and believed themselves able to continue at the present rate.

Since this firm put their products through a Pasteurizing process, the other dealers could not independently raise the price, although there was a feeling that milk at seventeen cents per quart was justified.

The matter was at length dropped and there is no indication of further action being taken.

### A Bereaved Showman

Fredericton friends of Mr. W. S. Harkins, the well known and popular showman, will regret to learn of the death of his only son Harry, which occurred at Binghamton, N. Y. on October 17. The deceased was about 37 years of age and leaves a wife and two children. Mr. and Mrs. Harkins lost their only daughter about eighteen months ago.

### Impressive Address

Sussex Record: His Lordship Bishop Richardson, of Fredericton, held a confirmation in Trinity Church, Sussex, on Wednesday evening, when the Rev. Mansel Shewen, presented a class of thirty-two candidates. The church was completely filled by a large and interested congregation. Bishop Richardson delivered a most eloquent and impressive address, which was listened to with the closest attention. The choir furnished special music.

### Fire This Afternoon

A fire occurred today at 1.30 in the Cartin Building, occupied by Ryan's Drug Store. The blaze seemed to have originated in the attic and part of the roof had to be torn away before a hose could be brought to bear on the blaze. The origin of the fire is entirely unaccounted for since the only fire in the building today was a small one started in the furnace early this morning, but allowed to go out during the forenoon.

### Married at St. John

An interesting event took place yesterday afternoon, October 18, at the Queen Square Methodist parsonage, 16 Pagan Place, St. John, when Frank Walter Rickard, of Barker's Point, York county, was united in marriage with Miss Myrtle Elizabeth Bearsto, of Fredericton, daughter of Mr. and Mrs. Johnston Bearsto. The ceremony was performed by Rev. Neil McLauchlan in the presence of near relatives. Mr. and Mrs. Rickard left on the evening train for Fredericton where they will reside.

### Bicycle Theft Charged

A well known young man employed in this city was arrested today on a warrant for the theft of a bicycle the informant being a resident of the city who complained to the police some time ago that his bicycle had been stolen. The accused also had a bicycle stolen some time ago. The bicycle which he is accused of stealing was lying about without a claimant and he used it according to his statement.

### Illegal Shooting

Residents of the Hanwell road complain of violations of the game law in that vicinity. They say that Sabbath shooting is indulged in by city sportsmen and that the law is also broken on week days. The legal bag of woodcock for one gun is ten birds, but it is said that on several occasions this season the limit has been exceeded. The sportsmen who hunt on the Hanwell road are men possessing a fair knowledge of arithmetic and it is therefore surprising that they should be mistaken in their count.

## INQUEST LIKELY IN MATTER OF THE DEATH OF WOODFORD CLOSE SHOT MONDAY ON THE NASHWAAK

Returned Soldier and a D. S. C. R. Apprentice—Parents and Relatives Reside in Devon—Joseph Owens, of Marysville, Fired Three Shots at What He Took for a Bear—One Pierced Arm and Body—Funeral With Military Honors.

It is probable that an inquest into the death of Woodford Close of Devon, who was shot in mistake for a bear at Kentville, near Nashwaak Village, Monday morning, by Joseph Owens, of Marysville, will be held. F. H. Peters, Clerk of the Peace, has communicated with Dr. T. C. Allen, Deputy Attorney General, who expressed the opinion that an inquest should be held. Communication with the Attorney-General, Hon. J. P. Byrne, is being sought. Dr. B. M. Mullin, of Devon, coroner, viewed the body Monday afternoon, and decided that the circumstances pointed to accidental shooting and that an inquest was not necessary. Other authorities believe, however, that the circumstances are such that an inquiry should be held. Relatives of the victim believe the same.

### Were Hunting

Woodford Close, accompanied by his brother-in-law, Glenn Libby, of this city, and R. V. Good, also of Fredericton, went to Kentville on a hunting expedition. Monday morning they started along the old Stanley Road, now little used, with fallen trees across it in places. Close said to the others that he would go ahead and started along the road. The others followed more leisurely until they heard three shots in quick succession. They then put on speed thinking Close had killed an animal. In about twenty minutes they came in sight of a rise on which they saw a small group of men. One came toward them and said a man had been shot. They went to the spot and found their companion lying shot through one arm and the body. He died some thirty-five minutes after being shot.

### Thought It was a Bear.

The shot had been fired by Joseph Owens, of Marysville, who with his uncle, Woodford McNeill, of Nashwaak Village, by whom he was employed, was cruising lumber. A friend also was with them. Owens carried a rifle and McNeill a shotgun, according to the statement of Mr. Good. As the cruising party topped a rise in the road, Owens cried out, "There's a bear," and raising his rifle, fired three times. The distance was forty paces, as measured by Good. Owens went toward the supposed bear and found that he had shot a man. His companions say that he fainted at the discovery.

### Wore Grey Shirt

Good states that Close was wearing a grey flannel shirt and from appearances when he reached the place had been sitting on a fallen tree at the roadside. His rifle leaned against the tree beside him evidently where he had placed it when he halted to rest. The view was quite clear.

The place where the tragedy occurred was remote and there was no way of taking the body to the nearest house except carrying. This was done for a considerable distance. As soon as possible word of the occurrence was sent out. The shooting occurred at 10.45. Dr. B. M. Mullin of Devon, coroner, received word at 2 p. m. and started for the place. After examination he did not think an inquest necessary.

Woodford Close was a returned soldier and recently had been taking an electrician's course with the D. S. C. R. He was engaged on the installation of motors at the Marysville cotton mill of late. He was a well known man and had a large circle of friends and acquaintances who were profoundly shocked to learn of his untimely death.

### Surviving Relatives

The deceased was aged thirty-three years. He is survived by his parents Mr. and Mrs. Alfred Close, of Devon, three sisters, Mrs. Glen Libby, of Fredericton, and the Misses May and Edna at home, and one brother, Lee of Devon.

Arrangements for the funeral have not yet been made. A military funeral will be given by the D. S. C. R.

### Hen Thieves Busy

Thieves broke into the poultry house of Mr. L. B. C. Phair on the Woodstock road a few nights ago and made off with three of his nicest hens. Mr. and Mrs. Phair had moved to their city home on the previous day so the thief was evidently familiar with their movements.

### Government Meeting

Hon. P. J. Veniot Minister of Public Works, arrived here last night preparatory to the meeting of the Provincial Government which will be begun to-night. Hon. Robert Murray, Provincial Secretary Treasurer arrived here this morning. Other members of the government will arrive tonight.

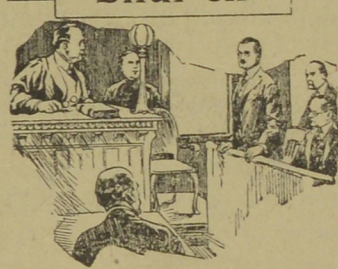

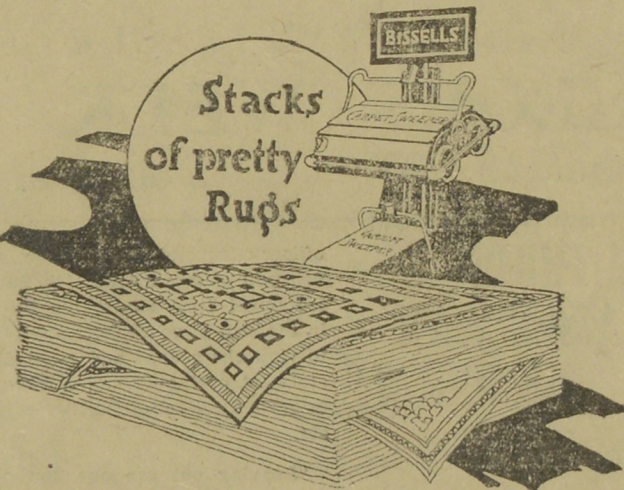

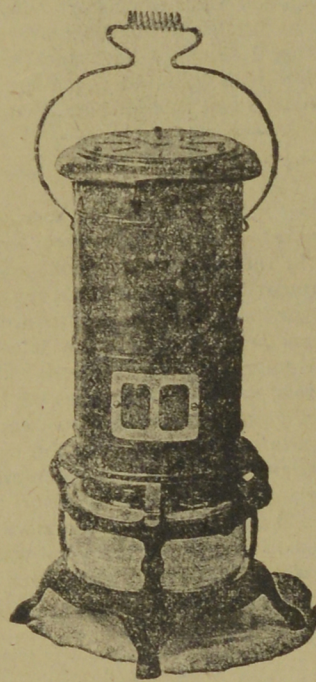
