ADENOIDS THRIVE ON A SUGAR DIET

New York, April 2—Deprecating the widespread acceptance of sugar as a harmless necessary part of the diet Dr. Frank Vander Bagert of Scheectady told the physicians in conference at the first day's session of the annual meeting of the Medical Society of the State of New York that for many years he has personally felt that sugar plays a most important part in the development of adenoids and hypertrophied tonsils.

"My case histories almost universally point to such a casual relationship," said Dr. Vander Bagert, "and I have come to believe that recurrence after operation can be prevented in almost all instances by elimination or limitation of sweets in the diet."

Dr. Bogert said that Dr. William Osler thought there was much more breathing in England than in any other country.

"Great Britain," he added is the largest consumer of sugar. Very recently Dr. Harry Campbell read before the Royal Society of London a paper in which he assumes the cause of adenoids to be a toxemia of intestinal origin, and suggests as a factor the enormous increase in the consumption of sugar of late years.

"Prior to the eighteenth century," said Dr. Bogert, "sugar was looked upon as a drug. Dr. W. R. Whitney suggests that it looks very much as though the race were being partly killed off in an attempt to produce a type of immunity against sugar, and that we could hardly expect this immunity to be first class in a couple of centuries."

"The craving for sweets, to which so much importance is attached by many writers can in most instances hardly be considered of more value than the craving for alcohol. Tissue hunger has long been distinguished from normal appetite and may depend upon an abnormal state of the digestive tract which inhibits assimilation. Children who show symptoms of inherited weakness of the thyroid gland have a very decided craving for large quantities of sweets. Craving can be relied upon as an index of bodily needs only when man reverts to his natural state."

Dr. Vandr Bogert referred to the admitted value of sugar in the diet of young infants, this being supplied by mothers' milk, and to soldiers in the field, lumbermen, mountain climbers, rowers and other men who are undergoing violent exertions in the open air when the sugar in the blood is heavily drawn upon. Quite different conditions prevail among children and adults engaged in ordinary occupations.

TEACHERS THROWN INTO THE WATER

Hays, Kan., April 2—The Fort Hays Normal School is in the grip of what professors describe as a "student Soviet," whose principal occupation is throwing professors into the lake on the college campus, according to Professor P. Caepher Harvey, who telegraphed State authorities to Topeka for protection. R. J. Hopkins, Attorney General has directed the County Attorney to prosecute all persons responsible for the disorders.

The trouble began it is said, when President W. A. Lewis of the school left a few days ago on business. On departing, he suggested a half holiday, during which the men students could build a running track. Girl students were to prepare a meal. At a "pep" meeting it is reported, a woman suggested in fun that girls who did not help should be ducked in the lake.

An announcement was posted that "all persons, including the faculty will be ducked if they fail to report at 1 p. m. John Lindquist, editor of the college newspaper, was the first victim. He was taken from the college library, and, although he cannot swim was thrown into the water over his head."

Professor Ducked

Another person to suffer was Professor James Start, a bridegroom. He was rescued from the lake by three students. Professor Harvey a third victim dived into the water before the students could act. Both Start and Lindquist are veterans of the war.

Professor Start's house was patrolled by students all day. Finally he took his bride to a hotel, and this also was picketed by students, who caught the professor when he started for the school in the morning.

The afternoon was my only afternoon for debate work, and I will not be forced to do anything by threats. I dived into the water for the sake of an ideal and as a protest against the use of force to promote school spirit."

TOM LAWSON WAS EJECTED FROM HOUSE

Boston, April 4—Thomas W. Lawson, broker and promoter, was ejected today from the hearing before the Committee on Rules at the State House on the bill to broaden the powers of the Attorney General to investigate stock sales. The ejection was due to Lawson's shouting at former Senator Beck: "You're a liar!" when Beck charged Lawson had tried to induce members of a church to subscribe for National stock.

Previously in a dry debate with Speaker Joseph Warner of the House, chairman of the Committee on Rules, the right to testify had been refused to Lawson.

This brought Lawson to his feet in an instant.

"Do I understand that any one arrested or under indictment cannot testify—that he will be shut off?" shouted Lawson.

"Yes," rejoined Speaker Warner.

"Even though the man will accept conviction in advance?" asked Lawson.

"Notwithstanding that," said the Speaker.

Lawson seemed to be furious, Baffled in every attempt to be heard, he appealed in vain to Speaker Warner

MOVIE STARS JOINED IN MATRIMONY

Los Angeles, April 1—It became known here today that Mary Pickford and Douglas Fairbanks two of the most popular moving picture stars in the world, were married here last Sunday. They obtained a license last Saturday, and the ceremony was performed the following day by the Rev. U. Whitcomb Brougher, pastor of the Temple Baptist Church. Friends of both Mr. Fairbanks and Miss Pickford said today that the couple probably would make a tour of the world while on their honeymoon, although they intend to make pictures en route.

The wedding of Mr. Fairbanks and Miss Pickford had been expected by their friends, and by film fans throughout the country and several times in recent weeks since both of them were divorced, false reports had gained circulation saying that the ceremony had been performed. Mr. Fairbanks was divorced by Mrs. Beth Sully Fairbanks a daughter of Daniel J. Sully about eight months ago. Two or three days later Mrs. Fairbanks was married to James Evans, Jr., a broker of Pittsburgh.

Miss Pickford divorced Owen Moore also a moving picture star, about six weeks ago. Neither Mr. Moore nor Mr. Fairbanks appeared to defend the suit brought against them, nor were they represented by counsel, although Mr. Fairbanks filed an answer denying his wife's allegations.

Report of trouble between the Moore and Fairbanks households had been current in film circles for more than a year, ever since Mrs. Fairbanks declared that another woman had taken her place in her husband's affections. Owen Moore threatened to bring suit against Fairbanks for \$250,000. This action never was brought, however, and later it was announced that a reconciliation had been effected between Fairbanks and his wife and between Miss Pickford and her husband.

Miss Pickford made her first stage appearance in the spoken drama under the direction of David Belasco, but never made a great success on the stage. After she had become a screen star, however, she returned to the management of Mr. Belasco and appeared in "A Good Little Devil," but after a few months Mr. Belasco released her from her contracts so that she might accept offers from film producers. It had been reported along Broadway for several weeks that Miss Pickford contemplated leaving the "movies" and returning to the theatre.

Mr. Fairbanks was a theatre star before he entered the moving picture world and his success as a screen player was almost instantaneous. His salary during the last few years, as well as that of Miss Pickford has been enormous.

Detroit, April 5—Sydney Lyons, 33 years old, was shot to death by his pretty 20-year-old wife, Evelyn, as he lay sleeping in their home at 247 Brush street, on Saturday. The weapon used was a Colt automatic, which Lyons kept under his pillow.



MEANING OF BONE DRY

Edmonton, Alta., April 4—President Stewart made clear his interpretation of "bone-dry" in the legislature Saturday when proposed amendments to the liquor act, submitted by Dr. Stanley were being discussed. "I take it," said the Premier, "that bone-dry does not mean that the doctors will be relieved of that if they will assist other citizens in voting on the plebiscite."

The plebiscite referred to is to be taken in this province some time in June to finally determine the question for Alberta of inter-provincial traffic in liquor. The Premier takes the stand that if the vote is overwhelmingly against the importation of liquor the province will go "bone-dry."
