PROTECT RESIDENTIAL AREAS

The following advertisement recently appeared in a Halifax paper:

"Notice is hereby given, that application has been made to the Building Inspector by the undersigned for permission to erect a shop on west side of Elm Street between Chebucto road and Oak street. Any person objecting to the erection of this building within the residential district should lodge a copy of said objections with the Building Inspector, City Hall."

The City Council of Regina, Sask., has before it for consideration an amendment to the fire limits bylaw which, if passed, will prohibit the opening of business places in the residential districts of the city.

This legislation is in harmony with the efforts of the Town Planning Branch of the Commission of Conservation, which for the protection of residential areas, has consistently advocated the zoning of towns and cities.

Unless a property owner has some guarantee that his investment will be safeguarded, there is little inducement to build or improve a home, even in the best residential districts, in most of our cities. In an eastern city, a permit was recently issued for the erection of a wood-working factory in the heart of a residential section. Although the residents formally protested against such construction, urging that the area was purely residential and that the insurance rates on adjoining property would be considerably enhanced, the permit was not revoked.

All building laws in cities should contain provisions to protect residential areas and for the securing of neighborhood assent to the erection and operation of business properties which were considered undesirable by those resident in the locality.

Under the amended bylaw in Regina, it is proposed to provide for such conditions by requiring the signatures of a substantial proportion of the property owners in any block, in which it is proposed to operate business premises before permission will be given by the city.

The requirement that proposals to erect such structures in a residential district be publicly advertised before a permit is issued also seems to be a desirable public safeguard.

Hon. Mr. Meighen in a speech in the constituency of West Hastings, Ont., on Wednesday roundly denounced the agrarian movement. The very day on which he spoke the farmers of Colchester, N. S. met in convention and nominated Capt. H. A. Dickson of Onslow as their candidate in opposition to Hon. F. B. McCurdy, who is seeking reelection in that constituency. Premier Meighen is announced to speak at Truro, on August 24th and will thus have an opportunity to repeat his attack on the farmers. If the Liberals, farmers and labor men rally to the support of Capt. Dickson the Minister of Public Works will be defeated.

Sydney Record: As was expected, determined effort is being made by Government agents to head off opposition in Colchester County to Hon. F. B. McCurdy the new Minister of Public Works. A great deal of stress is being laid upon the alleged honor it would be to Colchester to have a Cabinet Minister as its representative and still more stress upon how much Mr. McCurdy would do for the county were he elected. It will be interesting to see whether or not Colchester County can be 'bought' by that sort of thing. It will not be to the great credit of the county or the credit of the Province, if the answer should be in the affirmative.

A newspaper supporting the Meighen Government declares that the premier will "deal boldly with every issue, no matter whether his Government stands or falls thereby." As the Toronto Globe asks, "then why not let Hon. Arthur commence by dealing boldly with the issues raised by Mr. James Murdoch in resigning from the Board of Commerce because certain Cabinet Ministers repeatedly undertook to thwart the Board's desired activities by quiet and hidden opposition?"

The former Crown Prince of Germany has expressed a wish to go back to Berlin to look after some real estate business. And that reminds the Toronto Globe that it was the itch for more real estate that brought the German Empire to grief.

HON. MR. KING
REPLIES TO
THE PREMIER

Paisley, Ont., Aug. 12—Hon. W. L. Mackenzie King, chief speaker at a mass meeting of Bruce county Liberals in Paisley's beautiful Riverside park this afternoon, devoted considerable time to replying to Premier Meighens address at Stirling yesterday. He scored the premier's attitude toward the country at large as autocratic and lofty, picturing him as walking down the middle of a highway ignoring those on either side.

"I am reminded," he said, "of the Pharisee who kept to the middle of the road without allowing his garments to be touched by suffering humanity. There was another figure in that parable, and if Mr. Meighen wishes to play the role of the Pharisee I am content that the party I lead shall take the part of the Good Samaritan and do what it can to blind the wounds and better the conditions of humanity."

Besides the Liberal leader in the federal house, the list of speakers included Hartley Dewart, K.C., M.P.P.; F. F. Pardee, M.P., West Lambton, and T. H. Marshall, M.P.P. for Lincoln. The chair was occupied by A. P. McWhinney, M.P.P. for South Bruce. It was a hot day, but the 1,500 people who attended heard the speeches from very comfortable seats arranged under the shade of huge spreading elms. The town gave a warm welcome to the visitors.

The rally was arranged by the North and South Bruce Reform Associations and was more or less in the interests of R. E. Truax, M. P. for South Bruce, victor for his party in eleven previous contests, but now about to be matched for the first time against a U. F. O. candidate.

It is believed Marshal Foch will send General Petain to represent him.

HEAVY FINE
ON POOL ROOM
PROPRIETOR

Vincenzo Giacinto Convicted of Violating Prohibition Act—Minto Man Gave Him Away.

Vincenzo Giacinto, a naturalized Italian, and the proprietor of a pool and billiard parlor in Queen Street, this morning appeared in the Police Court before Acting Police Magistrate E. C. Allison McKay to answer the charge of selling liquor, contrary to the Intoxicating Liquor Act of 1916. Magistrate McKay imposed a fine of \$200 and costs falling in the payment of which the defendant will go to jail for six months.

The information in this case was laid by Sub-Inspector Fraser Saunders who has been keeping his eye on the premises of the accused for some little time. A few days ago Giacinto was seen getting into a Minto man's car, and the Inspector, on going to Minto and searching this man's house found a bottle of gin. The Minto man then came across with the information as to where the booze had been obtained and this led to Giacinto's arrest.

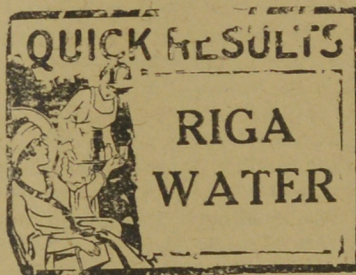
