## ITALIAN CUPON KING IS HAVING HIS TROUBLES

The U. S. Government is Auditing the Books of the Fifty Per Cent Financial Wizard—He Still Signs Checks Which are Honored by the Banks—Has Them All Guessing—Nothing Irregular Yet Disclosed.

New troubles are piling up for Charles Ponzi, the biggest sensation ever known in financial circles. The United States Government has begun an audit of the books of the 50 per cent interest king, a million dollar suit was filed against him and a former agent of the Department of Justice has filed an attachment against a group of the money wizard's alleged agents.

But the dapper little man who has them all guessing smiles through it, nonchalantly signing millions of dollars' worth of checks, all of which are promptly paid by his bankers, and declaring "I should worry."

Announcement that Edwin L. Pride & Co., Inc., certified public accountants had been named by the Government to do the work of auditing Ponzi's accounts were made today by United States District Attorney Gallagher.

Without warning District Attorney Joseph Pelletier announced he had dropped his investigation into the affairs of the money king and would have nothing further to do with the case unless called upon by Mr. Gallagher or Attorney-General Allen for assistance. District Attorney Pelletier's statement reads:

**District Attorney Drops Out**  
"The Attorney General has notified me that he will take over the investigation of the Ponzi matter. Too many cooks spoil the broth, and there shall be no rivalry between the Attorney-General and me.

"His desire to take over the Ponzi

investigation will be honored by me, and I will leave to him further investigations in the matter.

"My only thought was to protect the people from any possible loss even though there did not appear any evidence of a criminal offence, and Mr. Ponzi really accepted my proposition that he suspend taking money for investment until an audit should be made.

"If the Attorney-General needs my assistance it is at his command at any time. My sole desire is to get results and protect the people."

Service of a writ calling for the attachment of \$5,000,000 worth of real estate belonging to Clarence W. Barron, publisher of the Boston News Bureau, to be made tomorrow morning on behalf of Ponzi, preliminary to the filing of a declaration setting up alleged libel; a statement from Postmaster Roland Baker here that the Boston post office redeemed only \$30 worth of international postal reply coupons in the last three months for Ponzi's exchange company and the continued cashing of notes for the fourth consecutive day by the money king are high lights of the situation today.

In commenting on the case Mr. Gallagher said:

**Ponzi Shows Confidence**

"Statistics of the Post Office Department at Washington shed some light on the volume of business done in international reply coupons since 1908 when the United States Government first took up the business. Up to and including the year ended June 30, 1918 \$54,436.69 worth of coupons were redeemed by this Government. In the year 1908, which is looked upon as the banner year, there were \$13,735.60 worth redeemed by this Government. The business then fell off until 1918, when there were only \$1,903.90 worth redeemed.

"It is expected that the figures for 1919 will show an increase over 1918. The figures for the year 1920 are not yet available. The United States has made requisition for international reply coupons since 1907 to the number of 2,500,000 of which 1,600,000 have been distributed to the various offices on requisition and 900,000 are on hand. The totals in money can be readily obtained by figuring the redeemable value of each coupon 5 cents.

Commenting upon the presence of Mr. Pride, Ponzi stated that in his opinion the audit would take about a week, not longer.

"I want my position clearly understood" said Ponzi. "I do not challenge or defy the State Government officials I have volunteered to assist in any examination of my books, and will render any co-operation possible in assisting in obtaining speedy results."

"Does that mean, Mr. Ponzi, that you are ready to divulge your methods of doing business?" he was asked.

"It means that what I propose to show is that my assets are in excess of my outstanding liabilities," he replied.
