### NEW CONSTRUCTION COMPANY AT ST. JOHN

Capital of \$199,000—A New Lumber and Milling Company in Kings—Capital Increased.

Thomas Stephen, Lewis Stephen and James H. Duddy all of St. John are incorporated as The Stephen Construction Company Limited with head office at St. John and capital stock of \$199,000. The company is to carry on a general contracting and construction business.

Bloomfield Lumber Co. Ltd.

Limited, with head office at Bloomfield, Kings County, and capital stock of five thousand dollars. The company is to acquire and take over the rights and property of Daniel J. Boyce and Fred L. Roderick and to carry on a general lumbering and sawmilling business.

Country Market  
The country market was comparatively small today most of the farmers taking advantage of the fine hay-in weather. Prices were on the whole about the same as on Saturday but a rise occurred in the price of eggs. New potatoes were offered at \$6.00 per bushel. Prices were as follows: Beef, 12 to 15 cents per lb. Lamb, 20 to 30 cents per lb. Mutton, 12 to 20 cents per lb. Butter, 55 to 60 cents per lb. Eggs, 60 to 70 cents per doz. Potatoes, \$8.00 to \$10.00 per bbl. New Potatoes, \$6.00 per bushel. Vegetables 10 cents per bunch. Strawberries, 25 cents per box. Young pigs, \$3.50 to \$4.00 each.

## EXTRACTS CAN BE SOLD ONLY BY SMALL BOTTLE

### RULES AND REGULATIONS ARE GAZETTED TODAY

Limit of Two and a Half Ounces per Day per Person—Record of Sales Must be Kept.

In pursuance of the announcement made by Premier Foster to a delegation of wholesale grocers that the Provincial Government would make regulations governing the sale of extracts, essences and tinctures, the Royal Gazette today contains notice of the rules and regulations.

These are made under The Intoxicating Liquor Act 1916 and reduce the quantity of extract which may be retailed in any one container to two and one half ounces and provides severe penalties for infraction of any of the rules and regulations. This action is taken on account of the use of extracts for beverage purposes and the recent prosecution of wholesalers at St. John under the Prohibition Act for having extracts for sale.

It is provided that every manufacturer, wholesale merchant or broker before he shall manufacture, compound, purchase, receive, keep for sale or sell any tincture, essence or extract of ginger, lemon, vanilla or any other flavoring extract containing alcohol, must first notify the Chief Inspector by registered letter at Fredericton of his intention.

No extracts, essences or tinctures shall be sold except in containers or bottles containing not more than two and one half ounces and all persons selling such must keep a record showing the names and addresses of all persons buying, the dates of sales and the quantities of all sales. A true copy of such record must be furnished any Inspector upon demand and the book must be open to inspection by any Inspector.

The regulations however, will not prevent the sale of such extracts in a bottle or container containing more than two and a half ounces, to a druggist or manufacturer of confectionery or similar commodity or to a person in any trade or business in which any such article is commonly used for legitimate purposes, or to any public institution or to dealers for resale to any of the persons mentioned in the proviso. Record books for such sales must be kept and every person so selling shall have reasonable ground to believe that such sale is for legitimate purposes.

Preparation containing less than two per cent of proof spirits do not come under the provisions of the rules and regulations.

One Sale Per Person Per Day  
No peddler or transient trader is permitted to sell or dispose of any tincture, essence or extract mentioned, no sale for beverage purposes is authorized, no retailer shall sell to any one person in one day more than two and one half ounces except as provided.

## STANDARDIZED NURSES' COURSES ARE DESIRED

### COMMITTEE ON THE SUBJECT NAMED

Discussion, Two-Year Course vs. Three-Year Course—Election of Executive This Afternoon.

The New Brunswick Association of Graduate Nurses continued its annual meeting in the Fraser Memorial Hall this morning and transacted much business of importance to the members of the association.

The voting for members of the executive took place but the report of the scrutineers will not be received until the afternoon session.

Miss Elizabeth Robinson Scovill of Gagetown read a paper in connection with the discussion of the question of accepting graduates of hospitals giving two-year courses of training. Miss Scovill favored a two-year course. A third year could be used for post-graduate study or specialization.

Miss Branscombe of St. Stephen spoke to the same subject expressing the opinion that two years was too short a period for adequate training and favoring a three-year course.

Miss Retalick who was expected to deliver a paper on the subject was not present.

Miss Allie Burns of St. John who had been a delegate to the meeting of the Canadian National Association of Trained Nurses at the twin cities of Port Arthur and Port William presented her report on the convention.

Miss E. J. Mitchell of St. John, treasurer presented her report. A credit balance of \$449 is on hand.

There was discussion on the length of time nurses may be in arrears and still be in good standing in the Association. It was decided to permit arrears for two years.

On motion it was decided to appoint a committee on Hospital Standardization including the various hospital superintendents in the Province and Miss E. R. Scovill. All superintendents of training hospitals in the Province are to be requested to forward their curricula with a view to having all courses standardized.

### Given Suspended Sentence.

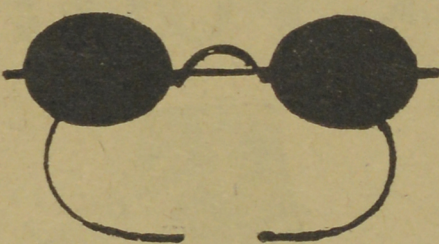
