His Majesty Passed Quiet Night but Slept Very Little

The Infective Process is Being Held in Check Says Official Bulletin—Anxiety of the Empire Alayed Somewhat by the Assurance of Attending Physicians—Plans of the Prince of Wales are Uncertain.

LONDON, Nov. 29—An official bulletin issued at Buckingham Palace, said: "The King passed a quiet, although rather sleepless night. The infective process is being held in check."

London, Nov. 29—Conflicting views concerning the illness of the King of England were in circulation today but the reassurance of royal physicians that his majesty's condition was unchanged served to allay somewhat the anxiety of the empire.

Dar-Es-Salaam, British East Africa, Nov. 29—The Prince of Wales anxiously awaited news from London today before planning the next step in his dash to the bedside of his father, the King of England, who lies ill in Buckingham Palace.

Prince's Plans Uncertain

Narobe, Africa, Nov. 29—The Prince of Wales plans still are uncertain. It was believed he would remain in Dar-Es-Salaam for a few days; then if the King's condition showed great improvement, continue his African trip, going southward to Beira, Portuguese East Africa by steamer.

(This is the first intimation that the Prince of Wales might not continue his journey to England. It was not confirmed from any other source.)

ENGAGED TO ONLY SON OF PRESIDENT

MAN WHO SOLD BRIDGE MAY GET LIFE TERM

New York, Nov. 29—A man who a decade ago was one of the first to realize the money to be made in "selling" the Brooklyn Bridge today, at 68, faces spending the rest of his life in jail.

George B. Parker was looked upon by the police as one of the most successful confidence men of his day. His turnover on the bridge was reputed to be big and often.

But yesterday it was a far different man who faced the judge in Kings County Court. A pudgy, gray-haired man with tear-dimmed eyes heard an assistant district attorney declare him a "menace to society" and urge that he be sent to jail for life. He had been arrested for passing a bogus check and as it was his fifth offence a life sentence under the Baumes law is compulsory. He was remanded for sentence Dec. 3.

HAS REACHED CUBA.

GOT PREMIERS MIXED UP AND APOLOGIZES

London, Nov. 28—The Empire Review has expressed to the Canadian Press its regret that it wrongfully attributed an article appearing in the current issue to Right Hon. W. L. Mackenzie King, Canadian Prime Minister. The article dealt with impressions of Europe and contained the intimation that the Ottawa government might sympathetically receive complaints of the complexity of regulations governing admission of immigrants to Canada.

The article was sent from Toronto "on behalf of the Prime Minister of Ontario," the Review says, "and the editorial department of the Review wrongly assumed this description referred to Mr. King."

Extracts of the article similar to those cabled to Canada by the Canadian Press appeared in certain newspapers in Great Britain and these are being asked tonight to make the necessary corrections.

SCUTTLED HIS MOTOR BOAT TO SAVE IT

St. Stephen, Nov. 28—A new way of saving a boat from burning was discovered today. Victor Murchie of Calais was putting his boat upon the beach at high tide preparing to tie it up for the winter when the engine backfired and the boat caught fire. Not being able to extinguish the flames, Mr. Murchie who had a gun with him, shot holes in the hull sank it and thereby saved the boat. It was a motorboat 30 feet long which was used for a pleasure boat. When the tide went out the boat was beached. The damage will be small.

SALMON CLUB HEARING IS POSTPONED

Will be Resumed at Either Fredericton or Saint John — A. E. Hanson on the Witness Stand.

Campbellton, Nov. 28—According to evidence submitted in the court here during this morning's session in the case of the Restigouche Salmon Club vs The Minister of Lands and Mines for New Brunswick it would appear that certain islands in the Restigouche River, which are at present in dispute as to ownership, at one time were points of land or beaches jutting out on the Quebec shore of the Restigouche River, and if such is the fact the plaintiff club considerably strengthened its case in its fight to retain certain parcels of land and salmon fishing privileges pertaining thereto is the opinion of those who have followed the proceedings so far.

Evidence was concluded for the plaintiff this afternoon and at 4.45 o'clock, following consultation of counsel it was agreed that further hearing would be held either in Fredericton or Saint John on a date to be decided upon.

Hearing was resumed in the town hall at 10.30 this morning when certified copies on numerous deeds and titles were offered by H. A. Carr, counsel for the Restigouche Salmon Club, with P. J. Hughes, K. C., and accepted as evidence. Mr. Hughes informed the court these documents were a complete chain dating back to the original grants respecting New Brunswick lots owned by the Restigouche Salmon Club.

A. E. Hanson

A. E. Hanson, deputy Crown surveyor, was the first witness called to the stand. He gave considerable testimony regarding certain plans and maps drawn up by him relative to the disputed property. Cross-examined by the Attorney-General, witness said he had taken the New Brunswick shore and that of Quebec as his points from which to gauge the centre of the stream where the boundary line ran, according to his opinion. Further questioned he said he understood the islands in question to belong to New Brunswick.

The map in evidence showed the boundary line between the Quebec shore and the shore of the islands examined by Mr. Hanson, the witness said if the boundary line were an exactly straight line the centre of the river, then three of the disputed islands, Adams' Island, Jeloff's Island and Taylor's Island would belong to the province of Quebec.

The Attorney-General, Premier Baxter, upon conclusion of re-examination by Mr. Hughes, requested Mr. Hanson be stood aside as he (Attorney General) might wish to further cross-examine later.

A number of other witnesses were examined after which an adjournment was made.

Premier Baxter, Hon. Mr. Richards and R. St. John Freeze left this evening for Bathurst.

Skating on Nashwaak

During the past few nights a number of local young people have taken advantage of the opportunity to don the blades for a skate on the Nashwaak, where it is considered fairly good despite the soft weather. Last night there was a large crowd on the ice in that section and the skating was "top notch" to use the terms of one of the more enthusiastic ice fans.

AN EPIDEMIC OF INFLUENZA IN CALIFORNIA

Has Taken a Toll of 56 Lives So Far This Month.

TEN DEATHS YESTERDAY

Canadian Steamship Sends Out an S.O.S. Call on West Coast.

Los Angeles, Calif., Nov. 29—An epidemic of influenza which has been sweeping Southern California has taken fifty-six lives so far this month with ten deaths reported yesterday, health authorities announced today.

Sends Out S. O. S. Call.

Portland, Ore., Nov. 29—The Canadian steamship Chief Maquilla, bound for the Orient from British Columbia ports, sent out an S. O. S. call at 4.32 a. m. today, the MacKay Radio station here reported.

No reason for the distress call was given. The position of the vessel given at the time of the S. O. S. call was latitude 50.25 north, and longitude 175.15 west.

COLUMBIAN AIRMEN ON A LONG FLIGHT

Havana, Nov. 29—Lieut. Benjamin Mendos of Columbian army air service left Cabanas, Cuba, at 7.35 a. m. for Puerto Barrios Gastemala, en route to Bogota on a 4,600 mile flight from New York. Mendez left New York last Saturday. From Puerto Barrios he will fly to Colon and from there to Bogota.

YOUTH LOSES HAND IN A WOOD CUTTER

Hopewell Hill, Nov. 28—Aubrey Smith, 16 year old son of Mr. and Mrs. Trueman Smith, of Curryville Albert county, met with a bad accident Tuesday while working with a wood cutter, which resulted in the loss of his left hand.

The young man was engaged in throwing away the wood from the cutter which was being operated at the home of J. Watson Dixon, of Mountville. His hand accidentally struck the saw. Dr. Lewis of Hillsboro was immediately called and the boy was rushed to the Moncton Hospital.

A HUGE CROWD AT ST. LOUIS DEDICATION

St. Louis, Nov. 29—The second of Aimee McPherson's four-square prayer watchtowers was dedicated here last night by the Los Angeles evangelist at 2500 persons filled the new church and overflowed into the street.

The new basement, galleries and vestibule were jammed, some even propped ladders against the windows to see the evangelist.

ANYTHING TO OBLIGE.

Paris, Nov. 28—A workman who bought a sheet of government stamped paper, as required for certain communications, learned that he did not need it and asked the stamped paper office for a refund. He was told to make out his application for the money on a stamped sheet costing exactly the price of the original paper.

Plight of Unemployed Miners in the Old Country is Serious

All Political Parties are Viewing the Matter With Very Grave Concern—The Miners Federation Issues an Appeal for Assistance — Many Thousands are Out of Employment.

LONDON, Nov. 29—The plight of unemployed miners in Britain has reached such a serious stage that all political parties are viewing the matter with the utmost concern and the Miners Federation has issued an appeal for assistance.

Nearly 300,000 mine workers are out of employment, and of these 200,000 to 250,000 constitute a permanent unemployed surplus.

With their wives and children, this means that over a million souls are faced with starvation unless help is speedily forthcoming.

Ambassador to Moscow

Berlin, Nov. 29—Appointment of Dr. Von Dirksen as German ambassador to Moscow was announced officially today. Russia already has agreed to the appointment.

A REAL BEAR STORY FROM NOVA SCOTIA

Springfield, N. S., Nov. 26—James Conrad and his son, Robbie, met a bear while hunting near Mid Lake recently. Robbie, seeing the animal first, called to his father, whereupon bruin turned and made a bee-line for them. Robbie shot the brute with his .22 calibre rifle and knocked him down, but immediately thereafter the animal sprang up and charged the lad with wide-open mouth. At this juncture Conrad saw the bear and fired, but failed to inflict a mortal wound.

This aggravated the wounded bear still more, and on he came, fiercer than ever. Conrad tried to throw another cartridge into the breach of his repeating rifle, but the magazine became detached and would not operate. By this time the bear was within ten or twelve feet of the hunters, whereupon Conrad fired point-blank with his revolver, breaking the bear's jaw. Bruin turned away, giving Conrad an opportunity to reload his rifle and fire, thus putting the wounded bear out of action forever.

A LIQUOR LAW VIOLATOR GOES UP FOR LIFE

Flint, Mich., Nov. 29—Channie Tripp, 37, of Flint, today was sentenced to life imprisonment following conviction of a fourth violation of the prohibition law. The sentence was pronounced by Circuit Court Judge Fred W. Brennan, under the new state criminal code which makes a life sentence mandatory for fourth felony conviction.

Fred Palm, of Lansing was sentenced to a life term on conviction of possessing a pint of gin several months ago following three felony convictions.

Foxes For England.

Sackville Post: Mr. Richard Whitman, son of Rev. N. A. and Mrs. Whitman, Middle Sackville, arrived from England on Sunday and expects to remain here a couple of weeks. Upon his return to the Old Land Mr. Whitman expects to take back a shipment of fifty pairs of foxes.

PORTRAIT OF DR. W. F. ROBERTS IS UNVEILED

The Empire's First Minister of Health is Honored by the Women's Institute.

Saint John, Nov. 29—"The tribute of the Saint John Women's Institute to Hon. W. F. Roberts, M. D., first Minister of Health in the British Empire and founder of this Health Centre," is inscribed on the brass plate affixed to the handsomely framed life size portrait of Dr. Roberts which yesterday was formally presented to the Health Centre on behalf of the Institute by Mrs. T. N. Vincent, the president, and received on behalf of the Health Centre by Dr. G. A. B. Addy, president of that institution. Several speakers eulogized Dr. Roberts and paid glowing tribute to his splendid pioneer service for the province in the Ministry of Health. He was deeply touched and replied feelingly, giving a brief review of some of the "high spots" of the advance of public health in New Brunswick under his administration. He spoke afterwards of his gratification that the work is going on so successfully under the leadership of Hon. Dr. H. I. Taylor.

Many gathered to witness the presentation of the portrait which took place in the board rooms of the Health Centre, where a prominent place has been given the fine portrait which is exactly similar to that which is hung in the parliament buildings in Fredericton. It is the work of E. Mersereau, formerly of Saint John, now with the firm of Sarony, New York photographers. After the presentation a delightful social hour was spent in the reception room and every one present extended personal congratulations to Dr. Roberts. Delicious refreshments were served.

A Fredericton Case
