FINANCE COMMITTEE WILL CONFER WITH LAND OWNERS FOR CARLETON ST. EXTENSION

Program at the Monthly Meeting of the City Council Was Not an Extensive One—A Full Board in Attendance—The Budget Was in Excess of \$28,000.

The City Council last night met in committee, passed the accounts, discussed matters pertaining to the proposed extension of Carleton Street, and afterwards adjourned to the Council Chamber for a formal meeting. In regard to the Carleton Street Extension it was decided to have the finance committee have further negotiations with the land owners and report at the next regular meeting.

Those present at the meeting were His Worship Mayor Clark, Aids. Hay, Goodspeed, Mitchell, Thompson, Ross, Bull, Jewett, Currier, and Smith.

City Clerk Haviland read the minutes of the last meeting which were approved.

Ald. Smith for the Municipal Home Committee reported expenses of \$311.76 and asked for a check for \$600 to meet current expenses. Adopted and check ordered to be issued.

Ald. Thompson for the finance committee reported tax collections of \$7,424.95 for August 1928, as against \$5,735.64 for the corresponding month of last year.

On motion of Ald. Mitchell a check for \$250 was ordered to issue in favor of the Fredericton Brass Band on account of concerts given this season.

More Light Needed

Ald. Ross said that Saunders Street in the West End was poorly lighted at present, and it was the desire of the exhibition directors that

four additional lights be installed there for the exhibition week. He made a motion to that effect which was adopted.

Ald. Ross said that Mr. Robert Bayley had declined appointment as auditor of the School Trustees Accounts and he moved that Mr. William Todd be named. A motion to that effect was adopted.

On motion of Ald. Hay a check for \$500 was ordered to issue in favor of the Children's Aid Society.

Parliamentary Commission

The Mayor stated that he had been notified that the British Empire Parliamentary Association was to meet in Fredericton on September 26th. In connection with the visit the provincial government had requested the cooperation of the civic authorities in providing entertainment for the visitors.

On motion of Ald. Ross the Mayor was appointed a committee to act in the matter.

The Mayor stated that he understood that the party would take luncheon at the Experimental Station at noon and that the government would provide a dinner in the evening. The party would number about fifty and be composed of men.

Ald. Ross moved, seconded by Ald. Bull that further negotiations for the acquiring of land for the extension of Carleton Street be referred to the Finance Committee and that a report be submitted at the next meeting.

On motion of Ald. Quinn the City Hall Committee was instructed to have a brick ashbin erected in the basement of the City Hall.

Ald. Quinn also moved that that portion of the corridor of the City Hall leading to the Council Chamber be repainted. It was carried.

On motion of Ald. Mitchell the council adjourned.

RECEIPTS FROM MOTOR VEHICLE LICENSES HIGH

Receipts for this year were \$650,000. Thus the estimates have already been exceeded by \$61,724.95 and two months of the fiscal year remain in which the 1928 total will be further swelled.

Gasoline tax receipts for the current year are also greater than those for the previous year. The total receipts at the Department of Public Works up to August 31, 1928, from gasoline tax in New Brunswick amounted to \$173,604.79, as compared with \$147,473.03 for the same period of last year.

The receipts for August were \$43,682.23, or approximately 50 per cent. greater than for the same month in 1927, when the amount was \$29,116.59, this being one of the means by which direct evidence of the increase in tourist motor travel in New Brunswick is brought to public attention.

New Brunswick is one of the few provinces in Canada which have not increased the gasoline tax this year to five cents per gallon. New Brunswick's gasoline tax remaining at three cents per gallon for the present calendar year.

Commissioner Salt gave out that two others were suspected but had not yet been found. The authorities think they may have crossed the border near Edmundston.

Auble, who have been active against rum-runners were badly damaged by the blasts of dynamite which occurred within a short time of each other. Provisionally no one was injured, although both homes as well as nearby houses were severely damaged.

Kennedy O'Neill of Auburn, Me., was detained by the police for investigation into the outrage. It was stated that O'Neill had been sighted near the wrecked homes previous to the dynamiting and a "blackjack" was found in one of his pockets.

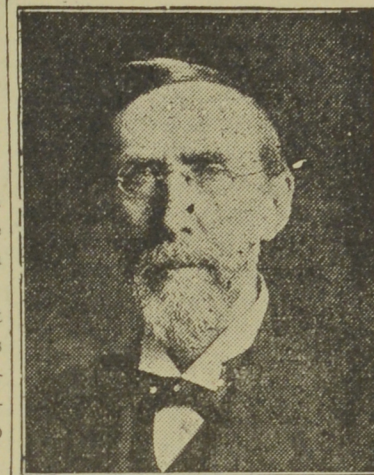

SIR G. E. FOSTER OBSERVES HIS 81ST BIRTHDAY

Ottawa, Sept. 4—Right Hon. Sir George E. Foster, one of the best known figures in the public life of Canada, yesterday celebrated his eighty-first birthday at his home here.

Even though he has reached the time of life when most men would be glad to abandon all thought of public activity, Sir George continues to interest himself in Dominion and world affairs. Besides his activity in Par-

liament—he sits on the Conservative side in the Senate—Sir George is president of the League of Nations Society in Canada and one of its active officers.

The political career of Sir George is well known. He has occupied various offices in the Government, including the ministries of Finance, Marine and Fisheries, and Trade and Commerce. He has been leader of the House of Commons and was one of the most prominent figures in the Governments of Sir Robert Borden and Right Hon. Arthur Meighen. As a speaker he is recognized to be in the front rank. He has represented Canada abroad at many important conferences and meetings.
