CANADIAN BANK OF COMMERCE WILL ABSORB STANDARD BANK ON A SHARE FOR SHARE BASIS

Toronto, July 13—Announcement that the Minister of Finance had consented to an agreement whereby the Canadian Bank of Commerce will purchase the assets and undertakings of the Standard Bank of Canada on a share for share basis, was made tonight in a joint statement issued by Arthur F. White, president of the Standard Bank, and S. S. Logan general manager of the Bank of Commerce.

On the completion of the amalgamation, which is subject to the authorization of the shareholders and the approval of the federal cabinet, the assets of the Canadian Bank of Commerce, which now total approximately \$600,000,000 will be increased by more than \$100,000,000.

The authorized capital of the Bank of Commerce is now \$25,000, of which more than 20,000,000 is paid up, officials of the bank told the Canadian Press tonight. The Standard Bank's authorized capital is \$5,000,000, of which \$4,825,000 is paid up.

Both banks last year paid a dividend of 12 per cent on their stocks, the Bank of Commerce paying a bonus of one per cent in addition. Bank of Commerce shares have a market value of \$298, and the Standard \$277. The par value of both stocks is \$100.

More Facilities

The enlarged institution will provide customers of the Standard Bank about 75 per cent of whose 220 branches are in Ontario, with "the additional facilities afforded by a chain of branches, from coast to coast in Canada, with direct representation in New York and London, including world wide banking connections, and the business will be administered as far as possible by the present officials of the Standard Bank."

There will be 811 branches under the amalgamation, with only 42 duplications, and the staff of the Standard Bank, who will be taken over by the Canadian Bank of Commerce will make a total staff of nearly 6,000 in the combined banks.

Statement Issued

The statement issued by Messrs. White and Logan follows: "An agreement is being entered into with the consent of the Minister of Finance, but subject to the authorization of the shareholders, and the approval of the Governor-General-in-council, whereby the Canadian Bank of Commerce will purchase the assets and undertakings of the Standard Bank of Canada on the basis of one share of Canadian Bank of Commerce stock for one share of Standard Bank stock.

"The Standard Bank of Canada has over \$100,000,000 in assets, is very strongly represented in Ontario, having more than 170 branches in the province, but is not strongly represented in Western Canada, Quebec and the Maritime Provinces. The Canadian Bank of Commerce, on the other hand, with approximately \$600,000,000 in assets have over 500 branches throughout the Dominion from the Atlantic to the Pacific with additional offices in London, New York, Seattle, Portland, Ore., Newfoundland and St. Pierre. The amalgamation will give the Canadian Bank of Commerce many new business connections throughout Canada, a greatly strengthened position in the Province of Ontario, and with the acquisition of the Standard Bank branches will have in all over 800 branches. The enlarged institution will provide the present customers of the Standard Bank with the additional facilities, afforded by a chain of branches from coast to coast in Canada, with direct representation in New York and London, including world-wide banking connections and their business will continue to be administered, as far as possible, by the present officials of the Standard Bank.

Western Business

"The Standard Bank officials have felt for some time that they should earlier have opened up more extensively in Western Canada. To do so now with the present competition would be very expensive and slow of development, and joining in with the Canadian Bank of Commerce they consider they will be in an excellent position to give to their customers the ser-

vice they have long desired to furnish.

"When the consolidation is completed the Canadian Bank of Commerce capital will be \$24,823,400, the reserve fund \$24,823,400 and the total assets approximately \$700,000,000,000.

"Arthur F. White, now president of the Standard Bank, will become a vice-president of the Canadian Bank of Commerce. S. H. Logan will become a director of the bank and will continue as general manager of the enlarged institution, N. L. McLeod, now general manager of the Standard Bank, will become assistant general manager of the Canadian Bank of Commerce. The entire staff of the Standard Bank of Canada will be taken over by the Canadian Bank of Commerce, and, will have a much greater opportunity for their activities. The staff of the combined banks will total nearly 6,000.

"The consolidation will be completed as soon as the respective shareholders authorize the transaction and other legal formalities are complied with, which would be in about three or four months.

"Several directors of the Standard Bank will be elected to the board of the Canadian Bank of Commerce."

If the tender be not accepted the cheque will be returned. Bonds of the Dominion of Canada or bonds of the Canadian National Railway Company will also be accepted as security, or bonds and a cheque if required to make up an odd amount.
