

ORGANIZATION PLANS FOR VIMY PILGRIMAGE

To Be Greatest Organized Effort Since the World War

No Activity Here

Members of Canadian Legion from This City Will Make Trip

While there has not been any special organization here in connection with it, nevertheless it is expected that within the coming months the local branch of the Canadian Legion, B.E.S.L. will organize plans for the War Veterans' Vimy Pilgrimage in the summer of 1936.

In other centres of the province the work is going ahead rapidly and organization has been almost completed. The sailing dates of the Pilgrimage have now been definitely set for July 15 and 16 in 1936. The place of embarkation is the port of Montreal, and the duration of the tour will be approximately three and one half weeks. The date of the unveiling of the Vimy Memorial will be July 26. It is understood that sufficient applications are made from the Maritime Provinces a minimum of 500, the ships bearing the Pilgrims will call at a Maritime port, going and returning.

Officials of the Canadian Legion here state that while a large number have announced their intention of making the trip there has been no definite organization work yet.

The Vimy Pilgrimage is called "the greatest organized effort on the part of Canadian ex-service men since the close of the Great War in 1918." The pilgrimage is expressly a solemn pilgrimage to the land where Canadians fought and suffered and where the Pilgrims wish to honor those fellow Canadians and brother Britons who made the supreme sacrifice.

The all-expense cost of the tour will be \$160. This includes all expenses for three days in France, all expenses for transportation by the same ships to London, hotel, bed and breakfast for the four days in London, and finally all expenses for ocean transportation back to Canadian ports.

The local branch of the Legion will show greater activity later in the summer when definite organization will be made.

TRUE BILL IS FOUND AGAINST TONY DANIELS

To Be Tried for Murder of George Madore, Coal Miner

Rocco Also Indicted

Court of King's Bench, Queens County, Opened This Morning

A true bill, charging Tony Daniels, of Black Diamond Settlement, with the murder of George Madore on September 8 of last year, was found today by a grand jury of the Court of King's Bench for Queens county, which opened at Gagetown this morning. His Lordship Justice A. T. LeBlanc is the presiding judge. The Daily Mail was informed by Sheriff Colwell of Gagetown of this morning's court proceedings.

The grand jury adjourned for lunch after finding the true bill against Daniels. The jury went out again early this afternoon and will examine the evidence against Patsy Rocco, fellow miner of Daniels', who also has been indicted by the Crown for the murder of Madore. Daniels and Rocco were indicted separately on charges of murder.

The two murder cases are the only ones on the present docket of the Queens county court. The deputy attorney general, R. P. Hartley, K.C., is conducting the prosecution and C. L. Dougherty, of this city, is assisting. So far no counsel has been assigned

to Daniels, but it is understood that Warren Brooks, of Gagetown, will represent Rocco, P. J. Hughes, K.C., of this city, was not retained for Daniels. Only a small number were present at the Gagetown court house this morning as the murder trials began.

Daniels' trial will commence as soon as the grand jury returns in the Rocco case. The witnesses who have been summoned are as follows: Dr. D. W. Buchanan, of Minto; Mrs. Mary Ross Coakley, Miss Marie Belding, Jack Riley, Lawrence LeBlanc, Alex. Nicholas, Angelo Daniels, son of Tony Daniels, and Frank Madore, brother of the murdered man. Corp. Ralph Love and Constable Peter Pablich, of the Minto detachment of the R.C.M.P. also will give testimony.

The alleged murder occurred on the evening of September 8 and was the result of a brawl on what is known as "Shaft Road." The indicted men are both miners, and were associates with George Madore, the murdered man. Madore died as the result of stab wounds allegedly inflicted by Daniels. In recent weeks Rocco also was indicted.

PENNIAC MAN HELD, ASSAULT ON ELDERLY LADY

Assault and Attempted Robbery of Mrs. Annie Whittaker

Struck on Head

Robt. Cleark, 24, Escapes To Penniac, Picked Up By City Police

Robert Cleark, 24, of Penniac, is being held by city police in connection with the criminal assault and attempted robbery of Mrs. Annie Whittaker, 83-year-old resident of this city. The assault took place on Parliament Square yesterday afternoon about 5.30 as Mrs. Whittaker was on her way to her home in King street, a few yards from the scene of the crime, after doing some shopping. Cleark was charged this morning with assault with intent to rob and was remanded until May 27 for hearing.

As she was walking through a short alleyway between the Education Office and the Parliament Building Mrs. Whittaker was suddenly struck on the head and knocked down within a few yards of King street, where several children were playing on the green. She thought at first that some object had fallen from the nearby building and struck her on the head, but as she regained consciousness she felt some one tugging at her purse. Frightened by her screams, her assailant ran
