Follows Bar Resolution

Carter of Saint John was appointed at last night's meeting of the Council of the New Brunswick Bar Association in this city to look into the matter of a recommendation to the government to enact legislation allowing actions to be brought against the government. This follows a resolution brought up at a recent meeting of the Canadian Bar Association at Halifax.

Several applications for admission as solicitors and final examinations for the bar were considered. A number of students were admitted to study law. They are, Ralph St. J. Freeze, Fredericton; Edward A. Dinsmore, Barker's Point; Donald W. G. Storey, Moncton; J. Edward Cormier, Westmorland Co.; Joseph G. Carten, Saint John; J. Edward Murphy, Moncton; Glendon G. L. Smith, Saint John.

Mr. Teed of Saint John was named a member for New Brunswick on the executive of the conference of governing bodies of the legal profession in Canada. Mr. Teed will represent the province at all meetings of that body.

P. J. Hughes, K.C., and C. F. Sanford, K.C., were named a committee with respect to the holding of the King's bench and chancery courts. C. L. Dougherty of this city was appointed to look after having photographs of the paintings of the supreme court judges and to see that these paintings are insured. J. N. W. Winslow, Woodstock, was granted re-admission to the bar.

ARCHDEACON BATE INDUCTED AT SAINT JOHN

Impressive Ceremony at St. Paul's Valley Church Last Night.

Ven. Archdeacon A. F. Bate was inducted as rector of St. Paul's (Valley) church at Saint John last night with an impressive service. The former rector of Christchurch Parish church here received the keys of the church from the church warden, C. H. Lee and A. N. Carter at the main door and at the various stations in the church, pledging himself to fulfill the duties of his new office.

His Grace Most Rev. J. A. Richardson, Archbishop of Fredericton, conducted the service and was assisted by Very Rev. Dean W. H. Moorhead, the former rector of the church, and now dean of the Christchurch Cathedral in this city. Archbishop Richardson in his address congratulated the parish on its choice of rector and congratulated Archdeacon Bate's parents on their son's service in the church.

Rev. W. P. Haigh attended the Archbishop as chaplain and other clergy present in their robes were Ven. Archdeacon H. A. Cody, Rev. Canon J. V. Young, and Reverends J. E. Taylor of Nauwigewauk; H. E. Dysart, Norton; Dr. W. R. Hibbard, Rothesay; C. J. Markham, Rothesay; J. E. Wickenden, Kingston; Julian P. McMann, Musquash; F. J. LeRoi, Fairville; George Readman, East Saint John; W. A. Filer, J. The large congregation filled the church and members of Trinity church choir augmented the regular choir of the church for the occasion. The inspirational music was under the direction of the organist, Professor Charles P. Hall and the anthem sung was "Hail to the Lord's Anointed."

APPEAL COURT ADJOURNED TO NEXT TUESDAY

Judgment in Daniel Bannister Appeal Expected at That Time — Smallest Docket.

The New Brunswick Appeal Court, which commenced its September sitting yesterday morning, completed what was probably its smallest docket, and adjourned yesterday afternoon until next Tuesday morning. All three cases on the present docket were presented yesterday. Chief Justice J. B. M. Baxter, and Mr. Justices Grimmer and Harrison comprised the court.

While no judgment was handed down in the Daniel Robert Bannister appeal which was heard on August 25, it is expected that judgment on an appeal from conviction for the murder of Philip Lake at Pacific Junction, will be handed down on Tuesday morning.

One judgment was handed down yesterday, it being in the case of Adelaide A. Lodge vs the City of Moncton. James Friel, K.C., asked for leave to appeal to the supreme court of Canada from a judgment handed down by the New Brunswick court at the June session in favor of the city. The case arose out of alleged damage to property of the plaintiff by the city in street work. Another case, that of Eva Collin Albert, Edmundston, vs Fraser Companies, Ltd., was argued by P. J. Hughes, K.C., of this city and A. J. Dionne, of Edmundston, for the plaintiff and Hon. R. B. Hanson, K.C., of this city, for the defendant.

There was no argument in the matter of the estate of Linton and Sinclair Co., Ltd., in which J. F. H. Teed, K.C., of Saint John, is appealing for an alleged balance of a bill of costs from the estate of which he was solicitor. Mr. Teed presented his factum for the court to consider.


