CHARGE DISMISSED
An information charging William Sidwell with threatening to shoot Milton Stairs was dismissed by Police Magistrate Walter Limerick in the local police court yesterday, after evidence had been taken of both complainant and defendant. The parties are residents of Hawkesbay, where the offence is alleged to have occurred. C. R. Barry represented Sidwell.

COLD WEATHER FIRES

ONE DECREE IS ORDERED IN N.B. DIVORCE COURT

Further Evidence in Second Case to Be Heard in Saint John

KINGSCLEAR RESERVE GETS SILVER MEDAL

Medal Originally Given by British Sovereign to That Reserve

Elections Today

William Polches Again Elected Chief; Art. Polches Assistant

Whether it is because the Kingsclear Indian reservation is the most peaceful and loyal of any reserve in the province or whether some chief of that reserve in pioneer days performed some deed of brave loyalty to the crown has not yet been made clear, but that reserve is in possession of two large silver medals, originally presented by King George Third, and Queen Victoria. The medals were presented in the early nineteenth century by the British Sovereigns, to the Kingsclear Reserve which at that time was about eleven hundred strong.

At the annual elections for chief and assistant chief at the Kingsclear Reserve this morning Lee McCutcheon, of this city, the Indian Agent, presented the medals to Chief William Polches and Assistant Chief Arthur Polches, both of whom were re-elected to office. Both have held office for three years.

A silent tribute to the governing of Chief Polches and his assistant is evidenced in the fact that not once in a long period of time has the R. C.M.P. been called upon to raid the reserve or make any arrests. Chief Polches first was elected to the office he now holds in 1914 and has held the post from time to time. His brother, Arthur, also has governed well as assistant chief.

The silver medal of King George Third was presented to Chief Polches this morning, and the silver medal of Queen Victoria was presented to Assistant Chief Arthur Polches. The presentation was made by Indian Agent McCutcheon. Originally the medals were presented to the Kingsclear reserve by the Governor General of Canada at that time.

The ceremony this morning was a most impressive one and the seventy residents of the Reserve turned out en masse to witness the presentation of the medals and to vote for their favorite.

Annual Meeting of Hospital Board Last Night, Officers Chosen

The annual meeting of the Victoria Public Hospital board was held last evening in the city hall with ex-Mayor W. G. Clark, M. P., vice-president, in the chair in the absence of the president, J. A. Reid.

It was announced in the superintendent's report during the evening that the year 1935 had been the busiest in the history of the hospital. The officers for the ensuing year were elected as follows: President, J. A. Reid; vice-president, W. G. Clark M. P.; secretary, Fred I. Haviland. Those present besides the chairman, were Mrs. D. J. Shea, Miss Areta Gerow, ex-Ald. Moses Mitchell, Warden Howard Cameron, Councillor Manner, C. E. Boone, C. A. MacVey, Dr. A. F. VanWart, L. S. Morrison, and F. I. Haviland.

Alexander Davidson resigned his seat on the board and W. G. Clark, M. P., was appointed in his stead. Prior to this ex-Mayor Clark had held his seat as mayor of the city. C. E. Boone whose term had expired was reappointed.

The report of the superintendent for the past month showed the following statistics: patients in hospital at beginning of month, 44; patients admitted during the month, 92; patients discharged during month, 88; number of patients in hospital at end of month, 48; medical cases admitted, 17; surgical cases admitted, 59; obstetrical cases, 9; births, 6; deaths, 6; major operations, 24; minor operations, 39; X-ray examinations, 71; maximum number of patients in one day, 54; minimum number of patients in one day, 33.
