The aldermen elected by the citizens, as it is entirely without the city's jurisdiction.

While several of the aldermen who opposed the Police Commission are running together on a ticket headed by Mayor Kitchen, they have as yet made no public statements as to whether the Police Commission is to be a plank in their platform. On the other hand, the ticket being formed by C. Hedley Forbes, who is running in opposition to Mayor Kitchen, has not declared its intention in regard to the Commission. In fact, Mr. Forbes has stated that so far no such thing as a ticket exists. It looks as though the new men nominated are so far independents.

Want Platform Expressed

The opinion is being expressed by citizens that different candidates should give an expression of opinion in regard to how they stand on matters of civic interest. Several of the candidates have stated that they do not know, for instance, how they stand as regards the Police Commission or in regard to daylight saving. If a man who is a candidate has no opinion to express in regard to important civic affairs he is not entitled to the confidence of his electors.



City Election

THE ELECTION FOR MAYOR AND ALDERMEN

FOR THE CITY OF FREDERICTON for the ensuing year will be held on

MONDAY

the 10th day of January, 1938

at the Polling Places as follows:—

DIVISION NO. 1—For all voters residing or owning property above the northwest centre line of Carleton Street, prolonged, at or near the City Hall, in the said City.

DIVISION NO. 2—For all voters residing or owning property in the remainder of the City, at or near the County Court House, in the said City.

NOMINATIONS

Every candidate for the office of Mayor or Alderman shall be qualified to vote at the election for which he is nominated and shall be nominated by at least TWO ratepayers residing in the City of Fredericton, and qualified to vote at the ensuing election for which such candidate is nominated.

Every nomination paper, with the certificate of the City Treasurer, shall be filed with the City Clerk or at his office, and not later than FOUR O'CLOCK on the afternoon of MONDAY, the THIRD DAY OF JANUARY, 1938, and the City Clerk, before receiving such nomination paper, shall ascertain from the same that the requirements of the Election Act have been complied with.

No candidate is qualified to be nominated for Alderman unless at the time of nomination he is a resident of the Ward for which he is nominated.

The acceptance of each candidate and the signature of at least TWO resident qualified voters, who must sign the nomination paper, shall be proved by affidavit attached to the nomination.

In case of a contest, each elector shall be entitled to vote for one candidate for Mayor, for ONE candidate for Alderman for Wellington Ward, for ONE candidate for Alderman for St. Anne's Ward, for ONE candidate for Alderman for Carleton Ward, for ONE candidate for Alderman for Queen's Ward, and for ONE candidate for Alderman for King's Ward.

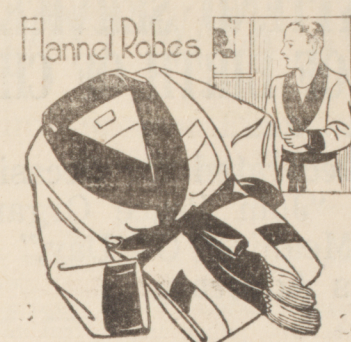

Did Not Refuse Credit

"Some of the press reports imply that the merchants of Minto have refused credit to the miners. That is not the case. We have no differences with the miners. Our credit differences are with the Union officials only and even then we have not unconditionally refused credit to them."

"We offered to continue one week's credit provided that our old bills were paid off. As far as we are concerned, we are still giving credit to many of the men on strike, miners with homes and others, whose integrity we have the highest regard for. In our case, and again I can speak for the Minto merchants, we have been compelled to suspend further credit to the Union because it became apparent that collection would be very slow."

"About three weeks ago, the merchants met and at that time decided that unless the Union paid up its large outstanding obligations to them at that date, we would not grant further credit. On the assurance of the Union officers that in future before any further relief orders were issued that the cash would first be on hand in the bank here to cover them, we decided to go on for a time on the new basis and allow further time on the old balance. However, during the week ended December 11, the Union issued extensive orders to merchants in the district with apparently no cash in the bank to cover such orders. We made special trips ourselves to the Union Hall for our money and had to come away empty-handed. Eventually we were paid for the current issue but not yet for the old amount. In view of this most unsatisfactory state of affairs, the merchants felt compelled, if they were to stay in business and honor their own credit obligations, to suspend credit to the Union until all unpaid balances had been paid."

Deplores Strike

"We deplore the fact that the men were brought out on strike with alleged promises of almost unlimited relief in the first place. We believe along with the miners, who have just formed their own union at once of the local collieries, that the strike method should be entirely dispensed with and that conciliation and investigation by the Fair Wage Board of New Brunswick, if negotiations with the employer fail, should be resorted to if the workmen feel they have grievances to be rectified."

"Mr. Wühr is also quoted as saying the merchants have given the boys a hand. I submit that during the slack-work summer period which preceded the strike, our firm extended credit to the many workmen up to
