predicted that the Japanese failure to launch a large scale offensive after their hours of grace passed was only a lull before the storm. They said, the full fury of Japan's air strength could be expected as soon as weather conditions here and at Shanghai are more favorable.

Havas News Agency reported that heavy rains over the Yantze River delta prevented the Japanese air fleet from taking off to bomb Nanking. Japanese military forces have stated. Havas added, they believed the suspense created by postponement of the scheduled attack would have a demoralizing influence on the Chinese population.

Only the United States and Italian embassies headed the Japanese warning for foreign embassies to evacuate their staffs and nationals.

Attended Banquet in Saint John Yesterday




