

GARDEN CROPS KILLED BY INTENSE HEAT

Since August 8 Mercury
Has Not Been Lower
Than 80 Degrees

Dropped Last Night

Capital Gets Relief as
Breezes Sprang Up
Last Night

In a temperature which has not been lower than 80 since August 8, the crops in Central New Brunswick are suffering irreparable damage. Gardens in this city have been hit especially hard and the intensity of the heat and sun for the past week has left the garden plants stripped for foliage. Beans, cabbage, potatoes—all have been scorched and stunted from further growth.

Welcome relief came to the citizens here last evening when a cool breeze sprang up. Today the mercury had dropped at least ten points which, with the cool wind improved conditions immensely. The temperature last night was only 62 degrees, the lowest in over a week for the evening hours. The average temperature over the last ten days has been as high as 88 degrees.

Yesterday the temperature in Fredericton was 96 degrees. This mark was six degrees lower than the high mark which was registered here for three successive days.

At nine o'clock this morning the official temperature was 72 degrees, but according to Postmaster Donald F. Cameron who keeps such records, the temperature is not likely to exceed 90 degrees today.

RIVER VERY LOW

Rainfall is greatly needed throughout the province. The most stressing need is of course in connection with the forest fire ravage, but crops are sadly in need of moisture also.

The Saint John River there is at a low point, being only several inches above the dead summer low mark. There has been no rain up river for almost a month with the result that at many places it is possible to walk part way across the river. Sanbars are much in evidence.

The stifling heat has ruined numerous beautiful flower beds in the city, several of which were in full bloom and real natural beauty spots.

NEW FIRE REPORTED

A new forest fire was reported at noon today to the New Brunswick Forest Service on the North Forks of Salmon Creek headwaters 16 miles due west of the Chipman Lookout.

The body is being shipped tomorrow morning to Elm Hill where the funeral is to be held at 2.30 p.m., A.S.T.

ARRANGE FOR REMOVAL OF PUBLIC NUISANCE

Thomas Hughes, Owner
of Slaughter House to
Build Septic Tank

Over Till Sept. 18

The Daily Mail Suggested Removal of the Nuisance

Thomas Hughes, owner of a slaughter house and piggery on the Woodstock road a short distance from this city, appeared in the police court this morning, information having been laid against him for violation of the Board of Health regulations governing slaughter houses.

Hughes was not asked to plead and the case was postponed until September 18, before which time it is understood that Mr. Hughes will have built a concrete septic tank to take care of the sewage and washings from the slaughter house and piggery which has allegedly been a public nuisance and a menace to the public health. This matter was brought before the attention of the public by The Daily Mail on several occasions. The septic tank will delete the offensive odor which has emanated for weeks from the particular vicinity in question, and which has been a source of complaint from many citizens.

The owner of the piggery was represented in court this morning by P. J. Hughes, K.C. Dr. J. M. Cameron appeared for the Health Department, he

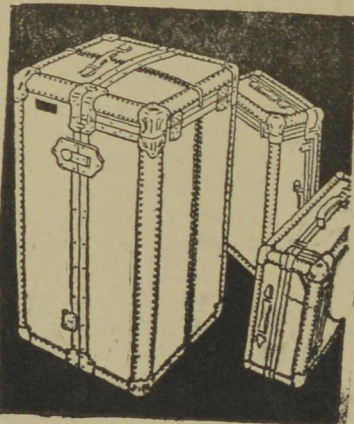
