## AMERICAN SOCIETY WOMEN BRANDED AS GRAFTERS BY WOMAN LAWYER

**Mrs. Mulliner Protests Against a Class She Calls "Alimony Grafters"—Says "Premium is Put on Divorce when Court Orders Payments by Ex-Husband—Is a Lure to Wife who Remains Constant"—"Man Must Go to Jail if He Fails to Pay, Though Sick, Injustice," Declares Woman Lawyer, Who'd Alter Law.**

When Mrs. Gabrielle Stewart Mulliner came out boldly in The American and branded as "frumps" the suffrage pleaders who attended the hearing before the Judiciary Committee of the Senate in Washington last Spring, there was a tempest in the suffrage teapot that hasn't stopped boiling yet.

Now Mrs. Mulliner is out with a criticism of "woman grafters" that promises to bring down upon her head the wrath of every divorcee in the country. Alimony is the field in which divorcees graft holds Mrs. Mulliner.

In her office on the eighth floor of No. 32 Fifth avenue Mrs. Mulliner outlined her views yesterday afternoon.

"Our present divorce laws work a terrible injustice upon American husbands when they allow the wife alimony," the woman lawyer began. "I am sure that much of the divorce evil could be eradicated if the system of alimony were done away with."

"It seems to me that women marry men for better or worse and enter into an agreement at the time of marriage to share all the good and evil fortune with their husbands. This it seems to me, ought to be construed to mean that women should share their husband's moral as well as financial failures. And when a woman finds life with her husband unbearable and they end their covenant by divorce, she should end all relations with this man. She should sever all financial connection as well."

"PREMIUM NOW PUT ON DIVORCE."

"I cannot understand the philosophy of a woman who casts her husband adrift and then arbitrarily demands a certain sum from him. And this in spite of the fact that he may be disabled or sick and unable to pay the money. And if he does not pay the 'graft' the woman will have him incarcerated in Ludlow Street Jail. I cannot understand why she should want to continue 'grafting' on him. 'A premium is now put upon divorce. A woman who divorces her husband and is awarded certain weekly or monthly cash payments, whether the man is conveniently able to pay it or not, has become a lure to the woman who stays with her husband through all his struggles. Women would think more deeply before signing divorce papers if they knew that alimony did not figure in it. In my opinion no woman should be supported by her divorced husband when she is free. Of course, I do not refer to the question of the support of children. I am referring to the financial support provided for the wife alone. 'I have seen so many cases where the man has been unable to pay the alimony that I have refused to handle any divorce cases where alimony is asked by the wife. I know cases where a man is supporting two women his ex-wife and his second wife. There is a prominent sculptor in this city who was ordered to pay his divorced wife a certain sum of money. He has frequently been unable to meet the payments because of the uncertain nature of his work. His wife immediately invokes the aid of the law and sculptor must immediately borrow the money from his friends."

**TWO EXAMPLES OF HARDSHIP**  
"Then there are many decisions which prove the injustice done to men by their ex-wives' insistence that their alimony shall be paid promptly. Here are two from the Law Journal of the last month:  
"Fritsch vs. Fritsch. This is an application to punish the defendant for contempt of court in failing to pay, after personal demand upon him the sum of \$110 due for alimony and counsel fees. His defense is that he is out of employment and has neither the funds nor ability to procure the same. If the fact is true his position is a pitiable one but the court is with out power to aid him. It has been held that poverty is no answer to such an application (Compton vs. Compton, 125 A.D., 859). Motion granted. Settle order on notice."  
"Michel vs. Michel. On this application to punish the defendant who is sixty-four years old, almost blind physically bordering on nervous prostration and unable to work for contempt, he defends upon the ground of his property. It has been held that this is no defense (Compton vs. Compton, 125 A.D., 859.) The court re-

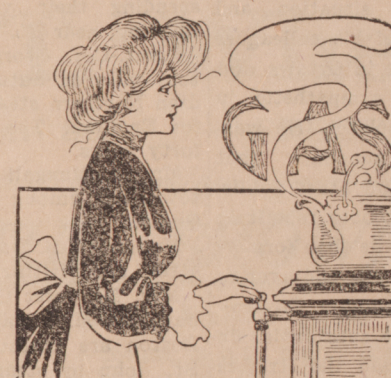

## Notice to Plumbers, &c.

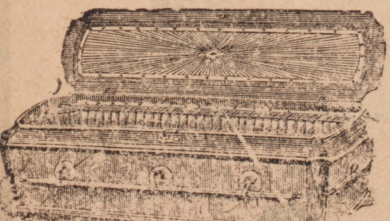
