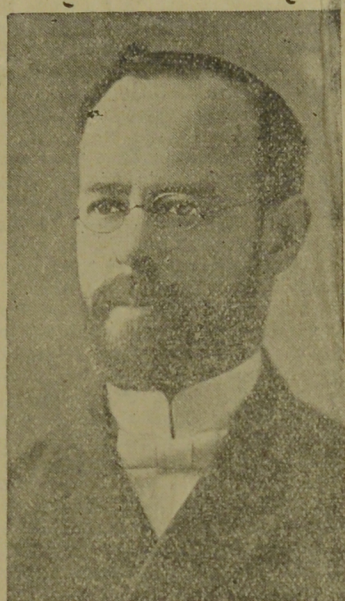

## ELECTION SERMONS

## PREACHED SUNDAY

Scott Act Enforcement Demanded From the Pulpit--Rev. Mr. McConnell Reviews the Year and Tells of Violation of Canada Temperance Act.

In several of the city churches temperance sermons having a bearing on today's civic election were preached yesterday. In all cases large congregations were present.

METHODIST CHURCH.

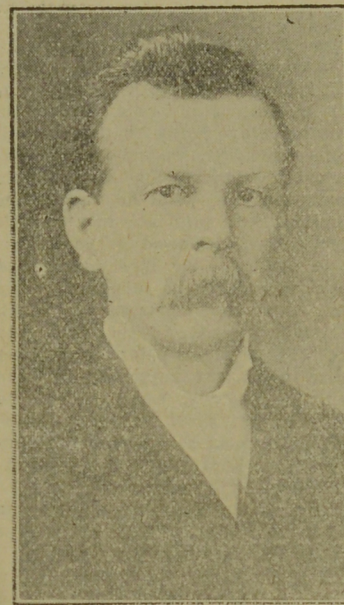
At the Methodist Church Rev. J. W. McConnell preached in the morning on the subject, "The Blot on the National Escutcheon," in the evening on the subject "Rum's Record in Fredericton for Twelve Months and the Hand of the Whiskey Business in the Civic Elections of Monday Next." The sermon in the evening was particularly directed toward the civic political situation. Rev. Mr. McConnell reviewed the past year in civic politics and stated that there had never been such a carnival of drunkenness in Fredericton as during that period. This was in spite of the fact that on April 30th, 1908, the electors of Fredericton had declared at the polls that they wanted the provisions of the Canada Temperance Act enforced. During the twelve months following that declaration, Fredericton had been a dry town. He would not say that a man was not able to buy a drink during that time for it was impossible to entirely stop the sale of liquor by legislation. Twelve months ago the liquor interests had made a determined effort, and had succeeded in placing in office a board of aldermen not favorable to the enforcement of the Scott Act. An administration of justice committee, appointed by that board, had performed acts as high handed as ever performed within the British Empire. The police commission of the previous year was discharged and almost at once large importations of liquor began to be made.

Some, said Mr. McConnell, might not be aware of the effects of the sale of liquor in Fredericton in the evening of the preceding Sunday. He had become painfully aware of it by finding four young men lying drunk on the steps of his church and by seeing others in a state of intoxication walking along Carleton street.

He stated that he had been pleased to observe that the Roman Catholic branch of the great church of Christ had made some strong declarations against the liquor traffic as had recently been made. The preacher proceeded to quote extracts from the letter which His Lordship Bishop

Casey of St. John, had addressed to the members of his church in which a strong indictment was made against the liquor trade.

During the course of his remarks,

Rev. Mr. McConnell said he was animated by no personal feelings against the liquor trade, which had been responsible for men walking off the wharves and for men being found dead about the city.

ST. PAUL'S PRESBYTERIAN.

At St. Paul's Presbyterian Church Dr. W. H. Smith preached in the morning taking as his subject, "Paul's Vote and Mine." His text was Acts 26:10; "And when they were put to death I gave my vote against them." Dr. Smith made an appeal for elevation to the aldermanic board, of men who could be trusted to enforce all the laws of the city. The Scott Act had not been properly enforced within the past year. Dr. Smith gave instances of drunkenness which he had observed personally and drew attention to the prevalence of Sunday-selling on the part of the liquor-dealers.

BRUNSWICK STREET BAPTIST.

At the Brunswick Street Baptist church in the evening, Pastor MacDonald preached an able and appropriate sermon from John 2:15, "And Jesus took a knotted cord and drove them from the Temple."

The preacher showed that the Saviour's action in cleansing the temple was prompted by the fact that men were interfering with the rights of their brother men. In regard to the sacred cleansing, he pointed out that Jesus had then entered as King and found it necessary to use his kingly authority to ensure equal privileges to all the people. Applying the lesson to present conditions in Fredericton, the preacher advanced strong arguments in favor of a clean city, and the protection of the weak and urged his hearers to make a kingly use of the ballot.

GEORGE STREET BAPTIST.

At the George Street Baptist Church the pastor, Rev. A. A. Rideout delivered striking temperance services, which were listened to with attention by large congregations. The preacher referred to today's election and stated that the city needed more effective enforcement of the Scott Act.

## ITALIANS BEFORE

## COUNTY COURT TODAY

The three Italians, Thomas Boyle, John Jamieson and Luke Booker, were sent up for trial by Police Magistrate Marsh this morning. They will be tried at the county court, which opens tomorrow.

Boyle and Jamieson were sent up on the charge of robbing the store of McManus & Co., Fredericton. All three will be charged with robbing the store of Howard K. Douglass at Stanley. Jamieson will also face the charge of robbing the store of Geo. R. Thompson of St. Mary's.

On Saturday afternoon the examination of witnesses was concluded. Chief of Police Hawthorne, acting on advice received from McGivney, went to that place in the morning, and secured two witnesses and some of the stolen property. Both witnesses were Italians. One swore that Jamieson had sold him seventeen rings for \$15.75 and had afterward taken five from him. The rings were produced and identified. The other Italian had in his possession a pair of shoes that had been taken from the store of McManus & Co. He would not say where he had got the shoes.

Two drunks were also before the court this morning. They were old offenders and the usual penalties were imposed.

Denver, Col., March 14.—Kathrine Murst, the first woman settler in Colorado, and reputed to be a countess, died here yesterday. She was 86 years old. With her husband, Count Murst, she came to Denver in 1858, necessitating by her presence a complete change in the modes of life at the border town. She was born in Baden Baden, Germany.
