## MUST NOT USE BAD LANGUAGE

President Lynch, of National League,  
After Profane Ballplayers--Two  
Umpires Fined.

New York, June 11.—President Lynch of the National League, intends to wage a vigorous warfare on players who are guilty of using bad language on the field.

"Most of the men I have suspended this year," said President Lynch today, have been disciplined, not for arguing with the umpires, but for cursing at them. Had some of the remarks of the players to the referees been made in the south or west great trouble would have ensued.

"I intend to break up this habit of having players call the arbitrators bad names and I will go the limit to discipline the next who offends. I also will not stand for umpires talking back to spectators or taking it upon themselves to criticize newspaper men. My attention has been called to the fact that last Thursday on the Polo grounds here, Umpires Johnstone and Moran stood in front of the press box and made remarks about the baseball writers. For this breach of the playing rule Johnstone has been fined \$25 and Moran \$15.

## EACH PUGILIST IS CONFIDENT HE'LL WIN

Ben Lomond, Cal., June 11.—Before leaving the Jeffries camp last evening for San Francisco with Choyinski with whom he will box in that city today, former champion James J. Corbett reiterated his belief that Jeffries is ready to go into the ring tomorrow if he had to and put up the fight of his life. After his bout with Jeffries yesterday Corbett turned to Mrs. Jeffries who had witnessed the three last rounds and told her that she had no cause to fear the outcome of the coming battle. Corbett's opinion is shared by all the experts in the camp. Jeffries is rid of every surplus pound of flesh, is as hard as nails and ready to go any route he may be called on.

The visiting newspaper men have told Jeffries the impression prevails in the east that he has been doing very little hard work since he began training. The big fellow spoke warmly on that subject while undergoing his daily massage.

"Where do these people get that idea?" he demanded. "I have trained for too many fights not to know something about condition and it is the truth I never went into a fight feeling any better than I do right now. I am satisfied with the shape I'm in. When I was hunting in the Tehachapi Mountains there was not a day that I did not walk thirty miles over rough country and that took the weight off me without my knowledge. I will be ten pounds lighter in the ring than I am now. The drying out process will do that. What I have been doing lately is to build up my shoulders and to get my wind right and that's what I need most."

## TAYLOR TRYING HARD TO STRENGTHEN RED SOX

Boston, June 12.—Pres. John I. Taylor has returned from his trip to Lenox Thursday afternoon, and has been a very busy man at the American league headquarters. He was in close communication with Manager Donovan and Hugh McBrean at Cleveland by long distance telephone. While he is satisfied that Hearne, the young infielder from the Bakersfield, Calif., club, will prove a good man, he is not taking chances, and is looking about for a young shortstop, fearing that Wagner may find trouble in getting into his old form raght away.

Gardner is suffering from lameness and must have a rest but Pres. Taylor says that with Speaker back in the game Engle can play second for a while and let Gardner out.

Pres. Taylor is very anxious to see the Red Sox as strong as possible when they reach Detroit next week, as that is the club he is anxious to help pull down. He said he had not tried to get Lee Tannehill from the Chicago club as he had heard that Tannehill was suffering with a lame leg, and he was not anxious to have any more cripples at the present time.

Notre Dame, Ind. June 12.—"Red" Kelly captain of the 1910 baseball team, has signed with the Chicago Americans and will join the team next week. He will return to Notre Dame next year to finish his course in law and will coach the team.

## GREAT SHOOTING RECORD

A foretaste of the record shooting that may be seen at Bisley this year was given recently when Sergeant John Tipples made 410 out of a possible 420, missing the bull's-eye apparently fewer than ten times in eight-four consecutive shots.

Under the new rules for Bisley, Sergeant Tipples used an aperture sight of his own invention on a rifle of service pattern. He was shooting in a North London Club competition under King's prize conditions, seven shots each at 200, 400 and 500 yards, and in four consecutive series at the three ranges scored 102, 101, 103 and 104. This is the first time that any man has made four scores of over 100 in a day.

## SYNOPSIS OF CANADIAN NORTH- WEST LAND REGULATIONS

Any person who is the sole head of a family, or any male over 18 years old may homestead a quarter-section available Dominion land in Manitoba, Saskatchewan or Alberta. The applicant must appear in person at the Dominion Lands Agency or Sub-Agency for the district. Entry by proxy may be made at any agency, on certain conditions, by father, mother, son, daughter, brother or sister of intending homesteader.

Duties—Six months residence upon cultivation of the land in each of three years. A homesteader may live within nine miles of his homestead on a farm of at least 80 acres solely owned and occupied by him or by his father, mother, son, daughter, brother or sister.

In certain districts a homesteader in good standing may pre-empt a quarter-section alongside his homestead. Price \$3.00 per acre. Duties—Must reside upon the homestead or pre-emption six months in each of six years from date of homestead entry (including the time required to earn homestead patent) and cultivate fifty acres extra.

A homesteader who has exhausted his homestead right and cannot obtain a pre-emption may enter for a purchased homestead in certain districts. Price \$3.00 per acre. Duties—Must reside six months in each of three years, cultivate fifty acres and erect a house worth \$300.
