

AthleticsFIFTY-SIX TROTTERS ENTER
2.10 CLASS IN SEASON 1910

Range in Age From Two to Twelve Years--Six Three-Year-Old, Nine Four-Year-Old--Peter the Great Leading Sire.

The standard of speed by which trotters and pacers who race on mile tracks are judged is 2:10. It is true that in many races down the big line 2:10 is not touched, but in the campaign this past season, from Terre Haute to Lexington, there was not a race winner who could not shade this time, and the heat winners who had not 2:10 ability can be counted on the fingers of one hand.

The remarkable increase in the number of 2:10 trotters tells in no uncertain manner of the improvement in the breeding of the American light harness horses. This year 56 trotters have gained entrance to the 2:10 list, which is a greater number than this exclusive circle could muster at the close of the season of 1896. This means that in the past 13 years 400 trotters have touched a mark first set by Jay Eye See, Aug. 1, 1884.

The new 2:10 trotters of this year range in age from 2 to 12 years. Miss Stokes and Justice Brooke being the infants and Alice Roosevelt the "old maid." Six foals of 1907 dropped into the list, almost doubling the three-year-olds in membership; Colorado E. Grace, Lou Billings, Emily Elin, J. Malcolm Foutts and George Todd being the additions.

The four-year-olds number nine: Joan, Billy Burk, Gold Dollar, Vito, The Plunger, Captain George, Dr. Treg, Silver Silk and Martha Tipton. Of the new comers, 21 are stallions, 19 mares and 16 geldings.

PETER THE GREAT FIRST.

Peter The Great, 2:07½, ranks as the leading sire in this list, with four to his credit. The Bondsman has three, Todd two, Margrave a like number, as has Arion, 2:07½. Bingen has one representative, while three of his sons are among the list of sires. Four sons of Baron Wilkes and three sires, the founder of the Wilkes family, have representatives.

Alice Roosevelt and Major Strong are by pacing stallions. Joan, Peter Donna, Peter Dorsey, Margate and Captain Cate are out of record-pacing mares. Ormonde has the honor of being the only new coming stallion with one of his get also in the list.

Capt. David A. Shaw of Cleveland, is the owner of Joan, Grace, Peter Dorsey and Miss Baritone, the latter being the only Massachusetts-raised addition. Patchen Wilkes farm owns three, Miss Stokes, Peter Donna and Crystallion. Walnut Hill farm owns two, the young mares Silver Silk and Martha Tipton, who have been reserved by Mr. Harkness for breeding purposes.

Willy is the first European-bred horse to earn a place in the list and he is a trotter that breeders on the other side of the water may well be proud of. Major Wellington was bred in Canada. Chester W. Lasell, J. J. Ryan and Frank G. Jones were the only amateur reinsmen who drove their own trotters to a place in the list.

LEWIS KNOCKED OUT
FIGHTING DICK NELSON

Shenectady, N. Y., Nov. 8.—Harry Lewis knocked out Fighting Dick Nelson in the first half of the second round here last night. Nelson was out of his class from the first taking the count of nine in the first round. At the beginning of the second round Lewis caught him full on the point of the jaw, and it was several minutes before Nelson was himself.

The fight was scheduled to go 10 rounds, and ostensibly for the welterweight championship of the world. Lewis weighed about 15 pounds the heavier, and the result was never in doubt.

Nelson went to the floor three times in the first round, all for generous counts, and in the second round was down twice almost to the limit in each period before the final clout in the face.

CANADIAN RAFFLES
HELD IN BALTIMORE

Baltimore, Md., Nov. 8.—The police last night arrested Geo. H. Barnette, aged 23 years, and Miss Florence Tomlinson, aged 18 years, daughter of Mr. Albert T. Tomlinson, both of Toronto. Barnette is a Raffles in real life. When arrested he wore evening clothes, carried two pretty domino masks, and had a loaded revolver and \$200 worth of jewellery in his possession. He was arrested when about to enter a pawnshop. He has confessed to committing a score of burglaries in New York, Philadelphia and other cities.

Miss Tomlinson, whose father is an inspector of the Grand Trunk Ry., was made the victim of a mock marriage when she was taken from her home by Barnette.

Toronto, Nov. 8.—In reference to the Baltimore despatch regarding the arrest of Geo. Barnette, Mr. Albert Tomlinson said his daughter had left home suddenly, without saying anything to her people, except that she had an appointment downtown and would return later. She did not return, and two days later they received a letter from her dated at Buffalo containing the statement that she and Barnette had been married at Niagara Falls. Other letters followed, posted from different points. In them, she added, that she was happy with Barnette, and asked her father to write to her. Quite recently she wrote that she had accidentally shot herself while playing with her husband's revolver.

"I am not surprised," said Mr. Tomlinson. "I had an inkling of this soon after they went away, and I have been expecting every day to hear of his arrest."

"Barnette," he said, "was arrested for burglary at Woodstock two years ago and served a term in the Central prison. He was also in a stealing affair up-country."

REPUBLICANS MAY CARRY NEW HAMPSHIRE.

Concord, N. H., Nov. 8.—The election as governor of Robert P. Bass, of Peterboro, who won the Republican nomination on a progressive platform, and for whom Col. Roosevelt spoke three times, was indicated tonight by returns from about one-half the towns and wards of the state. These early figures, if borne out, will give Bass a majority of 6,000 votes over his Democratic opponent, Clarence E. Carr, of Andover.

From the same returns, it appeared tonight, that Congressman Cyrus A. Sulloway, of Manchester, in the first district, and Frank D. Currier, of Canaan, in the second district, both Republicans, will be returned to congress by majorities somewhat reduced over their 9,000 votes each of two years ago.

A Republican majority of 150 on joint ballot in the legislature was indicated by the early returns. The election of all five members of the executive council also appeared probable from the early figures.

DEMOCRATS GAIN SIXTEEN CONGRESSMEN.

Chicago, Nov. 8.—Returns received up to 9:20 o'clock indicate that the Democrats have gained sixteen seats in the house of representatives. This is partly offset by a Republican gain in one New York district. The returns would indicate that the Democrats still lack seven seats of the twenty-seven necessary to give them control of the house.

ROOSEVELT LOST HOME DISTRICT.

Oyster Bay, N. Y., Nov. 8.—Stimson was beaten in Roosevelt's own election district. The vote was: Stimson, 158; Dix, 218.

TENNESSEE REPUBLICAN.

Memphis, Tenn., Nov. 8.—Partially, returns up to 9:30 indicate the election of Hooper, Republican, for governor by at least 15,000 majority.

LOCAL OPTION CARRIES IN FLORIDA.

Jacksonville, Fla., Nov. 8.—Local option carries the state from 3,000 to 5,000.

SPEAKER CANNON RE-ELECTED.

Danville, Ill., Nov. 8.—Joe Cannon, speaker of the house of representatives, was re-elected to congress today from the 18th Illinois congressional district by a slightly reduced plurality.

WOODROW WILSON WINS NEW JERSEY.

Trenton, N. J., Nov. 8.—Returns from 145 out of the 1193 districts in New Jersey, a trifle more than one-tenth, give: Lewis (R.), 19,107; Wilson, (D.), 18,157. These returns indicate a net gain of 71 to the district for Wilson on the basis of the 1903 vote, and would indicate his election by a plurality of about 15,000.

DEMOCRATIC LANDSLIDE IN IOWA.

Des Moines, Nov. 8.—Early indications are that Iowa cities, containing half the vote, have indulged in a Democratic landslide. Claude Porter, Democrat for governor, claims his election by 10,000, but the Republicans declare the result in doubt.



SYNOPSIS OF CANADIAN NORTH-WEST LAND REGULATIONS.

ANY PERSON who is the sole head of a family, or any male over 18 years old, may homestead a quarter section of available Dominion land in Manitoba, Saskatchewan or Alberta, the applicant must appear in person at the Dominion Lands Agency or Sub-Agency for the district. Entry by proxy may be made at any agency, on certain conditions, by father, mother, son, daughter, brother or sister of intending homesteader.

Duties—Six months' residence upon and cultivation of the land in each of three years. A homesteader may live within nine miles of his homestead on a farm of at least 80 acres solely owned and occupied by him or by his father, mother, son, daughter, brother or sister.

In certain districts a homesteader in good standing may pre-empt a quarter-section alongside his homestead. Price \$3.00 per acre. Duties—Must reside upon the homestead or pre-emption six months in each of six years from date of homestead entry (including the time required to earn homestead patent) and cultivate fifty acres extra.

A homesteader who has exhausted his homestead right and cannot obtain a pre-emption, may enter for a purchased homestead in certain districts. Price \$3.00 per acre. Duties—Must reside six months in each of three years, cultivate fifty acres and erect a house worth \$300.00.
