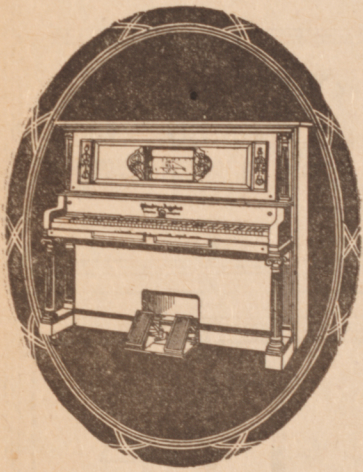

THE MISSES YOUNG**SR CHARLES' SCHEME IS EXPENSIVE**

Sir Charles Tupper in his retirement at Bexley Heath is still busy with plans and dreams for his native country. His latest proposal is interesting, at least, although it comes a little late in the day. It is that instead of warships Canada should construct the fastest steamers afloat of the cruiser build and capture the fast Atlantic service by running them between Halifax and Great Britain. If hostilities were to break out they would be used in keeping open our grain route across the Atlantic.

The scheme is not without its attractiveness. The big Cunarders are under subsidy from the British government to be converted into armored cruisers in time of war. But "the fastest cruiser afloat" is a pretty expensive proposition to tackle, and the standard is so constantly shifting onward that we should have to keep building or be out of the race. The Olympic, the White Star liner launched recently with a tonnage of 45,000 will not be "the last word" long. The Germans have already laid down the keel of a 50,000 tonner; and the Cunards have placed an order for one of still greater tonnage, probably from 55,000 to 60,000.

Speed is fearfully expensive. The big Cunarders Mauretania and Lusitania each burn 1,000 tons of coal a day. Until the internal combustion engine or some other new and improved form of motive power is devised great speed will continue to be very expensive to secure, and any government embarking on the race would have to calculate upon an enormous expenditure, for something which, after all, would not secure the desired end of coast defence.

GAME WARDEN DOYLE ON WILD GOOSE CHASE

Raided the Loggie Concern's Premises But Found Nothing Doing

(North Shore Leader.)

Surveyor General Grimmer, Chief Game Warden Dennis Doyle and the A. & R. Loggie Co., of Loggieville, figured prominently in a double quick settlement of a big game violation claim against the Loggie concern. It was not a Scott Act raid at all, but a real big game raid and while the three specified channels of information are positively closed, it is learned that there was nothing doing. The Loggie concern was found to be free of any breach of the game act and its vindication is complete. The matter has been the cause of considerable discussion. The proceedings were probably in camera, but then it is difficult to keep matters in camera all the time. They must develop or be developed for discussion.

Well, information is supposed to have reached the Hon. W. C. H. Grimmer that Messrs. A. & R. Loggie were violating the act. They had trout, moose meat, caribou meat, etc., and were shipping game, so it is alleged. The Loggie concern is one of great stability and recognized as one of the leading Miramichi establishments. With the possession or alleged possession of the information Mr. Grimmer writes Mr. Dennis Doyle to "raid" the place. To Loggieville Mr. Doyle repairs and subsequently proceeds with his investigation. Presumably he went through the cellar, refrigerators and other cold storage equipment. But what did he find? Nothing!

The affair happened one day last week. It may have been within the rights of the Surveyor General to conduct the search, but it was futile. Mr. Doyle returned to Newcastle and did not care to say anything at all. But he simply did his quota of the work as his position demanded. He is a good official, but if the goods were not there, how could he find them? But where did the information originate?

said that the merchants of Fredericton were robbers. It was between Sturgeon and Boulter and he believed Sturgeon. The attempt to curtail the mail-order business was most ill-advised and would be the greatest advertisement the mail-order houses had got in some time.

Mr. Phinney referred to the "rum party" and said that there was, not a man of them opposing the prosecution against Gunter. Ald. Hooper knew who were supporting the prosecution and who were not.

This was the second investigation of the kind. One was against Winter for enforcing of the Scott Act. This was the other.

Ald. Clark, at the conclusion of Mr. Phinney's address, stated that the evidence would be carefully considered as far as the first charge was concerned. The second had not been proven and from it Policeman Gunter was exonerated.
