LOOSE TONGUED POLITICIANS AND THEIR METHODS

(Montreal Herald)

Even a daily newspaperman is moved at times to admit that the Canadian people may at times take their mental pabulum too exclusively from daily newspapers. The daily newspaper is invaluable and essential as a vehicle of daily information; but it does not give perspective. That is the business of more slowly-constructed periodicals. There is only one periodical in Canada which gives a perspective view of the facts of political history; and that gives it only once a year. It is the Canadian Annual Review which has just appeared for the year 1910. There are things in this volume which the Canadian public looked at from the close quarters of the daily press and then forgot about, and which should most emphatically be looked at again in perspective. Canada is full of politicians who do things which pass muster at close quarters and under rapid and stressful scrutiny, but would become intolerable if considered carefully and leisurely at a few weeks' or a few months' distance.

Let us consider the loose-tongued politician. He flourishes in all parts of the Dominion, but nowhere perhaps more brilliantly than in Manitoba. Let us consider him in Manitoba on this occasion, because we shall hurt nobody's feelings at that range in Manitoba in the year 1910. He said things in that election in Manitoba which are today perhaps forgotten, but which if they were remembered would bring the blush of shame to every Manitoban. One of him—a Minister of the Crown—said in that election, on June 17: "When we had a vacant judgeship in this Province a very few months ago, and when there was considerable delay as to who should be appointed to this important position, the delay was owing to the fact that a leading Liberal, a man recognized as probably the most trusted friend Sir Wilfrid Laurier had in the Province, was

trying to sell that judgeship for the sum of \$10,000, claiming that the money was necessary to go into the campaign to defeat the Roblin Government." Another Minister of the Crown repeated the charge three days later. Then there was published a signed statement by a resident of Manitoba, declaring that he possessed evidence to corroborate this charge. And on July 2, the signer of the statement died of heart disease without having produced any of the alleged proofs and nothing has since been heard of them. The election took place on July 11, and gave the Conservatives a large majority in the House as the result of a popular vote in which their excess over their opponents was only one-third of one per cent. of the total vote cast.

Since that election not one single effort has been made by any opponent of the Liberal party, either in the federal field to which the matter properly belongs or in the provincial field in which it was raised, to substitute that terrible charge—a charge which strikes at the very foundation of government, which besmirches with suspicion all confidence in the judiciary of Canada, and does all that in a Province one of whose principal functions is to imbue the newly-arrived American immigrant to this country with a sense of the unassailable character of our courts and our administration of justice. We think in terms of the daily newspaper, and the election once over, the daily newspaper has moved on, according to the laws of its being to more current topics. Sole and singly, the Annual Review crops up to remind us of what in view of the lack of all attempt to follow it up seriously after the election, can only be described as one of the most atrocious pieces of loose-tongued electioneering ever perpetrated in this Dominion. It is a style of electioneering which was not confined to the Conservatives. In the same uncompromising record we are reminded that in March, when the election began to loom on the horizon, Mr. T. H. Johnson, the Liberal member for Winnipeg West dramatically placed before the Legislature a photograph of an express company receipt for a bundle of bonds valued at \$50,000 shipped to the Hon. Robert Rogers from New York, and intimated his belief that these bonds explained the Minister's support of the government guarantee of the Canadian Northern Railway issue. When Mr. Johnson was informed by the Minister that the bonds were merely a block of securities of a private company in which the Minister was interested and which were returned to him after an unsuccessful attempt to sell them in New York, he had no more to say on the subject. Mr. Johnson's actions did not like the other case which we have considered, tend to cast odium upon a government or a judiciary or an institution, merely upon an individual; but how vastly better for the reputation of the politician and for the tone of public life in Manitoba if the charge had never been made!

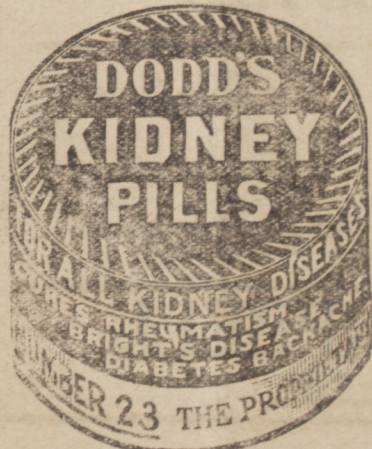
PRINCE NOT TO VISIT AMERICAN CITIES

BOWERS INQUEST RESUMES TOMORROW

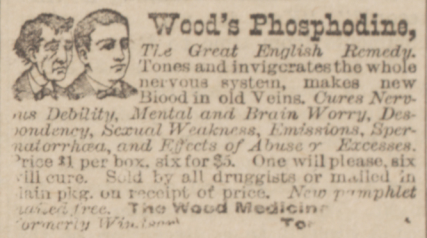
(St. John Telegraph.)

Dr. L. A. Currey, manager of the St. John River Steamship Co., Ltd., received word yesterday that Coroner Geo. A. Perley of Mauderville, would conduct an inquest into the death of James Bowers, the young Englishman who was drowned near Oromocto some weeks ago. The body was found this week eight miles below the scene of the accident, and Coroner Perley decided to hold an inquest which will open in the County Court House at Oromocto at ten o'clock tomorrow morning.

Dr. Currey will go up river on the steamer Victoria to make arrangements for the calling of witnesses, as the young man was trying to board the steamer Elaine from a small boat when the accident occurred, and the coroner's jury will be asked to fix the responsibility.

Besides the captain, officers and deck-hands of the steamer, three passengers, H. H. McLean of Fredericton; William Burr and W. S. Tompkins, will be called to give evidence. The victim of the drowning had been in this country only a few months, and was employed by Henry Wilnot. With his father he was attempting to receive a package for Mr. Wilnot from the boat, and the officers say that the steamer had come to a stop when the boat put out from shore.

The small boat struck the steamer with considerable force and the shock knocked the young man overboard. He sank, never to rise.
