Proceedings at Council Meeting Were Exceedingly Lively

Secretary Treasurer Bliss and Coun. Colter in a Wordy Combat--Mr. Bliss Says He Advised the Assessors to Get After Wealthy Tax Payers--Secretary Treasurer's Salary Fixed at \$1,500 with No Extras.

The County Council's session yesterday was enlivened by a breezy but verbal conflict between Coun. Colter, of Douglas, and Secretary Treasurer Bliss. The councillor took the ground that the salary of the secretary treasurer should not exceed \$1,200, basing his opinion on the salaries received by previous secretaries and the average amount received by Secretary Bliss since assuming office. Secretary Bliss, on the other hand, contended that the councillor's attention to his salary was on account of an effort of his, in his capacity as secretary treasurer, to have property of wealthy citizens of the county valued at its proper figure, and principally because he had suggested that the property of Hon. George J. Colter, father of Coun. Colter, did not have proper valuation. After a lively debate, Secretary Treasurer Bliss was re-appointed at an annual salary of \$1,500. Hon. H. F. McLeod was re-appointed auditor at the salary he received last year.

A report from the special committee on the Marysville claim of over-assessment, adverse to the Town of Marysville, was received and adopted. The Council also passed a resolution, placing a minimum assessment valuation of \$2 per acre on lumber lands within the county.

The report of the Assessment Committee was received. Assessment for county purposes was fixed at \$6,576.05 the lowest amount since 1908.

The session began at 2.30 p. m. On motion, the following county officers were appointed:

Fred St. John Bliss, Secretary Treasurer.

Hon. H. F. McLeod, Auditor.

Coun. Sterling, seconded by Coun. Smith, moved that the salaries be the same as before.

Coun. Essensa asked that some definite amount be named as the secretary treasurer's salary, and moved seconded by Coun. McMullen, that the amount be \$1,500.

COUN. COLTER OPPOSES.

Coun. Colter moved a resolution that the secretary treasurer's salary be \$1,200. Speaking to his motion, the councillor said that at the morning session the secretary treasurer had made some insinuating remarks concerning himself. He had asked every member of the committee which had considered the matter of the secretary treasurer's salary if he had in any way abused that official. All had said he had not. It should be remembered that at the last election, he had defended the secretary from the attacks of other councillors. Now that official was trying to use him as a scape-goat. He had neither fear nor love for the secretary treasurer. He trusted him as he would any other man.

Discussing the matter of salary, Coun. Colter said that Wm. Wilson as county secretary had received about \$600. James A. VanWart and John Black had received but little more. The present secretary treasurer on assuming office, had received about \$700 and his average salary since had been less than \$1,000.

"Why should there be so great an increase in his salary? The only reasons advanced were increased cost of living and increased business. It was only on the previous day that a councillor had said the taxation of the county was not greater than it was in 1905. That did not look as if the business of the office had been increased. The secretary treasurer seemed to exert some power, hypnotic or otherwise, on the councillors. As far as the secretary treasurer was concerned, the time would come when he (Colter), would meet him on any platform.

SECRETARY BLISS.

Secretary Bliss asked for permission to reply.

On the motion of Coun. Timmins, seconded by Coun. Colter, the secretary was heard.

Secretary Bliss stated that he was annoyed that such a controversy had arisen. Coun. Colter had said he had neither love nor fear for the speaker. In reply, he could say he did not fear the councillor and certainly had no reason to love him. On the first occasion that he had ever known Coun. Colter, the latter had come to the office of the secretary and asked for information concerning nomination and election. He had said to the speaker, "The people say I am coming out to keep down my father's taxes."

Continuing, Mr. Bliss stated that the attack on himself was made because he had stated that the wealthy class were not paying their pro rata tax. The assessors for the Parish of Douglas had been to him concerning the assessment in that parish. He had told them that the property of Hon. George J. Colter, according to report, was not assessed at the valuation it should be. He did not single out any one parish, for he had told the assessors of Kingsclear that it was not fair that Willard Kitchen should be taxed on only \$5,000. Through this same tendency to undervalue the property of the wealthy and tax that of the poor to its full value, in the Parish of North Lake a large property had paid no taxes for years.

COUN. COLTER REPLIES

Coun. Colter said in reply that if anyone brought in a scheme for the more equitable distribution of taxation he would find no more hearty supporter than himself. He was glad the secretary treasurer had come out from behind his cover. As far as the insinuations were concerned he could reply with deeds, not words. It was getting to be almost a personal matter.

Coun. P. Graham seconded Coun. Colter's amendment.

TOO MUCH HOT AIR

Speaking to the amendment Coun. Timmins said that there had been too much hot air. The atmosphere was heated. He had thought it had been finally settled in July that the secretary's salary was to be \$1,500, he to pay all expenses of his office. He would be sorry to see all the work spent on the matter at that time wasted.

Coun. C. W. Pond thought the matter of salary had been settled. The secretary treasurer was a pains-taking official. His remarks concerning the taxation of the wealthy class had evidently made some of the assessors wake up. Cost of living had increased. The working man was getting more money and the professional class should get the same.

Coun. McMullen said that it had been understood at the previous session that the secretary treasurer's salary was to be \$1,500. He could not see why there was to be a change.

Coun. Morrison said that the increase had been based on what the secretary treasurer had actually received under the old system.

AN EXCEPTIONAL YEAR

Coun. Colter replied that the year

referred to was most exceptional as during it the secretary treasurer had received \$400 more than in any other year.

Coun. Sterling was of the opinion that the secretary treasurer was cheap at the salary of \$1,500. He had given his best service to the county.

Only Coun. Colter and Coun. P. Graham voted for the amendment.

The original motion was carried.

LUMBER LAND ASSESSMENT

Coun. Sterling moved the adoption of the following resolution:

January 19, 1911.

To the Warden and County Council of the Municipality of York,

Whereas Section 4 of the Assessment Act requires that all property liable to taxation shall be assessed at its full cash value,

And, Whereas, it is the opinion of the members of this County Council, that lumber lands of this county are not being assessed at their full cash value as the law prescribes,

Therefore resolved, that in the opinion of the members of this county council the average minimum valuation of the lumber lands of companies and corporations should be at least two dollars per acre.

And therefore resolved, that the secretary treasurer be instructed to insist on a proper enforcement by the Assessment Act, in order that the burden of taxation may be equally distributed upon the ratepayers of the several parishes of the county.

Coun. Colter seconded the motion of Coun. Sterling.

OPINIONS DIFFERED

Coun. Grant asked if it was the intention to tax waste land the same as timber land.

Coun. Fred Pond thought the valuation proposed was a little stiff in view of the fact that there was so much waste land.

Coun. Morrison said he considered the proposed tax to be not enough.

Coun. Everett did not think \$2 per acre was too high.

Coun. C. W. Pond thought the assessors should be instructed to be careful in their valuation of timber lands. The rich people had been throwing the burden of taxation on the poor for too long a time.

Coun. Fawcett thought the valuation proposed was high enough.

Coun. Carson wanted the valuation placed at \$4 per acre.

Coun. Robt. Graham thought the valuation was too high.

The resolution was carried unanimously.

On motion the salary of the county auditor was fixed at the same amount as during the previous year.

Coun. Sterling presented the report of the Assessment Committee as follows:
