BLOOD-CLOT ON BRAIN KILLED YOUNG BOY

Cedric Delong Left Work at Noon on Account of Illness--Died at Ten O'clock

Cedric Delong a young boy aged fourteen years died with startling suddenness last evening. The cause of death is thought to have been the pressure of a blood-clot upon the brain. This is very unusual in one so young and a similar case has not been heard of for some time. The boy was the eldest son of Mr. and Mrs. Frank C. Delong of Saunders Street. He was employed in the Hart Boot & Shoe Company's factory. At noon he came from the factory to his dinner and complained of feeling ill. He did not return to work in the afternoon. During the afternoon his condition grew worse. Medical aid was summoned but nothing could be done for the boy who died shortly after ten o'clock at night. His illness was accompanied by symptoms which indicated the presence of a blood-clot on the brain.

PROSTRATED BY GRIEF

The deceased is survived by his parents two brothers and a sister. The members of the family feel their bereavement keenly the mother of the dead lad being almost prostrated by grief.

The funeral will take place Sunday afternoon at four o'clock from the home of his parents. Interment will be made at the Rural Cemetery. Rev. Dr. MacDonald will conduct the funeral service.

SUNBURY--QUEEN'S RECOUNT TO TAKE PLACE HERE ON THURSDAY

The recount in the Sunbury-Queen's election, which was to take place at Gagetown yesterday afternoon before Judge Wilson, was adjourned until Thursday next when it will take place here at 2 p. m. B. Wallace and Dr. L. A. Curry of St. John. Recorder Baxter, Mr. Smith, Col. McLean, Dr. Curry and Mr. W. B. Wallace came to Fredericton by steamer last evening, returning to St. John by rail. The ex-Minister of Public Works was looking well. It is probable that he will take a short vacation before entering strenuously into legal work.

PORTION OF OLD CHURCH BELL FOUND IN WILMOT'S ALLEY

Thought to Have Belonged to Baptist Church Erected in Early Days of City

An interesting relic of early days in Fredericton was recently discovered in Wilmot's Alley where excavations are being made preparatory to the erection of an addition to the building of the McMurray Book and Stationery Company. The relic is the portion of an old bell. It was unearthed a couple of days ago by John Martin who working making the excavation. There are numerous conjectures as to what the use of the bell originally was.

One story is that the bell belonged to the Baptist Church which stood on Queen Street near the entrance to Wilmot's Alley in the early days of this city. Those who are acquainted with the early geography of Fredericton, however, say that no church stood in that locality at all, the Methodist Church stood on the site occupied by the existing edifice. A Baptist Church stood early in the last century near where the Orange Hall now is on Queen Street West. Later there was a Baptist Church on King Street just below Regent. The bell however, could hardly have belonged to either church.

The relic will furnish material on which local archaeologists and historians may work.
