## ROMANTIC MARRIAGE OF BLIND TROOPER MILLOY

(Montreal Star)

The darkness that has been over the life of Trooper Milloy, late of the Canadian Mounted Rifles in South Africa, lifted today and sunning is again in his life.

Trooper Milloy lost the sight of both eyes while fighting the Boers in South Africa, but later he won the love of a charming girl, and yesterday Rev. Dr. Sparling married the two in St. James Methodist Church.

Although the blind soldier has never seen his wife he is none the less happy and contented and looks forward in spirit to a lifetime of happiness with the woman he loves. Mrs. Milloy is a daughter of Mr. Silas Munroe, a capitalist of Seattle, Washington, and as Miss Jean Munroe gained quite a reputation for herself as a musician in the Pacific States.

Trooper Milloy will be remembered by all who follow the Canadian participation in the Boer-British war in South Africa; his gallantry at Whitfort in encouraging his comrades to fight till the last, when the fatal bullet that robbed him forever of his sight, grazed both eyes, his conspicuous bravery in standing with the fellows bereft of sight and with the blood streaming down his cheeks.

On his return to Canada, after the war was over, Trooper Milloy received a splendid reception throughout the length and breadth of the Dominion. His service medal was presented to him by the present king His Majesty George V., then Duke of Cornwall and York, who with his own hands placed the badge of honor on the breast of the sightless soldier and spoke enthusiastically of his valor.

The trooper then made a tour of Canada lecturing on his experiences in South Africa, and everywhere received a rousing welcome. He later attended the University of Oxford, for a post graduate course, and subsequently took a deep interest in British politics. He stumped the provinces on behalf of the Unionists and Imperial preference, of which he is an enthusiastic exponent.

Mr. Milloy met his bride in London about two and a half years ago, and the two at once became infatuated with each other.

The party, which arrived yesterday, consisted of Miss L. Munroe, who acted as bridesmaid, and Mr. Magee, of Ottawa, an old comrade of the bridegroom, who acted as best man, and the two principals in yesterday's ceremony.

The newly married couple will leave Montreal tonight for Toronto on their way to the United States for their honeymoon.

After a brief honeymoon in the Southern States, Trooper and Mrs. Milloy will, in all probability, take up their residence in England, where a political career awaits the blind soldier.

## BRANDON HAS REPUDIATED SIFTON

Brandon, Man., March 4.—The Brandon Sun, Liberal, says today:

"In his speech in the House of Commons on Tuesday evening on the reciprocity agreement with the United States, the sentiments expressed by Hon. Clifford Sifton are directly opposite to the views held by his constituents, and especially by the Liberals of the electoral district of Brandon, which the minister represents. To the leaders of the Liberal party in this district, the action of the ex-minister is no surprise, as it had been openly stated here for the last fortnight that he (Mr. Sifton) intended to take the stand he has taken. He has been urged by leading Liberals in his own constituency to either support the reciprocity agreement or refrain from taking a stand on the measure, but to all entreaties he turned a deaf ear.

"There is absolutely no difference of opinion among the Liberals of Brandon constituency regarding the reciprocity agreement. They believe that the arrangement is in the best interest of Canada as a whole, and is especially favorable to the western provinces. The Liberals are not alone in this feeling, for the views they hold are shared by many prominent Conservatives, and that feeling is almost unanimous among those engaged in agriculture."

"While Mr. Sifton contends that the reciprocity agreement will ruin the milling industry, those who are engaged in it in this territory do not share these views. Prominent Liberals, in discussing Mr. Sifton's speech do not hesitate to strongly condemn the stand he has taken, and declare that meetings of Liberals will be called immediately to pass resolutions repudiating the views of the member for this constituency, endorsing the action of the government on the trade agreement with the United States."



Get a yard of double-faced elder-down. It comes in white, pink and blue, fifty-four inches wide. Hem one of the sides back three inches from the edge; on the other side run a tuck the same width as the hem (the three inches from the lap). Now fold the sides over so that the tucks meet down the centre front. Sew the bottom straight across, but at the top sew from either outer edge toward the centre, but leave space for the neck; cut out just enough to fit snugly, and bind the neck with ribbon. Use pearl buttons and silk cords made into loops for fasteners. Baby cannot get his hands and feet out, yet has plenty of room to kick and scratch.
