DISPENSATION FOR ROMAN CATHOLICS

Roman, Dec. 6—Roman Catholics all over the world are discussing this week, the dispensation of his holiness Pope Pius the ninth will permit of them using flesh meat next Friday December 8, upon which day the feast of the Immaculate Conception is celebrated.

Before the dispensation was granted, Pope Pius relieving Roman Catholics of the necessity of fast upon church holidays, when such happened to fall on a Friday. Christmas and New Year's days were the only occasions upon which the fasting rule suspended.

Now by virtue of Pope Pius action all Fridays throughout the year which are also observed as feast days church holidays with the exception of Good Friday will be the same as ordinary week days as far as abstinence from flesh meat is concerned. Next Friday becomes the first occasion upon which the dispensation of the Holy Father becomes operative since he assumed office.

THE KING AND QUEEN
ENTERED DELHI TODAY

Delhi, India, Dec. 7—King George and Queen Mary today made their state entry into Delhi to begin the round of ceremonies which will culminate next Tuesday in the great imperial Durbar. Their Majesties were accorded an enthusiastic reception by the immense crowds gathered about the gates to the city. Viceroy Harding and the governors and heads of provinces welcomed the King and Queen, while a notable gathering of native princes and their escorts awaited the imperial visitors inside the fort walls. The city and people alike were bedecked in the gayest holiday attire.

The official reception today marked the beginning of a ten day's programme of elaborate ceremonies. In addition to the Durbar itself the events will include the laying of the foundation stone of the King Edward Memorial, the attendance of the King and Queen at divine service in the great tented city without the walls, a grand review of British and native troops, and a race meeting and military tournament. The programme will conclude with a state progress through the city of Delhi, at which more than half of all the domesticated elephants in India are expected to be in use.

BIOGRAPHIES OF McNAMARAS
AS TOLD BY JOHN L.

Los Angeles, Dec. 5—Sitting in a corridor just outside his cell in the county jail only a few days ago John J. McNamara, secretary-treasurer of the International Association of Bridge and Structural Iron Workers, briefly sketched what he termed the uneventful lives of himself and his brother James B. McNamara.

"I was born in Cincinnati December 23, 1876," he said, "and I am the oldest of six children living although there were ten children originally. I attended the common schools in Cincinnati until I was twelve years old and then took a three-year course in a business college.

"Nothing of any importance happened to me until the panic began in 1892 when I turned my hand to anything and everything to keep the pot boiling as they say.

"I did my first bridge work at Cincinnati in 1898, joining the union the next year. Between 1898 and 1904 I visited various sections of the Middle West following my trade and working on steel bridges, viaducts, and similar structures.

ELECTED IN TORONTO

"I have held all the offices in local unions particularly in those of Cleveland and have attended all the conventions of the international association since 1902. I was elected second vice-president at the convention at Kansas City in 1903 and was chosen secretary-treasurer at Toronto in 1904. I have held that office ever since.

The last building I worked on was the Rockefeller structure in Cleveland. I left that job to go to Toronto and it was held open to me. If I wanted to go back, but I didn't as I had been made secretary treasurer

and had my time fully taken up with the duties of that office.

"The offices of the international association were in New York when I was first elected. Later for sentimental reasons I was instrumental in having them moved to Cleveland. Two years after the offices were moved there another change was made to Indianapolis for the reason that so many labor organizations had their international headquarters there.

"I never planned my life far ahead. The work of an ironworker probably precludes such planning for such a man does not know when he leaves home in the morning that he will return at night. It probably tends toward fatalism.

"I wanted to learn of the organization in which I held office, particularly the legal end of it, and so I attended the Indianapolis College of Law and was admitted to practice in 1909.

"There is little else about my life except my arrest. I am an inveterate reader and always have been, of books treating with economics and industrial matters."

JAMES B.'s CAREER

James B. McNamara who sat quietly by while his brother talked also was born in Cincinnati. His birthday was June 2, 1882. He attended the common school and then learned the printers' trade which he has followed ever since, working in job offices in Chicago, Cleveland, Cincinnati and other cities.

"Unlike me," said John J. McNamara, "my brother has never been especially active in trades union affairs."

MINISTERS KEPT BUSY
ANSWERING QUESTIONS

Press Gallery, House of Commons, Ottawa, Dec. 5—Hon. Dr. Pugsley was turned down short by Mr. Speaker yesterday afternoon. It was during the answering of questions. The Premier had given an answer to a question regarding mixed marriages which the ex-Minister did not deem sufficient. He was pleading for his right to have another answer.

"I rule" said the Speaker, after appeals from the government benches "that the Premier has answered the question as he sees fit, and the hon. gentleman has no right to discuss the matter."

"Even if the answer is not an answer?" asked Mr. Pugsley.

"Yes," answered the Speaker briefly.

The question in point, which was one of thirty-seven others answered by the Government consisted largely of a citation of questions by Conservatives and of Mr. Aylesworth's replies last session and a request for a statement of the new Government's opinion as well as of their policy Mr. Borden replied that the Government would regard with great respect Sir Alan's opinion on a question of law and agreed with him that it was a matter entirely of legal interpretation but he did not give any further information as to the government's intentions. It was to this latter point that Mr. Pugsley objected and drew down the Speaker's ruling.

The same question and another by Mr. J. H. Sinclair asked for a statement of the Government's attitude towards Mr. J. H. Burnham's assertion that Ne Temere was a large issue in the election in Ontario Mr. Borden responded that the Government did not feel called upon to express an opinion.

Mr. J. A. McMillan of Glengarry, asked whether the government had received any request for the communication of the sentence on F. D. McRae and received a reply in the negative.

Hon. Charles Murphy was told that Hon. T. W. Crothers had not promised that the Government would recoup those who had lost money through the Farmers' Bank and Mr. Borden had no information of any promises by supporters of the Government.

J. A. C. Ethier asked if Mr. Naotel had not on three occasions mentioned the attitude of Mr. Borden of the navy and repudiated him as leader. "No" was the reply of Mr. Borden, who added in reply to another question that the Government policy on the navy would be announced in due course.

The Government intends to continue the drainage works already commenced in the Riviere des Prairies, Mr. C. A. Wilson on Laval was informed.

To Mr. Molloy of Provencher, Mr. Borden denied that he had told Hon. George Taylor that there would be only two sessions of this Parliament the same gentleman was also told that a redistribution bill would be introduced before dissolution.

Mr. Lapointe of Kamaska was informed that the engineers expect the N.T.R. in Quebec to be finished by September 1912, and in New Brunswick a year later. The question of the operation of the line from Quebec to Moncton till the Quebec bridge is completed has not been considered.

The Government does not intend to introduce a bill to regulate the manufacture of explosives Mr. Robb of Huntingdon was told.

Mr. Ethier inquired who was drawing the pay of the Solicitor-General. He was told by Mr. Borden that no one was Solicitor-General and in reply to another question the premier stated that the Minister of Justice was not in receipt of it. Regarding his judicial superannuation allowance of the Minister of Justice, Mr. Borden said he "receives no salary or pension except such as is payable to him under the statutes of Canada."

Hon. Rodolphe Lemieux was told that the government has not yet considered the increase of the number of Civil Service Commissioners.

Mr. Robb learned that the Cedar Rapids grant of water power was made by the provincial government.

Mr. Pugsley inquired in regard to a reported statement of Hon. A. E. Kemp that only \$20,000 had been spent in refitting Rideau Hall for the Duke of Connaught; although \$100,000 had been voted. Hon. F. D. Monk replied that "the general statement was made that Government House was in a state of unpreparedness and that such a condition was inexplicable."
