number of ballots and it was a common practice so to do under the Act of 1894. A ballot could be marked with green blue, red or any colored pencil. An elector did not have to get his ballot from the returning officer. Under that Act there was no provision for marking a ballot in a polling booth.

Another Act of 1912 was to be read together with the Act of 1894. Yet it was entirely at the caprice of a number of polling officers as to what ballots were to be accepted and what rejected. That Act of 1912 provided that a black pencil be in each polling booth. There was a question whether it was directory or obligatory to mark ballots with a black lead-pencil.

Dealing with the matter of the two-hour protest Mr. Gregory stated that it was too limited for any observance of a degree of particularity in the stating of the grounds for protest. In this case Mr. Farrell had to write his own protest without legal assistance.

In the Fredericton election candidates had no agents in the polling booths. The scrutineers were not agents. Any protest Mr. Farrell could make had to be on his information and belief. He did make a specific allegation however, "saying I believe and allege." Of course that allegation had to be based on information.

Mr. Gregory said there was a question as to whether the "protest" was the two-hour notice or the ten-day petition. It was possible on a liberal interpretation that the petition was what was referred to by the word "protest" in this Act of 1903.

It was straining a technical point to claim that Mr. Farrell's notice did not contain definite grounds. As a matter of fact he believed the Aldermen all knew what Mr. Farrell's objections were. Ballots had been improperly marked, improperly accepted at some polls and improperly rejected at others.

Mr. Gregory contended that under the Act of 1863 the City Council had power to conduct an investigation. There was no specific mention of a recount, it was true, but there was only one way of investigation an election, and that was by recounting the ballots.

In applying for a mandamus it was necessary that the applicant should prove his interest in the matter. Mr. Farrell as a candidate had a perfect right in this case.

Mr. Gregory asked for an order absolute with costs. He also asked for a ruling on the question of whether an investigation should be confined to the grounds stated in the first protest.

had been made and that the uniform of the American navy had been disregarded, demanded reparation in the form of a salute of twenty-one guns. The American flag, while not taken ashore, was flying at the stern of the whaleboat and all the marines were in uniform. Rear-Admiral Mayo allowed the Huerta commander until six o'clock that evening to fire a salute, but later extended the time in order to afford the local commander an opportunity to communicate with his superior officers in Mexico City. A statement of apology was issued in Mexico City by General Huerta and the local officer who arrested the marines was ordered punished.

SALUTE DEMANDED.

This did not satisfy the United States government and the salute was insisted upon. General Huerta himself at no time agreed to comply, but an under secretary in the Mexican foreign office did inquire of Charge O'Shaughnessy if a salute fired to the gunboat Dolphin and responded to by the American ship, would be acceptable. This was emphatically rejected by the United States and word was sent that nothing short of a public salute to the American flag would be satisfactory.

This was the situation laid before the cabinet today by the President. There was a disposition on the part of some administration officials to wait for more facts and do nothing until an investigation had been completed. Others suggested that Huerta would evade the issue and delay and that prompt and vigorous action was necessary. John Lind, it is understood, had, in his conference with the President and Secretary Bryan, counseled a forceful move. For two hours the cabinet discussed the pros and cons and the possible consequence of drastic action and the plan of sending the fleet as a warning to Huerta of the lengths to which the Washington government was prepared to go to enforce its policy was unanimously adopted. There was no previous intimation that the naval demonstration would be ordered but this, as well as other moves, had been discussed on many an occasion in the past.

PREMIER FLEMMING

If it be proven that the illegal levy of \$15 a square mile was collected from the large owners of timber limits, the large sum thus extorted is still in existence and sound lawyers have expressed the opinion that this money is the property of the province and ought to be recovered and turned into the provincial treasury for legitimate purposes.

There is talk in Conservative circles about considering the whole question of the crown lands and the revenue to be derived from them but it is realized that this question, if raised at all is premature now, but might be raised after the investigation and settled in the light of what the investigation reveals; and it should be decided by the properly elected representatives of the people after they have had time to digest the evidence not only in regard to the timber bonus charges but in regard to the equally grave charges in connection with the Valley Railway.

TORIES WORRIED.

Governor Wood was in town yesterday, as also were the Speaker of the House, Mr. Dickson, and the Minister of Agriculture, Mr. Murray. The attorney general spent Sunday in the city and there have been many councils of the Conservative party, including men prominent in federal as well as provincial affairs. There is increasing talk of reorganizing the government but while all sorts of plans have been the subject of street talk the accepted view is that nothing can be done that will meet with public approval until after the Valley Railway and timber charges have been fully investigated.

Intense interest has been aroused in every corner of the province by the Dugal charges. During Easter recess these things have been the leading topic of conversation in every county, and it is noticeable that a great many independent Conservatives have come out flat-footed for a house-cleaning, beginning with a straightforward and manly investigation, at which everybody, with knowledge of value, would be permitted to testify without technical obstacles being placed in the way.

Premier Flemming is reported ill at his home in Woodstock and reports in St. John have it that his principal associates have decided to throw him overboard and attempt to save the government without regard to what may become of him. Whether this is so or not will, of course, only be known with certainty as the investigation proceeds.


Public conversation favors prompt action. It is seen that the public would be suspicious of any delay in appointing a commission and beginning its session.
