SUPREME COURT, JUNE SITTINGS, OPENED TODAY

Common Motions this Morning—Objection to Appointment of Master in Coy Estate Case

Jane sittings of the Supreme Court opened here this morning. Two common motions were made.

E. A. McKay of this city read an application to be re-admitted and re-sworn as an attorney of the court. J. D. Phinney made the motion and read the petition and affidavit. The court referred the application to the Barristers' Society, under Rule 56 of that body.

In an expropriation case concerning lands in Carleton and York Counties in which expropriation proceedings are being taken by the El River Light, Heat & Power Company, J. C. Hartley moved for direction as to publication of notice of appropriation. The court ordered that notice be advertised in newspapers published in Carleton and York Counties two months before September 1st.

By consent of counsel, the second case on the crown paper, The King vs F. F. Matheson, police magistrate of Campbellton, was taken up by the court agreeing but having it understood that this was not to be a precedent. Wm. Murray showed cause against and order nisi to quash conviction for second offense under the Liquor License Act. J. B. Phinney contra. Court considers.

Court then adjourned until ten a. m. tomorrow.

At three o'clock this afternoon the Catherine E. Coy estate case in chancery was heard. Havelek Coy of this city, was appointed master of the court some time ago but objection having been made court will decide whether he or another should have been appointed.

MR. FIELDING TESTIFIES IN FARMERS BANK CASE

Ottawa, June 10—The Hon. W. S. Fielding, former minister of finance, was examined by Mr. Frank Hodgins, K. C., in the Farmers Bank enquiry today. The question of the extension of the time of the charter was taken up.

"You had to do with the issuing of the certificate to the Farmers Bank?" asked Mr. Hodgins.

"Yes,"

"You had knowledge of the extension of time of which the bank had to organize?"

"Yes, I was opposed to granting any renewal, but was overruled by the committee, but finally succeeded in having the limit compromised on at six months."

Mr. Fielding replied.

"Have you any knowledge of a telegram to a Mr. Lowndes, a barrister which stated that the committee had turned you down?"

"I do not know of any, but you might take it that when I was overruled that it was a 'turn down.'"

Mr. Fielding told Mr. Hodgins that he had looked on the movement to obtain charter for the Farmers Bank always with anxiety.

"I disliked the movement because I was afraid of members of parliament going into business they did not understand. I always viewed the corporation with anxiety."

"What part did Mr. Calvert have in the matter?"

"I have no particular recollection whether he was in charge of the bill or not."

"Then had you any knowledge of the matter until the question of the certificate came up?"

"No."

The former finance minister said he had first been aware of the matter about a month before the money for the certificate was deposited at the department. With regard to the treasury board, Mr. Fielding said he considered that it was the supreme authority in the matter of granting the certificate to new banks, but that the finance minister should advise his colleagues and guide them. He recalled one case before his time as minister in which a certificate had been granted without a sworn statement. All precedents had been lived up to in the case of the Farmers Bank.

New York, June 11—A special train conveyed the guests from this city this afternoon to Port Washington, L. I., for the wedding of Miss Marjorie Ide and Shane Leslie. The bride is a daughter of Henry C. Ide, United States minister to Spain, and a sister to Mrs. W. Bourke Cochran, at whose home, the Cedars, the wedding took place. Mr. Leslie the bridegroom is a son of Colonel and Mrs. John Leslie of London and a grandson of Sir John and Lady Constance Leslie of Ireland and of the late Leonard Jerome of this city. Father Carroll, rector of the Church of St. Peter of Alcantara at Port Washington, performed the marriage ceremony. Among the ushers were Congressman Nicholas Longworth, Norman de R. Whitehouse, and Finley P. Dunne, the writer.

HARPER MEMORIAL LIBRARY DEDICATED

Chicago, June 11—The new Harper Memorial Library, erected in memory of Dr. William Rainey Harper, late president of the University of Chicago was dedicated today in connection with the eighty-third convocation of the University. The dedication was accompanied by interesting ceremonies in which many noted educators, librarians and others participated. Dr. Frank W. Gunsaulus, President Harry Pratt Judson of the University, and Dr. James B. Angell of the University of Michigan were the principal speakers. At the convocation exercises this afternoon the address was delivered by Franklin MacVeagh, Secretary of the Treasury.

BIG LOG JAM ON THE MIRAMICHI

Chatham, N. B., June 9—A sight that has not been witnessed on the Miramichi for the past twenty years, the jamming of nearly the whole of the gigantic lumber out of the South-west Branch at a point a couple of miles above Millerton, has attracted a large number of sightseers to this place yesterday and today.

Between 60,000,000 and 70,000,000 feet of logs are compressed within a distance of three-quarters of a mile, reaching from shore to shore and extending from the bottom of the river to a height in places twenty feet above the level of the water. It is a scene that will never be forgotten by those who have gazed upon it.

The value of the logs thus piled up in endless confusion approximates \$700,000, and may go above this figure. During the three days of the recent prolonged downpour all the logs in the southwest boom limits and those above it were swept down before the rising flood. A jam occurred at a point in the lower end of the boom limits and as each successive batch of logs were driven on the jam the earlier logs were forced lower and lower until they piled from the bed of the river to the top of the high water mark.

When all the logs had run in the mass extended from shore to shore in a solid formation fully three-quarters of a mile in length and now that the water has subsided several feet the whole body of the logs make a bridge across the river about three or four feet above the water's level.

Dynamite will have to be used, it is said, to loose the logs and enable the boom company to sort them out and make them into rafts for the lumbermen. At present only a few sticks can be hauled out at a time and the expense to the boom company to fulfill their part of the contract will be very heavy.

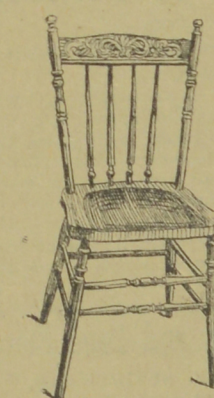
