On Monday last, the Hon. Mr. Partelow met a number of the leading Merchants of St. John, for the purpose of explaining the present state of the Fishery negotiation, and obtaining an expression of opinion as to the propriety of the Province acceding to the Treaty as it now stands. It appears that the Government of this Province, last autumn, remonstrated very strongly with the Home Government against any Treaty being made to cede the right of fishing on our coasts, without, amongst other concessions, registry of our ships and a participation in the American coasting trade. It now appears that in the Treaty as arranged by Lord Elgin, neither of those requisites is included. It appeared, however, to be the general opinion of the Merchants attending the meeting, that while the American Tariff remains as it is, as compared with ours, it would not be possible for the American Government to allow our ships a register. It was also alleged that the registry would rather be an injury to us, as it would allow the Americans to purchase our cheap ships and compete with us in the markets of the world. With regard to the coasting trade, it seemed to be the feeling that after the example set by Great Britain, it was neither politic nor just that our vessels should not be allowed the privileges American vessels freely receive from us. It was considered that if a stand was to be made at all on the part of this Province, it should be made on this point; but that still, as it is the obvious interest of the Americans themselves that this trade should be opened, and as no people are quicker to see their own interest, it was of little consequence to delay a treaty otherwise highly advantageous to the people of both countries, for a privilege that would certainly be conceded within a very few years.

Although no formal resolutions were put, we think we are warranted in stating that it was the general opinion of the meeting, that it would be for the interest of the Province to accede to the treaty.

The Hon. Messrs. Partelow and Chandler left town on Tuesday morning in the steamer Eastern City en route for Quebec.—*Courier*.

We are pleased to learn that the contractor for constructing the Railroad on either side of the Bend, has succeeded in obtaining a number of men from Prince Edward Island and Cape Breton, and that he has now about five hundred men engaged on the work.—*ib.*

We learn by telegraph last night, that the Hon. Mr. Partelow and the Hon. Mr. Chandler on behalf of New Brunswick, the Hon. Wm. Young on behalf of Nova Scotia, the Hon. E. M. Archibald, Attorney General, representing the Executive of Newfoundland, and Philip Francis Little, Esq. representing the House of Assembly of Newfoundland, transacted business yesterday at Quebec with the Earl of Elgin, respecting the fishery and reciprocity treaty.—*New Brk.*

EMIGRATION.—The packet ship "Liberia," Captain Cruikshank, arrived here on Saturday evening, after a passage of 28 days only, bringing 306 stowage and 9 cabin passengers, all in good health. The Liberia was in excellent order on arrival, and landed her passengers in first rate condition, thus furnishing another proof of the successful management of the Black Ball Line.

A boy about 12 years of age was lost overboard while fishing on the Banks of Newfoundland, although every effort was made to save him, not only by the boats of the ship, but by those of a fishing vessel close at hand; he was unable to sustain himself in the water until the boats reached him.—*New Brunswick.*

STABBING AFFAIR.—About 9 o'clock on Saturday evening, a man named Patrick Brophy stabbed a young man named Thomas Burns, in King-street, with a knife, inflicting a severe wound in his back. Brophy was afterwards arrested by the Police, and committed to Jail to await his trial.—*ib.*

The Woodstock Journal of Thursday says— "The weather since our last issue has been somewhat variable, but on the whole highly favourable to agricultural purposes. We never recollect to have seen the country look better at this season. So far crops of all kinds promise well; and in particular there is every prospect of abundance of hay. On Thursday and Saturday last it rained heavily, and the water has since risen several feet in the St. John and most of its tributaries, whereby numbers will now get their timber and logs to market, who must otherwise have left them for another season."

The Cape Breton News of the 10th inst., informs us that in consequence of the indisposition of the prosecuting officer, Mr. Henry, the trial of Mr. Martin for shooting Mr. Dodd, the seducer of his daughter, cannot be proceeded with in the present Term. Mr. Martin, through his Counsel, Mr. Wilkins, moved for bail, but could not procure it; and afterwards by several affidavits setting forth the improbability of his receiving a fair trial at Cape Breton, moved for the transfer of the case to Arichat. We have not learned the issue.—*Reporter.*

Canadian Parliament—Quebec, June 21.—The Ministry was defeated this morning on amendment of address, in answer to speech from the throne, for not settling the clergy reserves ques-

tion this session. The vote stood 29 to 42. Dissolution of Parliament is expected immediately.

By telegraph from Quebec, we learn that the Provincial Legislature was prorogued on Friday last, and that a dissolution of the Assembly would immediately follow.

The steamer *Richmond*, with a large number of passengers and a heavy freight, bound for Tobique, broke her main shaft on Wednesday evening when within two miles of Woodstock. It is thought she cannot be taken down without a rise of water.—*Woodstock Sentinel.*

Breadstuffs.—The last news from Europe has had a 'depressing effect' upon our grain and flour markets. It has had a contrary effect upon a large class of consumers. The "depression," in connection with the arrival of various instalments of "the new (vegetable) crop," and the prospect of a bountiful harvest, inspires the hope that the eyes of an anxious people will again be delighted with a sight of loaves approaching to their old proportions.—*Quebec Gaz.*
