Tilley submitted financial statements, &c. Last year a loan and an imposition of additional duties had to be asked to make good deficiency of '61 and anticipated deficiency of '62. This year he asked no loan, nor did he propose any additional duties-any change in the revenue bill would be in lessening duties in some cases. The revenue of the year would be ample to meet the expenditures. DEAR VISITOR—I hope my omitting to send you an account of the first week's sayings and doings of our Legislators, with the striking events incident to the opening of a Provincial Parliament, will not be com-plained of by your numerous readers in as much as you have gathered from other sources, everything of interest. The Speaker elect appears to bear his honours well, and evidently has the confidence of the House—though not so ready and decided in the perfor-mance of the duties of the chair as his predecessor—he is dignified, and impartial, and with longer service, may be very efficient in every way. It is supposed that the defeat of Hon. Mr. Fisher may have the effect of uniting him more closely with the Govern-ment side, and so far as the position of parties is con-verned this may offset the resignation of Mr. Smith. Several members of the Legislative Council are yet absent. Mr. Robertson is absent in England, Mr. Odell is residing in Halifax, and the President is not expected to be able to occupy hts seat again, on ac-count of his age and infirmities—the latter gentle-uman, however, continues to receive the salary ; the man, however, continues to receive the salary ; the acting President, Mr. Saunders, consenting to this

arrangement. The Prerogative of appointing a President of Coun-cil, after first vacancy has been held by the Executive; but the Government probably fearing some embar-rassment in the matter, and after a correspondence with the imperial authorities, yielded to that branch the right to elect their own President, who may re-main in office during four years, or till the assembling of a new Parliament, after the termination of four
