The differences between the cabmen and railways have been accommodated, and the strike is ended.

LONDON, Sept. 14 .- It is generally considered that the events of the last fortnight have made little change in the political condition on the Continent. either to lessen or increase the chances of war. While on the one hand the press of Germany have assumed a quieter tone and profess to be more con-fident of peace; on the other hand it is known that France has refused a formal demand made by Chevalier Negra, the Italian Ambassador, for the recal of the French troops from Rome; and at the same time Prince Girgenti has brought to Paris proposals from Spain to cement an alliance with France by sending 80,000 soldiers to Rome. This proposition, and the approaching interview shortly to take place at Bay-onne between the Emperor Napoleon and the Queen Spain, are looked upon as foreshadowing an alliance. the object of which is to rid France of the care of the Holy See in case she should be plunged into war; so that by this means France if without any other ally could make Spain useful.

Rumors, too, that several fighting regiments have been recalled from Africa; that Gen. Lobouf has been sent on a special mission to Germany ; and that Prussia has determined to annex the Grand Duchy of Baden, add to the feeling of distrust in the permanence of the existing peace. This feeling is faith-

fully mirrored in Paris by the depression on the Bourse and consequent decline of rentes, and in diplomatic circles here the situation is pithily summed up in these words "No fear of war though it may begin to morrow."

LIVERPOOL, Sept. 15 .- The London Times has a lengthy article on American affairs. The writer believes that Mr. Johnson, U. S. Minister, has a carte blanche from his Government to settle the Alabama case. The case of itself, presents little trouble. The only difficulty is the reluctance of the American Government to settle a difficulty growing out of war resentment. No American Statesman ever believed that the Alabama escaped with the connivance of Great Britain. There might be a question of inade-quate laws making Eugland answerable, but this could be easily settled. The real grievances of the United States was the indifference of England in a cruel war and her willingness to see the Union dissolved. Of this the Americans were conscious at the time and remember keenly now. They think we should have an active sympathy with the North. That a Confederacy based upon American Slavery should have been at once condemned. That the Republican party was the true friend of England. That it was wrong to even doubt the success of the Federal arms. After all the anger of the Americans was due to their consciousness of England's want of sympathy in their hour of peril; but the anger, if right, has been enough indulged. Mr. Seward has refused the handsome offer of arbitration which should be credited to England. He now cuts the past adrift, and the thing is as good as settled. Legal points will not stand in the way. The only thing to ascer-tain is the responsibility of England, and to fix the proper indemnity. The press of London comments variously upon the

recent speech of Napoleon at Chalons. The following words were made use of by the Emperor on the orcasion : " I will say nothing more, as the public prints are sure to draw prophecies of war, however moderate my words are."

BELGIUM .

An International Convention of the Workingmen of Europe has been in session in Brussels recently, The attendance has been large, the proceedings harmonious and orderly. The objects of the meeting and the conclusion obtained may be best summed up in the resolution which was adopted to day. It was resolved that workingmen cannot attain complete emancipation from the oppressions of employers through the means merely of local strikes. That all strikes should be subject to a code of uniform rules and regulations, that councils of arbitration be formed to settle differences between the employer and employed, and finally that trade societies be established in those countries where they do not now exist, and O'Rielly spoke an hour and a half, tracing Whelan's

A correspondent of the Farmer gives the follow ing information with regard to the trade of Boston with the Provinces :- The whole numbe of animals (foreign) imported the past week, are 119, 95 of which are from the Provinces. The clearances for foreign ports were 90, 90 of which went to the Provinces. The arrivals were loaded with lumber, wood, coal, fish, &c., and the clearing vessels went mostly in ballast, showing a balance of trade in favor of the Provinces.

NEW YORK, Sept. 15 .- The Print Works of the Washington Manufacturing Company at Gloucester, New Jersey, were burned yesterday. Loss half a

An enormous deve-lopment of the electric fluid filled the air. #### ONTARIO

Great excitement prevailed at Ottawa last week, cansed by the trial of Whelan for the murder of D' Arcy McGee. Despatches state that threatening letters were sent to all the witnesses for the prosecution. One of them was attacked and knocked down by a slung-shot. The city swarmed, it is said, with newspaper correspondents, detectives, &c. Among the American visitors were six Head Centres of Feni an circles. The jail was guarded by a regiment of regulars, and a guard of twenty men received Whelan every night on his return from the Court House. He was defended with extraordinary skill by the best criminal lawyers of Ontario, but the evidence against him could not be shaken. The jury, on Thursday last, brought in a verdict of Guilty 1

A telegram to Monday's News says of Saturday's proceedings :-

Orrawa, Sept. 12.-Whalen's produced one witness to-day from Cincinnati, named Mitchell, who was in gaol at Ottawa last April for Fenianism, but bailed out after a few weeks. He testified as to conversa-tion between Doyle and Whelan, overheard by detective Callen and Hess, on 16th April last, and swore that Whelan made no admission as to murder of Mc Gee. Witness admitted that he was locked up in his cell at six o'clock, after which he heard no more, and as the conversation between Whelan and Doyle lasted some two hours more, with occasional intervals, Mitchell's evidence, though doubtless true so far as it went, does not disprove statement sworn to by Cullen and Hess.

Crown prosecutor then called several witnesses in rebuttal of testimony offered by defence; and after a sharp argument and consultation between Judge and Counsel, the case was adjourned till Monday on the understanding that no more evidence would be offered on either side.

This afternoon true bills were found against Patrick Buckley and John Doyle, as accessories to the murder

of McGee. Their trial will be deferred till next assizes.

The following is from a despatch to the Morning

Telegraph : \* OTTAWA, Sept. 14 .- J. A. Cameron spoke two and a half hours for defence. Spoke of the great projudice against the prisoner; denounced adverse comments of the Press, and stated that the lives of Whelan's Counsel had been threatened. He labored to destroy the evidence for the Crown, especially that of Turner, Wade and Lecroix, dwelling upon the fact that the latter swore that McGee's white hat was a black one. The speech was eloquent, earnest and pleasant. At the close there was an attempt at applause, which was promptly suppressed.

### PRUSSIA.

King William of Prussia, with a large staff of officers, has left Berlin on a tour of military inspection through the North German States. On his arrival at Dresden he was received by the King of Saxony and conducted to the Royal Palace.

### NEW ZEALAND.

The Maroi prisoners have escaped, and the natives of New Zealand have again risen in insurrection. The extent of the rising is unknown. Troops have been hurried to the Island.

INDIA. Despatches state that the Press of Bombay and of Calcutta and of all parts of India as far as heard from, without exception, condemn the reported ap-pointment of the Earl of Mayo as Governor General of India.

#### FOUTH AMERICA.

Advices from South America announce a terrible earthquake on Southern coast. They occurred 16th of August.

The citizens of Arica, Arequipa, Iniqui, Chola, and Chincha have been utterly destroyed. From 25,000 to 80,000 lives were lost.

The loss of property between Tacha and Arica is estimated at fourteen million dollars.

The water rose to such a height that a tidal wave 40 feet high roll d with resistless fury upon the ships in the harbor and precipitated them on the main

The U.S. store ship Freedonia was capsized and all

on board were lost. The Freedonia had on board \$1,800,000 worth naval stores. The vessel was rolled over and smash-

ed to atoms by the advancing tidal waves. The U. S. steamer Wateree was carried half a mile inland and left high and dry, only one sailor of her crew being drowned.

It will be impossible to ever get her afloat again The Peruvian corvette America was also carried ashore in the same position as the Wateree. Her loss was three officers and thirty sailors and marines. The American merchantman, Rosa Rivera, the English sinp Chancellor, and the French bark Ed-

wardo, were all lost.

The surviving inhabitants of the cities destroyed are in a terrible destitute condition.

### UNITED STATES.
